### ***Opinion***

We have audited the financial statements of National Telecommunications Cooperative Association Regional Retiree Medical Funding Trust I (Trust), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Description of Trust**

The following description of the National Telecommunications Cooperative Association (NTCA) Regional Retiree Medical Funding Trust I (Trust) provides only general information. Participating members should refer to the Trust Agreement for a more complete description of the Trust's provisions. A copy of the Trust document can be obtained from the NTCA office in Arlington, Virginia.

***General***

The Trust was established on December 30, 1993 to provide NTCA member companies – those domiciled in the states of North Carolina, South Carolina, and Tennessee that are exempt from tax under Subchapter F of the Internal Revenue Code (IRC) - with a funding vehicle to help meet their liabilities for sickness, accident, and other welfare benefits for eligible current and former employees upon retirement. Such welfare benefits are characterized as nonpension in nature and are provided through an employee welfare benefit plan as defined in Section (3)(1) of the Employee Retirement Income Security Act of 1974, as amended.

***Contributions***

Contributions to the Trust are made by participating members only. Employee contributions are not accepted. While there is no stated annual maximum for such contributions, each member's contribution is limited to an amount that, in the member's sole discretion, is determined to be appropriate to fund that member's liabilities for postretirement, nonpension benefits for its current and former employees under its employee welfare benefit plan.

In certain instances, a participating member can contribute to the Trust by transferring amounts held under other funding vehicles set up to meet obligations for its employees' welfare benefit plan. However, amounts contributed and/or transferred must be used solely to reimburse the member for postretirement, nonpension welfare benefits paid on behalf of its retirees.

***Withdrawals***

Trust assets are held in separate accounts for each participating member within the Trust. These separate accounts are further subdivided into subaccounts, one holding assets to cover liabilities for the member company's key employees (as defined in Section 416(i) of the Internal Revenue Code (IRC)) and one holding assets to cover liabilities for the company's nonkey employees. These assets are available only for reimbursement of member company payments; employees or retirees have no access to these assets and have no vested or nonvested entitlement to them.

Participating members may take withdrawals from their accounts only as reimbursement for documented payments to provide postretirement, nonpension welfare benefits to their retirees. Only monies from the key employee subaccount can be used to reimburse the member for such expenses on behalf of key employees. The same reimbursement procedure applies to expenses for nonkey employees in that the monies are withdrawn from the nonkey employee subaccount.

The Trust's contract administrator is responsible for processing requests for reimbursement from the Trust. The contract administrator may also pay, from Trust assets, reasonable expenses incurred on behalf of the Trust.

**Note 2. Summary of Accounting Policies**

***Basis of Accounting***

The financial statements of the Trust are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trust Committee determines the Trust's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Trust's gains and losses on investments bought and sold as well as held during the year.

***Cash***

From time-to-time, deposits in Federal Deposit Insurance Corporation (FDIC) insured institutions exceed the insurance limitations. Management periodically reviews these institutions and the related deposits and does not believe that these concentrations expose the Trust to significant credit risk.

***Company Withdrawals***

Withdrawals to reimburse members for benefits are recorded in the period paid.

***Administrative Expenses***

The Trust's administrative expenses are paid by the Trust, as provided by the Trust Agreement. Certain administrative expenses incurred in connection with the general administration of the Trust that are paid by the Trust are recorded as administrative expenses in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

***Subsequent Events***

The Trust has evaluated events and through June 19, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds*

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

*Exchange-traded fund*

This fund is valued at the net asset value of units held by the trust at year-end, in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Trust believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Trust Termination**

Although it has not expressed any intent to do so, the Trust Sponsor, NTCA, has the right under the Trust to amend in whole or in part any or all of the provisions of the Trust Agreement and to terminate the Trust Agreement and the Trust itself subject to the provisions of ERISA. In the event of the Trust termination, assets in the Trust will be distributed in accordance with the terms of the Trust.

**Note 5. Related Party Transactions and Party in Interest Transactions**

Contributions to the Trust are made by NTCA members. The contributions are received by Services Management Corporation (SMC), the contract administrator, and transferred to the custodian bank.

The Trust has an agreement with SMC, a wholly owned subsidiary of NTCA, under which SMC has been designated contract administrator of the Trust and provides services to the Trust, including management of all Trust activities; benefits management and administration; field service and education; custody of Trust documents and records; assistance to the trustees, custodians, investment managers and others in the performance of their functions; secures insurance protection for many of those with fiduciary responsibilities for the Trust; and such other services as may from time to time to be required for proper administration of the Trust. SMC is compensated for these services on a fixed-fee basis.

Total fees incurred under this agreement were \$30,200 and \$29,051 for the years ended December 31, 2024 and 2023, respectively.

At December 31, 2024 and 2023, there were no amounts due to SMC for administrative services to the Trust.

**Note 6. Tax Status**

In accordance with Section 505(c) of the IRC, the Trust's Sponsor, NTCA, filed the required notification with the Internal Revenue Service (IRS) for a determination that the Trust is exempt from tax under Section 501(c)(9) of the IRC. IRC Section 501(c)(9) is referred to as a voluntary employee beneficiary association (VEBA). On June 7, 1995, the Trust received a favorable response from the IRS to its exempt letter request. The Trust has not been amended after receipt of the latest exemption letter.

Accounting principles generally accepted in the United States of America require Trust management to evaluate tax positions taken by the Trust and recognize a tax liability (or asset) if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.
