Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Kodiak BP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Kodiak BP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established in January 2014 covering all eligible employees age 18 years or older who have completed six months of service. Employees may enter the Plan on the first day of the month following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees are automatically enrolled at a deferral rate equal to 4 percent of eligible compensation. Employees automatically enrolled in the Plan receive automatic deferral increases annually of 1 percent up to 10 percent.

Kodiak Gypsum Mountain States, LLC (dba Jones Hertz Drywall Supply, AO Inc, and Western Interiors LLC) (the "Company") administers the Plan. American United Life Insurance Company (AUL) serves as the Plan's third-party administrator and custodian, manages plan assets, and maintains the Plan's records. AUL offers plan participants a variety of investment options through various pooled separate accounts and an investment contract. Individual accounts are invested in the various investment options at the direction of the participants.

During 2023, the Plan was restated to allow the employees of Miller Lumber Company, Diamond Home Improvement, and Don's Appliance LTD to participate in the Plan. Employees from the newly participating entities have the option to roll their balances into the Plan at their discretion.

During 2024, the Plan was restated to allow the employees of Gross-Yewell, Simonson Properties, CCA Midwest, Valley Lumber & Rental, KBP Olympic Peninsula dba Thomas Building Center, and Sams San Antonio Masonry and Steel to participate in the Plan. Employees from the newly participating entities have the option to roll their balances into the Plan at their discretion.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute a percentage of their eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions to the Plan during January 2025, including the related lost earnings.

The Company may contribute a discretionary matching contribution. During the year ended December 31, 2024, the Company elected to contribute a discretionary matching contribution of 33 percent of elective deferrals up to 9 percent of eligible compensation. The employee must be participating on the last day of the plan year in order to receive the discretionary matching contribution. The discretionary matching contribution is funded in a one-time payment following the plan year. For the year ended December 31, 2024, employer discretionary contributions, net of forfeitures, totaled \$5,570,000.

The Company may also contribute a nonelective discretionary profit-sharing contribution, which is allocated based on the same ratio of each participant's eligible compensation to the total of such eligible compensation for all participants. The Company did not make employer nonelective discretionary profit-sharing contributions for the year ended December 31, 2024.

December 31, 2024 and 2023

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 8.00 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100 percent vested in the employer discretionary match and discretionary nonelective portion of his or her account after three years of credited service.

Commissioned employees working at least 190 hours per month use an equivalency method for vesting rather than using actual hours of service. Employees who meet this requirement will fully vest in employer contributions after attaining three years of service under these terms.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a single lump-sum amount or a partial withdrawal payment equal to or less than the vested balance of a participant's account. Installment payments are permitted for required minimum distributions only.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals. In-service withdrawals are also allowed upon attainment of age 59½.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$247,737 and \$136,080, respectively.

The Plan used approximately \$180,000 for the year ended December 31, 2024 to reduce employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by AUL or its affiliates. AUL is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 1 - Plan Description (Continued)

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 7, 2025, which is the date the financial statements were available to be issued.

During 2025, the Plan was restated to allow the employees of Liberty Door and Window and Kendal Lumber to participate in the Plan. Employees from the newly participating entities have the option to roll their balances into the Plan at their discretion.

Note 2 - Summary of Significant Accounting Policies (Continued)

In April 2025, the Plan switched its third-party administrator and custodian from AUL to Principal Financial Group (Principal). As a result, all balances except those invested in the AUL Stable Value Account were transferred to Principal on April 15, 2025.

Note 3 - Certified Information

AUL holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by AUL.

There were no unfunded commitments or redemption restrictions on the investments described above.

Note 5 - Investment Contracts

The Plan has a benefit-responsive investment contract with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on an annual basis for resetting. When establishing interest crediting rates for this product, AUL considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
