Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mayo Clinic Health System 401(a) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Mayo Clinic Health System 401(a) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution money purchase pension plan originally covering all employees of Mayo Clinic Health System – Mankato (the Medical Center) who have completed one year of service, defined as 1,000 hours of service during the year, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Fidelity Management Trust Company is the trustee (the Trustee), as defined by the Plan.

The Plan was frozen, effective December 31, 2014, for all employees with the exception of employees whose terms and conditions of employment were subject to a collective bargaining agreement between the Medical Center and a union representing such employees, and such collective bargaining agreement provides for inclusion in the Plan. Effective December 31, 2015, the Plan was frozen for all employees other than employees of the Mayo Clinic Health System – Mankato Minnesota Nurses Association (MNA) collective bargaining unit. At the time of each freeze, all affected participants became 100% vested in their account balances. On the first of January of the subsequent year of each freeze, the affected employees became participants in the Mayo 403(b) Plan, which is sponsored by the parent company of the Medical Center.

The Mayo Clinic Director of Benefits resolved on December 13, 2016 to freeze the Plan for employees of the Mayo Clinic Health System – Mankato MNA collective bargaining unit effective January 1, 2018. As of this date, no employees were eligible to become participants in the Plan and no further employer contributions were made to the Plan. Any participant who is employed by the Medical Center on December 31, 2017 became 100% vested, effective December 31, 2017. The Plan was completely frozen as of the end of the day on December 31, 2017.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Contributions

Prior to the Plan being frozen, the Medical Center contributed to the Plan, on behalf of each eligible participant, a match equal to the participant's contribution to the Mayo Clinic Health System – Mankato 403(b) Plan (the 403(b) Plan) up to a maximum of 4% of compensation for employees with less than seven years of service and 5% of compensation for employees with more than seven years of service. Participant contributions to the 403(b) Plan were required to be equal to or exceed 2% of compensation for the participant to be eligible for the matching contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions were subject to certain limitations, as prescribed by law. Participants who were subject to the Mayo Clinic Health System – Mankato MNA collective bargaining agreement continued to have Medical Center matching contributions until December 31, 2017, as described above.

Participant Accounts

Each participant's account is credited with the Medical Center's contributions, if any, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

The Plan has selected investment options, as described in the Plan's literature, from which participants may select. The funds vary in type of investments, rate of return, and investment risk. Amounts are deposited with the Trustee and are credited to the individual participant accounts. Participants self-direct the investments in their accounts and can allocate their account balances and future contributions to the various investment options in any combination. Such allocations may be changed at any time during the year.

Self-Directed Brokerage Accounts

Participants also have the opportunity to invest their contributions in participant-selected investments, including most listed stocks, options, bonds, U.S. Treasury securities, mortgage securities, certificates of deposit, unit investment trusts, foreign securities, exchange-traded funds and limited partnerships, real estate investment trusts and other mutual funds.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Vesting

Vesting in the Medical Center's contributions, plus actual earnings thereon, was based on years of continuous service. A participant vested at a rate of 20% per year, and the participant is 100% vested in his/her account balances after five years of continuous service. As a result of the freezes described above, all participants who were active employees as of the respective freeze dates described above became 100% vested as of the freeze dates.

Payment of Benefits

Upon death, termination, retirement, or becoming permanently disabled, a participant with an account balance of \$1,000 or more may request a distribution. The normal form of payment is an annuity; however, participants may elect to receive a lump sum or installment payments. If a participant terminated employment and the participant's account balance was never greater than \$1,000, the plan administrator will authorize the benefit payment in a single lump sum, without the participant's consent. In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Specific provisions for the Merged Plans are described in the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$77,900 and \$1,073,300, respectively. Forfeited balances of terminated participants' non-vested accounts are used to pay plan expenses or are periodically distributed amongst eligible participants. In 2024, approximately \$1,074,500 was allocated to all participants with a balance.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and

assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Mayo Clinic's Investment Subcommittee determines the Plan's valuation policies, utilizing information provided by the investment advisors, Trustee or other third parties. See Note 3 for a discussion of the Plan's fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (d includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits payments were recorded upon distribution.

Administrative Expenses

Plan administrative fees are paid directly by the Plan or absorbed by the Medical Center. Transaction-based fees, which are associated with optional services offered under the Plan, are incurred by each participant who takes advantage of the services.

3. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the same term of the financial instrument.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan's policy is to recognize transfers in and transfers out as of the actual date of the event or change in the circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds

Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

Pooled Separate Account

The TIAA CREF Real Estate Fund is a pooled separate account in which daily unit values are published on NASDAQ; however, the fund is not traded on this exchange. The value of the unitholder's investment rises and falls with the return on the underlying assets in the account.

Variable Annuities

The TIAA CREF variable annuities are valued at the daily unit value published on NASDAQ; however, the funds are not traded on this exchange. The value of the unitholder's investment rises and falls with the return on the underlying assets in the fund.

Self-Directed Brokerage Accounts

The self-directed brokerage accounts are valued based on quoted market prices of the underlying investments, except for cash, which is valued at cost, which approximates fair value. The self-directed brokerage accounts consist of common stock, mutual funds and cash.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

4. Fully Benefit-Responsive Investment Contracts

The Plan holds traditional investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value of the general insurance accounts, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The crediting interest rate for all investment contracts is based on a formula agreed upon with the issuers, and such interest rates are reset monthly, quarterly, semiannually or annually.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction exemption under ERISA or (5) premature termination of the contracts. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable.

5. Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest on investments for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustee of the Plan.

6. Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Medical Center has the right, under the Plan, to terminate the Plan, subject to the provisions of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated December 5, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps to bring the operations into compliance with the IRC.

9. Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Subsequent Events

The plan administrator evaluated events and transactions occurring subsequent to December 31, 2024 through July 15, 2025, the date the accompanying financial statements were available to be issued.
