In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a

substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

December 31, 2024

1. Description of the Plan

The following description of the Mayo Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Mayo Holding Company is the plan sponsor. The Plan is designed to provide benefits for employees of the following entities as of December 31, 2024 and 2023 (collectively referred to as the Clinic):

- Mayo Clinic Health System – Decorah Clinic Physicians
- Mayo Collaborative Services, LLC
- MMSI, Inc.
- Franklin Heating Station
- Rochester Airport Company
- Mayo Clinic Health System – Waycross
- Mayo Clinic Health System – Red Wing
- Franciscan Skemp

Mayo Clinic Health System – Waycross and Mayo Clinic Health System – Red Wing transferred balances into the Plan, but are not actively contributing.

Under the provisions of the Plan, an eligible employee is one engaged in recognized employment who works greater than 0.5 full-time equivalent or completes 1,000 hours or more of eligible service in a rolling 12-month period. Eligible employees may enter the Plan on the first day of the month after the employee has met eligibility requirements. Eligible employees are automatically enrolled in the Plan, unless they affirmatively decline to participate.

Mayo Retirement Savings Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The HR Director of Programs-Benefits resolved on December 11, 2024 to merge the Franklin Heating Station Hourly Employees' 401(k) Plan (the Merged Plan) into the Plan effective January 2, 2025. The net assets totaling \$12,221,904 were transferred from the Merged Plan to the Plan effective December 31, 2024.

Contributions

Each year, a participant may contribute up to 50% pretax annual compensation, as defined in the Plan. If automatically enrolled, a participant's deferral is set at 4% of eligible compensation until changed by the participant. Participants are also permitted to make Roth after-tax deferrals to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Clinic contributes from 50% to 100% of the first 4% of base compensation that a participant contributed to the Plan, depending on length of pension benefit service years, as defined. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Plan allows for in-plan Roth conversions. An active participant may not make an in-plan Roth conversion more frequently than once per year, and the minimum amount that may be transferred is \$1,000.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and allocations of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

The Plan has selected investment options, as described in the Plan's literature, from which participants may select. The funds vary in type of investments, rate of return, and investment risk. Amounts are deposited with Fidelity Management Trust Company (the Trustee) and are credited to individual participant accounts. Participants self-direct the investments in their

account and can allocate their account balance and future contributions to various investment options in any combination. Such allocations may be changed at any time during the year.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are 100% vested in the Clinic's contributions plus actual earnings thereon upon completing three years of vesting service. A year of vesting service is a year in which a participant completes at least 1,000 hours of service.

Payment of Benefits

Upon termination of employment, retirement, death or becoming permanently disabled, a participant with an account balance of \$1,000 or more may choose the timing of payment as a lump-sum amount or as installments as set forth in the Plan. If the balance in the account is less than \$1,000, a lump-sum payment will be made in a reasonable period of time. During employment, participants may withdraw account balances upon attainment of age 59½.

Effective August 1, 2023, the Plan added the option of hardship withdrawals. Hardship withdrawals are only made in the event of a financial hardship. There is no fee to take a hardship withdrawal from the participants account, but there are specific IRS requirements when they are allowed.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$47,400 and \$24,900, respectively. The accounts will be used to reduce future employer contributions. In 2023, forfeited non-vested accounts reduced employer contributions by approximately \$16,800.

Administrative Expenses

Plan administrative fees are paid directly by the Plan or absorbed by the Clinic. Transaction-based fees, which are associated with optional services offered under the Plan, are incurred by each participant who takes advantage of the services.

1. Description of the Plan (continued)

Loans

The Plan allows participants to borrow from their accounts. Participants can borrow up to 50% of their vested account balance. The minimum loan amount is \$1,000, and a loan must not exceed one-half of their vested balance or \$50,000. The loan is repaid to the participants account, plus interest, through after-tax payments. The Plan allows one loan outstanding at a time.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Mayo Clinic's Investment Subcommittee determines the Plan's valuation policies, utilizing information provided by the investment advisors, Trustee, or other third parties. See Note 3 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No new participant notes receivable are allowed in the Plan.

Payment of Benefits

Benefits payments are recorded upon distribution.

3. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Notes to Financial Statements (continued)

3. Fair Value Measurements (continued)

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

The Plan’s policy is to recognize transfers in and transfers out as of the actual date of the event or change in the circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

Pooled Separate Account

The TIAA Real Estate Fund is a pooled separate account in which daily unit values are published on NASDAQ; however, the fund is not traded on this exchange. The value of the unit holder’s investment rises and falls with the return on the underlying assets in the account.

Variable Annuities

The TIAA CREF variable annuities are valued at the daily unit value published on NASDAQ. The value of the unit holder’s investment rises and falls with the return on the underlying assets in the fund.

3. Fair Value Measurements (continued)

Self-Directed Brokerage Accounts

The self-directed brokerage accounts are valued based on quoted market prices of the underlying investments, except for cash, which is valued at cost, which approximates fair value. The self-directed brokerage accounts consist of common stock, mutual funds and cash.

The methods described above may produce a fair value calculation that may not indicate net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

4. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustee of the Plan.

5. Fully Benefit-Responsive Investment Contracts

The Plan holds traditional investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value of the general insurance accounts, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The crediting interest rate for all investment contracts is based on a formula agreed upon with the issuers, and such interest rates are reset monthly, quarterly, semiannually, or annually.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that

cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction exemption under ERISA, or (5) premature termination of the contracts. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable.

6. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee, as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Clinic has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Clinic contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Tax Status

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code) and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt.

9. Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
