Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Enterprise Bank and Trust Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Enterprise Bank and Trust Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Enterprise Bank and Trust Company (the Company) covering substantially all employees who are 18 years of age or older, with the exception of interns, leased employees, and temporary employees (defined as employees who will not reach 1,000 hours of service within their first year of employment or any subsequent Plan year). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On June 30, 2025, the Company approved the termination of the Plan in connection with the merger of the Company with Rockland Trust Company. As of that date, no additional contributions or deferrals were permitted. Assets will be distributed to participants based on their direction; however, the timing of such distributions may extend beyond December 31, 2025.

The 401(k) Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Effective January 1, 2020, participants may contribute up to 70% of their eligible compensation, as defined in the Plan, in the form of pre-tax or Roth contributions (was previously 50% of eligible compensation). Effective January 1, 2020, the Plan allows after-tax contributions between 1% and 5% of eligible compensation for highly compensated employees (was previously 1% to 2%) and between 1% and 70% of eligible compensation for non-highly compensated employees (was previously 1% to 50%). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. During March of each calendar year, the automatic deferral percentage is increased by 1%, up to a maximum of 15%.

The Company contributes 70% of the first 6% of eligible compensation that a participant contributes to the Plan. Each plan year, the Company may elect to make a discretionary profit sharing contribution to employees who are 18 years of age or older and are employed by the Company on the last day of the Plan year. No profit sharing contribution was made in 2024 and 2023.

Each participant shall direct the investment of his or her account and shall elect among various mutual funds, common collective trust funds, and a self-directed brokerage account. Each participant has the ability to change his or her investment allocations at any time. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching and profit sharing contributions, and an allocation of Plan earnings, and charged with an allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are at all times fully vested in their participant accounts with respect to their contributions. Participants vest in discretionary employer matching contributions and profit sharing contributions based on years of service, beginning after one year of service and become fully vested after four years of credited service.

Forfeitures

Forfeitures represent the non-vested portion of terminated participants' account balances, plus related earnings. These amounts can be used to reduce employer contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$800 and \$25,894, respectively. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts of \$91,198 and \$1,058 were used to reduce employer matching contributions, respectively. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts of \$7,738 and \$21,500 and were used to fund administrative expenses, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The notes receivable from participants are secured by the balance in the participant's account. Participants are limited to two loans outstanding at any time during the Plan year. No loan shall be for a term exceeding five years, unless the loan proceeds are used for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a single lump-sum payment or installment payments in excess of \$5,000 on a determined basis over a maximum of 20 years. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. Participants who are eligible for a hardship withdrawal or have attained age 59½ may elect to withdraw all or a portion of their vested account. All distributions are subject to the applicable provisions of the Plan. The Plan can elect to distribute funds out of the Plan when a participant terminates employment and has a vested balance of less than \$5,000.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

For purposes of the preparation of these financial statements in conformity with U.S. GAAP, management has considered transactions or events occurring through July 15, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Income Tax Status

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype Plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Management has determined that the Plan has no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. Information Prepared and Certified by the Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by John Hancock Trust Company LLC (John Hancock), the trustee, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statements of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

5. Parties-in-Interest

Certain distributions made from the Plan are in the form of loans to the Plan's participants. These loans are considered exempt from the prohibited transaction rules and qualify as party-in-interest transactions under ERISA.

Certain participants have elected to invest in Enterprise Bancorp, Inc., the holding company of the plan sponsor, through the self-directed brokerage window. At December 31, 2024 and 2023, the Plan held 13,419 and 11,922 shares, respectively, of Enterprise Bancorp, Inc. with a fair value of \$530,555 and \$384,582, respectively. During the years ended December 31, 2024 and 2023, the Plan recognized interest and dividends related to Enterprise Bancorp, Inc. totaling \$12,460 and \$10,887, respectively. During the years ended December 31, 2024 and 2023, the Plan recognized net appreciation in the fair value of shares of Enterprise Bancorp, Inc. totaling \$109,993 and \$45,191, respectively.

The administrative expenses of maintaining the Plan, including Plan recordkeeping fees paid to the Plan trustee and audit fees, totaled \$88,574 and \$85,414 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

The Plan was terminated effective June 30, 2025, in connection with merger of the Company with Rockland Trust Company. Although the Plan legally terminated on that date, all assets will remain in the trust until distributions are completed at the direction of the individual participants.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

The Financial Accounting Standards Board's Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Common collective trust funds are valued at the NAV of units of the collective trusts. The NAV, as provided by John Hancock, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on these funds. There are no unfunded commitments at December 31, 2024 and 2023.

Self-directed brokerage account: This account consists of interest bearing cash, non-interest bearing cash, common stocks, and mutual funds valued at the closing price reported in the active markets on which the individual securities are traded, and is classified as Level 1.
