Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of STRATTEC SECURITY CORPORATION Employee Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Note #1 Description of Plan

The following summary description of the STRATTEC SECURITY CORPORATION Employee Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all United States employees of STRATTEC SECURITY CORPORATION (the "Company"). The purpose of the Plan is to permit eligible employees to reduce their compensation and have corresponding contributions made on their behalf to the Plan to provide additional income to the employees upon retirement. The Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan also provides for an employer matching contribution as an incentive for employee participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

All non-bargaining unit employees 21 and older and bargaining unit employees with an agreement providing for participation in the Plan, excluding employees covered by a collective bargaining agreement, unless the terms of such agreement specifically require participation, leased employees and nonresident aliens who receive no United States source earned income, are eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code ("IRC"). In addition, "catch-up" contributions are allowed for those participants age 50 and over in addition to the maximum deferral amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investments options offered by the Plan. Participants may change their percentage of salary reduction or elect to discontinue contributions effective with the beginning of any payroll period.

The Plan provides an auto-enrollment provision whereby all newly eligible bargaining and non-bargaining unit participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a target date fund, based on the participant's date of birth, until changed by the participant.

Additionally, the Plan instituted an auto-escalation provision whereby all bargaining and non-bargaining unit participants who affirmatively elected to contribute at a rate between 0% and 4% shall receive an annual 1% increase to their elective contributions on October 1 each year. The automatic increase will cease when the covered participant's rate of default elective contributions is 5% of the participant's compensation.

The Plan provides for matching contributions that may be made by the Plan. During 2024, the Company elected to make matching contributions of 100% of the participant's deferral to a maximum of 5% of the participant's eligible wages for both bargaining unit and non-bargaining unit employees. Contributions are subject to certain limitations as dictated by the Internal Revenue Service ("IRS") annually.

Investment Options

Participants may direct all contributions in 1% increments between various investment options, with the exception of the STRATTEC SECURITY CORPORATION Stock Fund.

Participants may change the investment of future contributions and/or account balances on a daily basis.

Note #1 Description of Plan (Cont'd)

Participants may also direct contributions into the Schwab Self-Directed Brokerage Accounts. The Schwab Self-Directed Brokerage Accounts is an option that provides participants the ability to set up a self-directed fund through Principal, which allows participants to buy and sell mutual funds and individual securities not currently available in the Plan.

Vesting

All participants' accounts are fully vested at all times in both employee and employer matching contributions.

Notes Receivable From Participants

The Plan has a defined set of criteria for allowing notes receivable from participants. Eligible participants with account balances of at least \$2,000 may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, less defaulted loans (if any). Participants can have only 1 loan outstanding at any time. Loans are repayable through payroll deductions over periods ranging up to 60 months for general purposes or 120 months for the purchase of a principal residence. The loans are secured by the balance of the participant's account and the Plan is set up to charge a reasonable rate of interest. The Plan is currently using a rate of interest at 1% greater than the prime rate in effect at the time the loan is extended. Loans are deemed impaired if they are 90 days past due. As of December 31, 2024 and 2023, no loans were impaired.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. The net earnings of each of the investment funds are determined and allocated separately. The net earnings of each fund consist of the income from assets, which includes interest, dividends, gains or losses from the sale of assets and unrealized appreciation or depreciation, or specific participant transactions.

The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Benefit Payments

Distribution of an account balance will be made to the participant in the case of termination, or to the beneficiary in the event of death. Participants whose account balance is less than \$7,000 will receive a distribution of their vested aggregate account balance without the consent of the participant. If the distribution is less than \$1,000 the distribution will be made in the form of lump sum cash. If the distribution is greater than \$1,000, but less than \$7,000, the Plan will pay the distribution in an automatic direct rollover to an individual retirement account (IRA). Participants with account balances of \$7,000 or greater may elect to defer distribution of their account balance to a later date, but in no event later than April 1 of the calendar year following the calendar year in which they attain the Required Minimum Distribution age as determined and indexed by the Internal Revenue Service.

Participants may elect to receive their distribution from common stock funds in common stock or cash. All other distributions are made in cash.

Note #2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities.

Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balances plus any accrued but unpaid interest, less amounts defaulted (if any). Delinquent loans are treated as distributions based upon the terms of the plan document. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Fees related to the payment of benefits and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Plan also pays certain investment advisory and plan administration fees from plan assets. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. During 2024, approximately \$89,000 of administrative expenses were paid from Plan assets.

Payment of Benefits

Benefits are recorded when paid.

At December 31, 2024 and 2023 there were no amounts included in the net assets of the Plan payable to terminated employees who have elected to receive a distribution from their account balances.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the IRS and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan year ended December 31, 2024 and 2023. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

Note #3 Fair Value Measurements

US GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Valuation based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts

Principal/Black Rock S&P 500 Index investments are valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

Collective Trusts (Cont'd)

The Galliard Stable Return Fund PN is composed primarily of investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Common Stock

Valued at the closing price reported on the active market on which the individual securities are traded.

Self-directed Funds

Accounts consist of mutual funds that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note #5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note #6 Tax Status

The Plan has obtained a determination letter, dated June 17, 2015, in which the IRS stated that the Plan, as designed and amended, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

Note #7 Party-in-interest Transactions

Certain Plan investments are managed by Principal Trust Company, the trustee and, therefore, these transactions qualify as party-in-interest. The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the plan or by the Company. Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan for their services. At December 31, 2024 and 2023, the Plan held 73 and 115 shares, respectively, of common stock of the Company, with a cost basis of \$766 and \$1,205 respectively. Plan participants are prohibited from purchasing new shares of Company stock but can reinvest their dividends in additional shares of Company stock on their existing shares owned in the Plan.

Note #8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note #9 Subsequent Event

The Plan has evaluated subsequent events through July 15, 2025, which was the date that the financial statements were available for issuance and noted the following subsequent event:

The Company has approved the transition of the Plan into the SuccessWise Pooled Employer Plan (SuccessWise PEP) sponsored by Principal Life Insurance Company effective January 1, 2026 and the assets of the Plan will be transferred to the SuccessWise PEP.


