Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about I-CAR 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

I-CAR 401(K) PROFIT SHARING PLAN NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the I-CAR 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Inter-Industry Conference on Auto Collision Repair (the Company) who are 21 years of age or older. Employees are eligible to make elective salary deferrals following their completion of 1 month of service if they are reasonably expected to work at least 1,000 hours for the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, the Plan was converted from a traditional 401(k) plan to a safe harbor 401(k) plan. In addition, on December 1, 2023, the trustee of the plan was changed from Merrill Lynch to Fidelity Management Trust Company.

Contributions

Each year, participants may contribute a portion of their eligible compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Effective, January 1, 2023, the plan's auto-enrollment provision whereby all newly eligible employees on or after December 15, 2016 were automatically enrolled in the Plan with a default pre-tax deferral rate of 6% of eligible compensation, unless they affirmatively elect not to participate in the Plan, was deactivated. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution to the Plan. Effective January 1, 2023, the Company began matching 100% of employee contributions up to the first 4% of eligible compensation that a participant contributed to the Plan. Previously, the Company matched 50% of employee contributions up to the first 6% of eligible compensation that a participant contributed to the Plan. As of December 15, 2016, the profit sharing feature of the plan was frozen. Effective December 1, 2023, the plan provides for discretionary employer profit sharing contributions to the plan. No such contributions were made for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contributions, the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid for by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN - Continued

Vesting

Effective January 1, 2023, participants are immediately vested in their contributions and the Company's matching contributions plus earnings thereon. A participant becomes 100% vested in the Company's profit sharing contribution (nonelective employer contribution) after five years of credited service, in accordance with the following schedule.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest is repaid ratably through regular payroll deductions over a period not to exceed five years; however, if the note is for the purchase of your principal residence, the administrator may permit a longer repayment term.

Payment of Benefits

Upon retirement, death, or disability, a participant becomes fully vested and may receive a lump-sum payment of his or her entire account balance. Upon termination, a participant may elect to receive a cash or in-kind distribution of their vested account balance as a lump sum distribution. The Plan auto-distributes de minimis balances of separated employees that are \$5,000 or less. Hardship distributions are permitted under certain conditions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$90,536 and \$83,372, respectively. These funds are used to reduce employer contributions or pay plan expenses. In 2024, forfeiture funds in the amount of \$30,136 were used to pay plan expenses. In 2023, forfeiture funds in the amount of \$28,652 were used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not distribute any excess contributions for the years ended December 31, 2024 and 2023, to the applicable participants prior to March 15 of the following years.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company and excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025 the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE TRUSTEE

The Trustee, Fidelity Management Trust Company has provided certification that the following information, which is contained in or used to develop the financial statements or schedules, is complete and accurate:

- Details (cost and fair values) and summaries of investments held at December 31, 2024 and 2023.
- Summaries of investment asset transactions for the year ended December 31, 2024.
- Investment earnings for the year ended December 31, 2024.
- Notes receivable from participants at December 31, 2024 and 2023.

Net appreciation in fair value of investments for 2024 was \$2,715,939.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurements, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In accordance with ASU 2015-07, *Fair Value Measurement: Disclosures for Investments in Certain Entities that Calculate Net Asset Value (or its Equivalent)*, investments for which fair value is measured using net asset value (NAV) as a practical expedient have not been categorized within the fair value hierarchy. However, the investments are included in the fair value table for purposes of investment reconciliation to amounts in the statement of net assets available for benefits.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value funds: Valued at contract value. Contract value is the amount unitholders would receive if they were to initiate permitted transactions under the terms of the underlying contribution plans. The stable value collective trust is held with an investment company that uses NAV per share as a practical expedient to estimate fair value.

Common/collective trusts (CCT's): The Plan holds interests in various common/collective trusts, valued at net asset value (NAV) of units of a bank collective trust. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities divided by the total units outstanding.

5. PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Certain investments are managed by the Trustee. Therefore, the Plan's investments in these funds qualify as party-in-interest transactions under ERISA. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

7. TAX STATUS

The IRS has determined and informed the Company by letter dated March 31, 2014 and an updated letter dated June 30, 2020, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
