**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Bank of Ann Arbor (the “Company”) Employees 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution 401(k) profit sharing plan and provides for employee contributions under Section 401(k) of the Internal Revenue Code (IRC). The Plan was established January 2, 1996 and has been amended from time to time subsequent to that date. Effective January 2, 2015, the Plan document was formally restated in its existing form. It covers substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees are eligible to become plan participants, make deferral elections and receive discretionary employer matching contributions on the first day of the month subsequent to the month in which the age requirement of 21 years old is met.

Contributions: Employees participating in the Plan can elect to make pre-tax and after-tax deferral contributions of his or her compensation up to the maximum allowed by the Internal Revenue Service (IRS). The Plan provides for discretionary employer matching contributions. For the year ended December 31, 2024, the Company matched 60% of employee contributions up to 10% of eligible wages. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation, which then increases by 1% per year until a deferral rate of 10% is reached, unless the participant takes action to change such percentage.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of the applicable Company’s contribution as well as Plan earnings or losses and is charged with his or her withdrawals and an allocation of administrative fees. The Company’s contributions are allocated based on eligible compensation as defined in the Plan document, or participant contributions. Plan earnings or losses are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death and Disability: A participant (beneficiary) is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their voluntary pre-tax and after-tax contributions, plus actual earnings thereon. Vesting of discretionary employer matching contributions is based on years of continuous service. A participant is 100% vested after two years of credited service.

Forfeitures: The nonvested portion of the discretionary employer matching contributions of terminated participants can be used to offset plan administrative expenses or offset future employer contributions. During 2024, approximately \$12,400 of forfeitures were used to offset employer contributions.

Notes Receivable from Participants: The Plan provides that participants can borrow funds against their employee account balances limited to 50% of their vested account balance and not less than \$1,000 or more than \$50,000. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Payment of Benefits: Upon termination of service or attainment of age 59½, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested account balance or installment payments. Benefits are recorded when paid.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan and are assessed at the participant level. Certain investment management fees are charged to Participants through their selected investments and are reflected as a reduction of investment return and included in the investment income reported by the Plan.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of Plan financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisor.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in aggregate fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: The Plan provides for investment options in various mutual funds and a common collective trust stable value fund. The investments are exposed to various risks, such as, interest rate, market, liquidity, credit risks, and global pandemic and international conflicts. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

**NOTE 3 – RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

#### **NOTE 5 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges which are level 1 inputs, as defined above.

*Common Collective Trust (CCT) - stable value fund:* The fair value of participation units in the common collective trust - stable value fund are based upon the net asset values of such fund, after adjustments to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive investment contracts. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fidelity Management Trust Company (“Fidelity”) is the trustee of the Plan and, therefore, the Plan's payment of trustee fees, record keeping fees and investment management fees to Fidelity qualifies as a party-in-interest transaction. In addition, certain Plan investments are shares of mutual funds managed by Fidelity or an affiliate of Fidelity and constitute party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 7 – TAX STATUS**

Effective January 2, 2015, the Plan document was restated to comply with various tax law changes. Since the Plan was restated on a prototype document that has received a favorable opinion letter dated March 31, 2014, the Plan is not required to file for an individual determination letter. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**NOTE 7 – TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
