Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Union Mutual Fire Insurance Company 401(k) Employee Savings Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Union Mutual Fire Insurance Company 401(k) Employee Savings Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

(1) DESCRIPTION OF THE PLAN

The following description of the Union Mutual Fire Insurance Company 401(k) Employee Savings Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan’s Adoption Agreement for a more complete description of the Plan’s provisions.

- (a) General – The Plan is a defined contribution plan covering all full-time employees of Union Mutual Fire Insurance Company (the “Company”). There are no age or service requirements to become a participant in the Plan, with the exception of part-time or temporary employees that are scheduled less than 1,000 hours of service per computation period. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of the month following hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In 2024, the Plan Sponsor entered into an affiliation agreement with Norfolk & Dedham (N&D). As part of this affiliation, the Plan Sponsor and N&D are in the process of developing a new retirement plan structure. The proposed structure is expected to be a hybrid plan incorporating features of both a 401(k) plan and a cash balance plan. As of the date of this report, the ultimate impact on the current Plan, including any modifications to benefits, contributions, or administrative structure, remains undetermined.

In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in the three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan’s provisions and applicable law.

- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, subject to Internal Revenue Service “IRS” limits. Participants are automatically enrolled in the Plan upon eligibility unless they elect out. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions as set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined plans.
- (c) Employer 401(k) Matching Contribution – The Company makes a matching contribution each payroll period for each employee who enters into a salary reduction agreement. The match during 2024 and 2023 equaled 100% of the first 3% deferred by participants.
- (d) Discretionary Profit-Sharing Contributions – The Company may contribute a discretionary profit-sharing contribution for each employee, without regard to current or accumulated net profits of the Company. Employees are eligible for the discretionary profit-sharing contribution after six months of service. During 2024 and 2023, the Company made a profit-sharing contribution for each eligible participant equal to 10% of their eligible compensation.

- (e) Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, and allocation of (a) the Company’s additional discretionary contribution, (b) Plan earnings, and (c) forfeitures of terminated participants’ non-vested account balances. Allocations are based on a participant’s eligible compensation relative to total eligible compensation, deferred contribution amounts, or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant determines the investment strategy of their account as provided by the Plan.
- (f) Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions of the participant’s account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, death or disability, a participant becomes fully vested.
- (g) Payments of Benefits – Upon termination of service, death, disability, or retirement, the participant or beneficiary may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or leave the funds in the Plan until retirement age or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.
- A participant may withdraw rollover contributions at any time. Hardship withdrawals are permitted by the Plan in cases of great and immediate financial need. In-service distributions are also permitted once the participant has reached age 59 ½ or has been a participant for at least 5 years.
- (h) Forfeited Accounts – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the Company’s contributions or Plan expenses. Total forfeitures used during 2024 and 2023 were \$34,167 and \$62,474, respectively. As of December 31, 2024 and 2023, there were \$12 and \$17,634, respectively, of available forfeitures.
- (i) Notes Receivable – Participants may borrow a minimum of \$1,000 up to a maximum, not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, up to five years. The loans are secured by the balance in the account and bear interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest are repaid ratably through weekly payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (c) Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.
- (d) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Administrative Expenses – In general, all Plan expenses except certain recordkeeping fees are paid for by the Company.
- (f) Benefit Payments – Benefits are recorded when paid.
- (g) Subsequent Events – The Plan has evaluated subsequent events through July 15, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) TAX STATUS

The Plan is based on a prototype plan and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated March 31, 2014. This letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code "IRC". Although the Plan has been amended since receiving the opinion letter, the plan administrator and prototype sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(5) WITHDRAWING PARTICIPANTS

There were no participant distributions requested in 2024, but not paid until 2025.

(6) RELATED PARTY TRANSACTIONS

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(7) INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Standard Insurance Company, the custodians of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(8) INVESTMENTS AT CONTRACT VALUE

The Plan has entered into a fully benefit-responsive guaranteed investment. The custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(9) FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(11) RISKS AND UNCERTAINTIES

The Plan provides for various investment instruments. Investment securities, in general, are exposed to various risk, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.
