We have performed audits of the accompanying financial statements of Hatco Corporation 401(k) Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hatco Corporation 401(k) Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Hatco Corporation 401(k) Trust (the "Plan") provides only general information. For a more complete description of the Plan and investment options, participants should refer to the Plan Document and investment prospectuses.

General

The Plan is a defined contribution plan sponsored by Hatco Corporation (referred to as the "Sponsor"). The Sponsor is the Plan Administrator. Fidelity Management Trust Company ("Fidelity") is the custodian of the Plan's investment assets and record keeper. Investments are all participant directed. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Eligibility

Employees of the Sponsor are eligible to participate in the Plan after completion of three months of service. Plan entry dates are the first day of the quarter within the Plan year coinciding with or subsequent to the date of completing the eligibility requirements. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Contributions

Participants may contribute to the Plan up to 60% of their eligible compensation, as defined by the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). The Sponsor may make discretionary contributions to the Plan. To be eligible for discretionary contributions, participants must have performed over 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year. In 2024, the Sponsor made a discretionary match of 50% of participant contributions up to 4% of eligible compensation to the Plan totaling \$770,959. The Sponsor may also contribute a discretionary profit sharing contribution allocated to each participant based upon their ratio of annual compensation to total annual compensation for all employees. No discretionary profit sharing contributions were made in 2024.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Sponsor contributions, and Plan earnings (losses), and charged with withdrawals and administrative expenses. Allocations are based on the participant's eligible compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and earnings (losses) thereon. Sponsor contributions and earnings (losses) thereon vest in accordance with the provisions of the Plan as follows:

Participants who terminate employment because of death, normal retirement, or disability, as defined by the Plan, are considered 100% vested.

Forfeitures

Forfeitures are portions of participants' accounts that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of nonvested account balances are used to reduce the contributions that the Sponsor would otherwise contribute in the year. Unallocated forfeitures at December 31, 2024 and 2023, were \$17,387 and \$19,841, respectively. For the 2024 Plan year, \$17,000 of forfeitures were used to reduce the Sponsor discretionary matching contribution made subsequent to year-end.

Notes Receivable from Participants

Participants may borrow from their account of a minimum amount of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. The notes are secured by the balance in the participant's account. The range of interest rate on notes as of December 31, 2024, is 3.25% to 9.25%. The notes are repaid over various terms generally not to exceed five years, unless the note is for the purchase of a primary residence, in which case the term may exceed five years. The notes are payable immediately upon termination. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, a participant or a designated beneficiary may request a lump-sum amount equal to the value of the participant's vested account balance, less any administrative fees required for the processing of the payout. Participant accounts with values of less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment and accounts with values of \$1,000 to \$7,000 will be automatically rolled into an IRA unless the participant directs otherwise.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are stated at their outstanding principal balance plus accrued interest. Interest income is recorded on the accrual basis. Delinquent participant notes receivable are classified as distributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Investment-related expenses are included within net appreciation of fair value of investments. Other expenses of the Plan are paid by the Sponsor and are excluded from these financial statements.

Subsequent Events

The Sponsor has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividend income, excluding interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Fidelity, custodian of the Plan.

Note 4: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end registered mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at a stable \$1.00 NAV which approximates fair value. The money market fund held by the Plan is deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Party-In-Interest

Transactions involving participant notes receivable and investment funds administered by affiliates of Fidelity are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan Document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 7: Tax Status

The Plan adopted the Fidelity Prototype Plan ("Prototype Plan") with an Internal Revenue Service determination letter dated June 30, 2020, which states the Prototype Plan was in compliance with the applicable sections of the IRC. Although the prototype document has been amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan Administrator believes the Plan is exempt from federal and state income taxes. Plan management evaluates uncertain income tax positions taken by the Plan.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Contributions

Participants may contribute to the Plan up to 60% of their eligible compensation, as defined by the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). The Sponsor may make discretionary contributions to the Plan. To be eligible for discretionary contributions, participants must have performed over 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year. In 2024, the Sponsor made a discretionary match of 50% of participant contributions up to 4% of eligible compensation to the Plan totaling \$770,959. The Sponsor may also contribute a discretionary profit sharing contribution allocated to each participant based upon their ratio of annual compensation to total annual compensation for all employees. No discretionary profit sharing contributions were made in 2024.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Sponsor contributions, and Plan earnings (losses), and charged with withdrawals and administrative expenses. Allocations are based on the participant's eligible compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions and earnings (losses) thereon. Sponsor contributions and earnings (losses) thereon vest in accordance with the provisions of the Plan as follows:

Participants who terminate employment because of death, normal retirement, or disability, as defined by the Plan, are considered 100% vested.

Forfeitures

Forfeitures are portions of participants' accounts that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of nonvested account balances are used to reduce the contributions that the Sponsor would otherwise contribute in the year. Unallocated forfeitures at December 31, 2024 and 2023, were \$17,387 and \$19,841, respectively. For the 2024 Plan year, \$17,000 of forfeitures were used to reduce the Sponsor discretionary matching contribution made subsequent to year-end.

Notes Receivable from Participants

Participants may borrow from their account of a minimum amount of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. The notes are secured by the balance in the participant's account. The range of interest rate on notes as of December 31, 2024, is 3.25% to 9.25%. The notes are repaid over various terms generally not to exceed five years, unless the note is for the purchase of a primary residence, in which case the term may exceed five years. The notes are payable immediately upon termination. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, a participant or a designated beneficiary may request a lump-sum amount equal to the value of the participant's vested account balance, less any administrative fees required for the processing of the payout. Participant accounts with values of less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment and accounts with values of \$1,000 to \$7,000 will be automatically rolled into an IRA unless the participant directs otherwise.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are stated at their outstanding principal balance plus accrued interest. Interest income is recorded on the accrual basis. Delinquent participant notes receivable are classified as distributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Investment-related expenses are included within net appreciation of fair value of investments. Other expenses of the Plan are paid by the Sponsor and are excluded from these financial statements.

Subsequent Events

The Sponsor has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividend income, excluding interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Fidelity, custodian of the Plan.

Note 4: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end registered mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at a stable \$1.00 NAV which approximates fair value. The money market fund held by the Plan is deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Party-In-Interest

Transactions involving participant notes receivable and investment funds administered by affiliates of Fidelity are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan Document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 7: Tax Status

The Plan adopted the Fidelity Prototype Plan ("Prototype Plan") with an Internal Revenue Service determination letter dated June 30, 2020, which states the Prototype Plan was in compliance with the applicable sections of the IRC. Although the prototype document has been amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan Administrator believes the Plan is exempt from federal and state income taxes. Plan management evaluates uncertain income tax positions taken by the Plan.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
