December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the J.W. Speaker Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of J.W. Speaker Corporation (Employer). Employees are eligible to participate and receive Employer contributions on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

OneAmerica Retirement Services serves as the record keeper. Matrix Trust Company serves as the trustee and custodian.

Contributions

Participants may elect to make pretax contributions from 2% to 85% of their annual compensation to the Plan, as defined in the Plan agreement. These deferrals are specifically allocated to the account of the individual participant. Participants are eligible for matching contributions upon hire. Discretionary matching contributions were made by the Employer at an amount equal to \$0.50 on \$1.00 of participant's pretax contributions up to 6% of compensation for the year ended December 31, 2024.

All newly eligible employees are automatically enrolled in the Plan beginning with a deferral rate of 6%. The employee may make an affirmative election to opt-out of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, Employer's matching contribution and an allocation of plan investment income. Allocations are based on participant compensation or account balances, as defined in the Plan agreement. The Plan allows participants to invest their account balances between or among separate investment funds established by the trustee within the trust.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover amounts, plus actual earnings thereon. Vesting in the Employer contributions portion of their account plus earnings thereon is based on years of continuous service. Vesting in the Employer contributions plus earnings thereon is 20% after one year of service and increases 20% per year thereafter until 100% vesting is reached at five years.

Payment of Benefits

Any benefits provided by the Plan are paid from the net assets available for benefits. The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to such participant's account. The method of distribution will be determined by an election made by the Plan participant. The participant can elect a lump-sum distribution or installment payments for a specified term as defined in the Plan agreement.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$96,800 and \$70,900, respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$70,800 from forfeited non-vested accounts during the year ended December 31, 2024.

Notes Receivable from Participants

The Plan allows loans to be taken out by plan participants. These loans are secured by participants' account balances. The maximum loan that can be made to a participant is an amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Otherwise, the term for repayment of the loan may not exceed five years, unless the loan qualifies as a primary residence loan. Principal and interest is paid ratably through payroll deductions. Interest income is recorded on the accrual basis. The interest charged to the participant shall be at a rate deemed reasonable by the Plan Administrator based upon rates for similar loans. The interest rate on participant loans ranged from 2.63% to 8.50% at December 31, 2024.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

The significant accounting policies which have been consistently applied in the preparation of the accompanying financial statements follow:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

The Plan's investments are held by the trustee and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Employer pays a portion of the Plan's administrative expenses. Certain plan expenses are paid by the Plan and are expensed when incurred.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

In accordance with the framework, the Employer groups plan assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued based on quoted prices of the fund in active markets.

Collective trust fund - Valued at net asset value (NAV) based on information reported by the investment advisor using the audited financial statements of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INCOME TAX STATUS

The Plan adopted a volume submitter plan document, which received an advisory letter from the Internal Revenue Service (IRS) on September 24, 2015, which stated that the volume submitter plan document is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Employer has determined that the Plan is eligible and have chosen to rely on the current IRS advisory letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

NOTE F - RELATED-PARTY TRANSACTIONS

A majority of the costs of administering the Plan are paid directly by the Employer. These costs include administrative and audit fees and are insignificant to the total net assets of the Plan.

NOTE G - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - the schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE H - SUBSEQUENT EVENTS

Plan management evaluated the December 31, 2024 financial statements for subsequent events through June 27, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
