NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following brief description of the Prevea Clinic, Inc. 401(k) and Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan, established in 1997, is a defined-contribution pension plan covering substantially all employees of Prevea Clinic, Inc. (the Company and Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan restated its plan-adoption agreement effective January 1, 2016.

Contributions

The Plan permits employees to contribute to the Plan with both pre-tax dollars or Roth-deferral contributions with after-tax dollars in accordance with the Internal Revenue Service (IRS). Rollover contributions from other qualified plans or individual retirement accounts are also permitted under the Plan. Effective February 1, 2019, the Plan was amended to add an auto-enrollment feature to the Plan for all new participants at an automatic 3% deferral.

The Company will match the participant's contributions upon reaching age 18 and completion of one year of service, which is defined as 1,000 hours of service. Hours of service are defined as paid time, including vacation and holiday time. Participants can become eligible for Company contributions on January 1 or July 1 following the date the outlined requirements are met. Participants must continue to meet the 1,000 service-hour requirement every year, as well as be employed by the Plan Sponsor on the last day of the year, to receive the matching contribution. The Company match is equal to the participant's contributions up to a maximum of 6% of the participant's eligible compensation.

In addition, the Company can make a discretionary contribution in an amount determined annually by the board of directors. Eligibility requirements for the discretionary contribution are consistent with requirements for the Company match outlined above. Discretionary contributions of 3% of eligible wages were made for 2024 and 2023, with an additional 3% for those eligible wages exceeding 80.01% of the Social Security taxable wage base, which was \$168,600 and \$160,200 for 2024 and 2023, respectively.

Vesting

Participants are, at all times, fully vested in the value of their account balances attributable to their voluntary contributions.

Participants become 20% vested in the Company's contributions following one year of service and are additionally vested another 20% for each year of additional service up to five years of service, at which time participants are fully vested.

Benefits

Upon termination of service due to death, disability, or retirement, the participant or beneficiary is entitled to receive, as benefits, the entire amount credited to their accounts as of that date. Upon a participant's termination from employment with the Company for a reason other than death, disability, or retirement, the participant is entitled to the vested balance in their account.

The method of distribution for account balances exceeding \$7,000 will be determined by an election made by the Plan participant. The methods available are lump sum, installment payments or part installment and lump sum. The standard method of distribution for account balances less than \$7,000 is a lump-sum payment or immediate rollover into an individual retirement account. Effective June 1, 2020, the Plan allows for in-kind distributions of securities held in a segregated account in addition to cash distributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching and discretionary contributions, along with an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan's provisions. The benefit to which a participant is entitled is the vested portion of the participant's account.

Investment Options

Upon enrollment in the Plan, a participant may direct investments consisting of their employee contributions and employer contributions, plus actual earnings thereon. Investments are to be made in 1% increments to any of the investment options offered by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant can only have one loan currently outstanding from the Plan. The loans are secured by the balance in the participant's account, or real estate in the case of mortgage loans, and bear interest at a rate commensurate with local prevailing rates on commercial and mortgage loans. Loans outstanding at December 31, 2024 and 2023 bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions while the participant is employed by the Plan Sponsor. Participants may continue to make loan payments after termination by sending funds directly to the Plan record keeper.

Forfeited Accounts

Forfeited non-vested accounts from Company matching and discretionary contributions will first be used to reinstate participant accounts, as applicable, then to reduce future Company matching and discretionary contributions and pay Plan expenses. Forfeitures of participants' non-vested account balances of \$186,628 and \$180,409 were used to reduce Company contributions and pay administrative expenses in 2024 and 2023, respectively. At December 31, 2024 and 2023, the outstanding balance of forfeited non-vested accounts was \$364,737 and \$173,540, respectively.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on an accrual basis.

Investment Valuation and Income Recognition

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits and statements of changes in net assets available for benefits are prepared on a contract-level basis.

Except for the Plan's group annuity contract (see Note I), the Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded.

Administrative Expenses

Administrative expenses are paid by the Plan to the extent not paid by the Company.

NOTE C - RISKS AND UNCERTAINTIES

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become fully vested upon termination of the Plan.

NOTE E - INCOME TAX STATUS

The Plan adopted a prototype plan offered by Transamerica Retirement Solutions. The Plan obtained its latest determination letter on May 12, 2017, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has since been amended. However, the Plan Administrator believes that the Plan is qualified and that the related trust is tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RELATED-PARTY TRANSACTIONS

The Plan pays certain Plan administrative expenses. Other expenses are paid by the Company.

Certain Plan investments are managed by State Street Bank & Trust Company, the trustee of the Plan, and Transamerica Trust Company (formerly known as Massachusetts Fidelity Trust Company) and Transamerica Life Insurance Company, the custodians of the Plan. These transactions qualify as party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions.

NOTE G - INFORMATION CERTIFIED BY TRUSTEE AND CUSTODIANS

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee and custodians have certified that the following data included in the financial statements and supplemental schedules are complete and accurate:

- Investments, fully benefit-responsive investment contract and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE H - FAIR VALUE MEASUREMENTS

There is a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Valued at the net asset value (NAV) of shares held by the Plan at year-end by reference to quoted market prices.

Self-directed brokerage accounts and personal choice retirement accounts - These accounts may include mutual funds, common stock and exchange-traded funds, all of which are valued at the closing price reported in the active market in which the securities are traded.

Collective trust funds - Valued at the NAV of units held by the collective trust funds at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV for the funds is based on the underlying investments held by the fund, less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE I - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Transamerica Guaranteed Investment Option (GIO) is a general account group annuity contract issued by the Transamerica Life Insurance Company (TLIC), which seeks to provide maximum return consistent with a guarantee of principal. The GIO is a stable value product that guarantees principal and interest. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

This contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Non benefit-responsive withdrawals may be subject to restriction or adjustment in accordance with contract provisions.

The crediting interest rate has a portfolio interest rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and there is no set maturity. The effective credited interest rate is set in accordance with contract provisions. TLIC will provide at least 30 days advance notice of any interest rate reset.

Events that would limit the ability of the Plan to transact at contract value with the issuer or the participant include, but are not limited to, premature termination of the contract by the Plan or Plan termination. However, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

NOTE J - OPERATIONAL ERRORS

During the 2024 Plan year, operational errors occurred related to the untimely remittance of employee contributions; errors identified in 2024 were corrected in 2025. The Plan has concluded that any financial statement as a result of these errors is immaterial.

NOTE K - SUBSEQUENT EVENTS

Subsequent events have been evaluated through June 24, 2025, which is the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
