We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **EL DORADO FURNITURE 401(K) PLAN NOTES TO FINANCIAL STATEMENTS**

### **NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the El Dorado Furniture 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provision, which is available upon request.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility Requirements**

To become eligible, participants must be full-time employees of El Dorado Furniture Corporation (the “Company”) who have completed the 90 days of employment service, and are at least 21 years of age.

#### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes 35% of the first 5% of base compensation. Additional amounts may be contributed at the option of the Company’s Board of Directors.

Contributions in excess of the above limitations are refunded to the participant and any matching portion to the Company.

The Plan was amended effective July 1, 2015. The amendment defines entry dates for acquired employees. In addition, the amendment automatically enrolls an eligible employee to defer 6% of their pay, unless a different percentage, including zero, is specifically chosen by the employee. Participants already in the Plan as of the amendment date that are not making an elective deferral contribution of at least 6% are automatically enrolled to defer 6%, unless a different percentage is elected by the participant. If a different percentage is not elected, including zero, the percentage will be automatically increased each January 1 by 1% up to a maximum of 10%.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s voluntary contribution, the Company’s matching contribution, and Plan earnings; and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant, under a seven-year graded schedule, is 100% vested after six years of credited service for matching contributions and 100% vested after seven years of credited service for discretionary contributions.

#### **Note Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are repaid over a period of one to five years, and are secured by the balance in the participant’s account. The notes bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Interest rates range from 5.25% to 10.50%. Principal and interest are paid ratably through monthly payroll deductions.

#### **NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Participants may receive an amount equal to the value of their vested interest upon termination of employment, death, disability or retirement. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest as a lump sum distribution.

#### **Rollovers**

The Plan accepts rollover contributions from other tax-qualified plans, governmental 457 plans, and traditional IRAs for those participants who choose to invest in the Plan.

#### **Forfeitures**

Forfeited accounts are used to offset employer contributions made after the forfeited amount is determined. Forfeitures may first be used to pay Plan expenses. Any forfeiture left after paying plan expenses are used to offset the next contributions.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct their contributions to be vested in one or more of the investment options available to the Plan.

#### **Administrative Expenses**

The Employee Retirement Income Security Act of 1974 (ERISA) allows certain expenses directly related to operating the Plan to be paid from the participant accounts. Such expenses include investment management fees and commissions, Plan expenses for the general administration and recordkeeping, and other per-use fees.

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### **Investment Valuation and Income Recognition**

Investments held by the Plan are required to be reported at fair value, except for investments in fully benefit-responsive investment contracts (“FBRIC”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. FBRIC’s are reported at contract value because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any investments in fully benefit responsive investment contracts as of December 31, 2024.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Risk and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statement of net assets available for plan benefits and statement of changes in net assets available for Plan benefits.

##### **Subsequent Events**

The Plan has evaluated subsequent events through June 30, 2025, which is the date the financial statements were available to be issued.

#### NOTE 3 – INFORMATION CERTIFIED BY THE CERTIFYING ENTITY

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the certifying entity of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i- Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and 2023.

#### NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### NOTE 5 – TAX STATUS

The Internal Revenue Service, by a favorable opinion letter dated April 15, 1993, concluded that the form of the Standardized Paired Profit Sharing 401(k) Plan and related trust is acceptable in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE 6 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting *Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Registered Investment Company*: valued at the quoted net asset value of share held by the Plan at the end of the Plan year.

- *Collective Investment Trust*: the fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contract are generally valued at representative quoted market prices.
- *Separate investment accounts*: are comprised of common stock, corporate bonds, and U.S. government securities. Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, the Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits.

Certain Plan investments are managed by Principal Life Insurance Company. Principal Life Insurance Company is the certifying entity as defined by the Plan and, therefore, these transactions qualify-as-party in interest transactions.

**NOTE 8 – EXCESS CONTRIBUTIONS**

For the years ended December 31, 2024 and 2023, the Plan had \$21,765 and \$120,551, respectively, for contributions in excess of amounts allowed by the IRS. These amounts are included as deductions from net assets on the statement of changes in net assets available for benefits. The Plan distributed those excess contributions as appropriate during December 31, 2024 and 2023, respectively.
