### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

#### NOTE A **DESCRIPTION OF PLAN**

The following description of the Magnificus Corporation (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- 1) **General.** The Plan is a defined contribution 401(k) plan covering all employees any participating affiliates who are eligible the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.
- 2) **Contributions.** Each year participants may contribute 1% to 86% of eligible earnings.
- 3) **Participant Accounts.** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- 4) **Vesting.** Participants are always 100% fully vested in their Elective Deferral and Rollover Contribution Accounts.
- 5) **Investment Options.** Upon enrollment in the Plan, contributions from the employer and employees are held in a Trust which invests the contributions with the investment medium selected by the participants. Participants receive investment statements quarterly and are permitted to change their investment allocation or transfer between existing investments.
- 6) **Participant Loans.** Participants may borrow from their vested accounts up to 50% of their vested balance. Loan terms cannot exceed 5 years, unless the loan is for the sole purchase of participant’s principal residence – the terms for residence loans cannot exceed 30 years. The loans are secured by the balance in the participant’s accounts. Loans made to participants cannot exceed 50% of the vested balance. The interest rate on the outstanding loans must bear a reasonable interest rate and must not give preferential treatment to certain participants. Principal and interest are paid ratably through bi-weekly payroll deductions.
- 7) **Payment of Benefits.** On termination of service due to death, disability, or retirement, a participant may elect to receive their vested benefit in either a single lump sum payment, or have the payment paid as a "direct rollover" to an individual retirement account or individual retirement annuity (an “IRA”) or to another employer's qualified plan. Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan that had not been paid at December 31, 2024 or 2023.

- 8) ***Forfeited Accounts.*** At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$0.00 and \$0.00, respectively. These accounts may be used to reduce future employer contributions or pay the Plan's administrative expenses in a future period. If you are rehired before five one-year breaks in vesting service occur, your forfeited amount will be restored if you repay to the Plan the full amount of your distribution. Unallocated forfeited balances as of December 31, 2024 and 2023 were not material.
- 9) ***Subsequent Events.*** The Plan monitors significant events occurring after the balance sheet date and prior to the issuance of the financial statements to determine the impacts, if any, of events on the financial statements to be issued. The Plan has evaluated subsequent events through July 15, 2025, which the financial statements are issued.

**NOTE B**      ***SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are held by the custodian and are stated at fair value except for its investment contract which is valued at contract value (See note C). Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Participants' loans are valued at their outstanding balances, which approximate fair value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded when earned.

Net realized gains or losses on investment sales represent the difference between the sale proceeds and cost of the investments, or the adjusted market price. Net unrealized appreciation or depreciation on investments held at the end of the Plan year represents the net change in the fair value of investments during the year. The Statement of Changes in Net Assets Available for Benefits presents the net appreciation or depreciation in fair value of investments, which consists of realized and unrealized gains and losses.

**NOTE D**      ***INVESTMENT CONTRACT WITH INVESTMENT COMPANY***

The Plan entered into a deposit contract with Ascensus Trust Company. Ascensus Trust Company maintains contributions in a general asset fund. The account is credited with actual earnings on all underlying investments and charged for Plan benefit payments. The Plan's contract is included in the financial statements at the December 31, 2024, at contract value as reported to the Plan by Ascensus Trust Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals.

**NOTE E**      ***PLAN TERMINATION***

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their employer contributions.

**NOTE F**      ***TAX STATUS***

The Internal Revenue Service has determined and informed the Plan by letter, that the Plan, as amended and related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**NOTE G**      ***RISKS AND UNCERTANTIES***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

In preparing the financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through July 1, 2025, the date the financial statements were available to be issued.

**NOTE I FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies:**

Valued at the daily closing price as reported by the fund. The registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
