Independent Auditor's Report

To the Plan Administrator

Opinion

CHEETAH CHASSIS EMPLOYEE STOCK OWNERSHIP PLAN

NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of Cheetah Chassis Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: Cheetah Chassis Corporation and its affiliated participating employer, John Evans Manufacturing Co., (collectively, the Employer or Cheetah) established the Plan effective January 1, 2022, as an internally-leveraged employee stock ownership plan (ESOP) designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Employer and the Plan Trustee are responsible for oversight of the Plan.

Prior to the establishment of this Plan, the Employer was formerly a participating employer in the Diamatrix, Inc. Employee Stock Ownership Plan (renamed the Strick Trailers Employee Stock Ownership Plan as of May 1, 2022). The Plan Agreement recognizes Diamatrix, Inc. as a predecessor employer for purposes of service credits for eligibility, contribution allocations, and vesting under the Plan.

Effective April 2022, the Diamatrix, Inc. Employee Stock Ownership Plan converted the respective shares of common stock held in the then participating employer Cheetah employee accounts to cash totaling \$2,069,482 and the cash was subsequently contributed as the initial deposit to the Cheetah Employee Stock Ownership Plan trust account.

Using the cash contributed from the Diamatrix, Inc. Employee Stock Ownership Plan; effective May 30, 2022, the Plan purchased 1,782 shares and effective October 28, 2022, the Plan purchased 1,700 shares of the Employer's common stock for \$561 per share for an aggregate purchase price of \$1,953,402.

In 2024, the Employer contributed \$1,781,041, comprised of 2,918 shares of the Employer's common stock for \$596 per share and \$42,729 in cash.

Eligibility: Employees of the Employer who have at least one year of service and are age 18 or older are eligible to participate.

Employer Contributions: The Employer may elect to make discretionary contributions to the Plan. In 2024, the Employer made no discretionary contributions to the Plan. A participant is eligible for an allocation of the Employer's contribution for the year if the participant is employed on the last day of the Plan year and has completed at least 1,000 hours of service during the Plan year.

Participant Accounts: The Plan is a deferred contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of shares of the unallocated account and forfeitures of terminated participants' nonvested accounts, as well as an allocation of the Employer's discretionary contributions and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings as a percentage of total earnings of all eligible participants, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Voting Rights: The Trustee votes all of the Employer's common stock held by it as part of the Plan assets as directed by the Employer, provided that the participant or participant's beneficiary is entitled to direct the Trustee as to the manner in which voting rights on shares of Employer's common stock which are allocated to the participant's account are to be exercised with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets, or such similar transaction. If the participant does not exercise his or her right to vote the Employer's common stock, the Trustee will vote such shares on behalf of the collective best interest of Plan participants and beneficiaries, subject to the Trustee's fiduciary duty under ERISA.

Vesting and Forfeitures: Vesting in the Employer's contribution portion of each participant's account is based on years of service. A participant becomes 20% vested after two years of service, increasing by 20% per additional year, with full vesting after six years of credited service. However, a participant will become 100% vested upon attainment of Normal Retirement Age (65) while in employment, upon termination due to total disability, upon death while employed or upon termination of the Plan. Although participants become vested in their account balances, the timing of the payment of their benefits is subject to certain restrictions as specified below under *Benefits*.

The forfeited nonvested account balances during any Plan year are first used to repay any prior forfeitures that must be reinstated and the remainder, if any, are reallocated as of the last day of the Plan year to eligible participants' accounts in proportion to each participants' compensation as a percentage of total eligible compensation for the Plan year. In 2024, forfeited nonvested accounts of terminated participants of \$9,307 were allocated to the accounts of eligible participants.

Benefits: Upon occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan, a participant or, if applicable, a beneficiary may elect to receive a lump sum distribution equal to the value of the participant's vested interest in his or her account, if under \$5,000. Vested balances in excess of \$5,000 are generally subject to a 5-year annual installment distribution schedule.

Notwithstanding the above, no portion of a participant's account attributable to the Employer's common stock acquired with the proceeds of a loan will be distributed until the Plan year following the Plan year in which the loan to which the shares are attributable is fully paid.

Put Option: Under federal income tax regulations, the Employer's common stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Employer buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the current value of the common stock. The Employer can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification: Diversification is offered to participants close to retirement age so that they may have the opportunity to move part of the value of their investment in the Employer's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The election to diversify is made subsequent to year-end based upon the shares of the Employer's common stock in the participant's account at year-end. Actively employed participants who elect to diversify may elect to transfer the diversified amounts to the Diamatrix, Inc. Retirement and Profit Sharing Plan. Terminated participants who elect to diversify may elect to transfer the diversified amounts to third party retirement plans or receive diversification funds available in cash.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Plan Termination: The Employer reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Employer's Board of Directors should direct the Trustee to pay all liabilities and expenses of the trust fund.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash is maintained in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts.

Investment Valuation and Income Recognition: The shares of the Employer's common stock are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Administrative expenses for maintaining the Plan are paid by the Employer or the Plan, at the discretion of the Employer.

Tax Status: The Plan is based on a pre-approved employee stock ownership plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated December 29, 2020, stating that the pre-approved employee stock ownership plan document was designed in accordance with the applicable sections of the IRC. Although the Plan and the pre-approved employee stock ownership plan document have been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Subsequent Events: The Plan Administrator has evaluated the financial statements for subsequent events occurring through July 17, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. In situations where there is little or no market activity for the asset or liability, the Plan makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Following is a description of the valuation methodology used by the Plan for assets that are measured at fair value on a recurring basis. There have been no changes in the methodology used at December 31, 2024 and 2023.

Common Stock of Cheetah Chassis Corporation: Valued at the aggregate fair value as determined annually by the Plan Trustee based on a report from an independent valuation specialist at the reporting date. The independent valuation specialist used the income approach (discounted cash flow method) based on the Employer’s historical data, with a certain adjustment related to the lack of marketability to determine the fair value.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan’s management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of these assets could result in a different fair value measurement at the reporting date.

Quantitative fair value disclosures about significant unobservable inputs used in the fair value measurement for the Employer's common stock have been omitted as the Plan previously adopted ASU 2013-09, *Fair Value Measurements (Topic 820): Deferral of the Effective Date of Certain Disclosures for Nonpublic Employee Benefit Plans in Update No. 2011-04*, which allows for the indefinite deferral of the quantitative disclosure requirements.

NOTE 4 - INVESTMENT IN EMPLOYER COMMON STOCK

The Plan's investment in the Employer's common stock at December 31, 2024 and 2023, was as follows:

The net depreciation of the Employer's common stock was \$535,985 for the year ended December 31, 2024.

NOTE 5 - PLAN AMENDMENT

Effective July 1, 2024, the Plan Agreement was amended to update the allocation conditions to allow a one-time, special cash contribution for select participants to the plan.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan's assets are solely invested in the Employer's common stock. These transactions qualify as exempt party-in-interest transactions.

The Employer provides certain accounting and administrative services to the Plan for which it receives no compensation.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests primarily in the Employer's common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in Employer's common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.
