NOTES TO FINANCIAL STATEMENTS

FOR THE YEAR ENDED DECEMBER 31, 2024

**A. Description of Plan**

The following description of the Autobody Products, Inc. (company) Profit Sharing Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions:

- 1) *General.* The plan is a defined contribution plan covering all full time employees of the company who have one year of service and are age twenty-one or older. The plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).
- 2) *Contributions.* The amount to be contributed to the Plan shall be determined by the Employer, in its absolute discretion. A contribution may be made without regard to the existence of current or accumulated profits. Participants direct the investments of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds as investment options for participants. For the year ended December 31, 2024 the company contributed 15 percent of eligible employees compensation to the plan.
- 3) *Participant Accounts.* Each participant's account is credited with the company's contribution and their respective earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) *Vesting.* A participant will be credited with a year of service for vesting purposes upon completion of 1,000 hours of service during a plan year. A participant is 100 percent vested after 6 years of credited service.
- 5) *Participant Loans.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$25,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's accounts and bear interest, not less than 1 percent in excess of the prime rate in effect as of the date of such loan. Principal and interest are paid ratably through monthly payroll deductions.
- 6) *Payment of Benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive a lump amount equal to the value of the participant's vested interest in his or her account, or annual installments over the approximate joint life expectancy of the participant and his spouse or designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
- 7) *Forfeited Accounts.* At December 31, 2024 forfeited nonvested accounts totaled \$34,551. These accounts will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$26,665 from forfeited nonvested accounts.

**B. Summary of Accounting Policies**

*Basis of Accounting.*

The financial statements of the plan are prepared on the accrual basis of accounting. Investments held by a defined-contribution plan are required to be reported at fair value. The Statement of Net Assets Available for Benefits and Statement of Changes in Net Assets Available for Benefits are prepared on a fair value basis.

*Use of Estimates.*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes, therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition.*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

The Plan accrues a percentage of the fair market value of the Plan assets which is transferred into a holding account to pay recordkeeping fees and other administrative expenses as they come due. The Company must pay any expenses which exceed amounts accumulated in the holding account.

*Subsequent Events*

Management has evaluated events as of July 15, 2025, and has concluded that there were no subsequent events that materially affected these financial statements for the years ended December 31, 2024 and 2023.

**C. Fair Value Measurements**

**FASB ASC 820 Provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).**

**Following is a description of the valuation methodologies used for assets measure at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.**

***Mutual Funds***

**Valued at the net asset value (NAV) of shares held by the plan at year end.**

**The following methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.**

**The plan's assets are valued at Level 1, based upon the FASB ASC 820 method for determining fair value.**

**D. Plan Termination**

**Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.**

**E. Tax Status**

**The IRS has determined and informed the company by a letter dated January 27, 2015, that the plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Service Code (IRC). The plan administrator and the plan's tax counsel believe that the plan is currently being operated in compliance with the applicable requirements of the IRC.**

**The federal tax returns of the Plan for 2022, 2023 and 2024 are subject to examination by the taxing authorities, generally for three years after they were filed.**

**F. Risk and Uncertainties**

The plan invests in various investment mutual funds. Investment mutual funds are exposed to various risk such as interest rates, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.

**G. Related Party Transactions**

The Company absorbs a portion of the administrative costs related to the plan. Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

The Plan's investments include proprietary funds managed by American Funds, who holds these investments and therefore, these transactions qualify as party-in-interest transactions.

Participants have loans from their fund accounts outstanding in the amount of \$132,134 and \$78,158, as of December 31, 2024 and 2023, respectively.
