INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Management

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Project for Pride in Living, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of Project for Pride in Living, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan for Project for Pride in Living, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established to provide employees with a systematic means of saving and investing for the future. All permissible employees of Project for Pride in Living, Inc. (the Organization) are eligible to enroll on the first day of the month immediately following their date of hire.

The Plan's custodian is Mutual of America Life Insurance Company (Mutual of America), and the Organization is the Plan Sponsor and Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Investments are held in pooled separate accounts and an interest accumulation account.

Contributions - Participants are allowed to make elective, pretax (traditional 403(b)) deferral contributions or elective after-tax (Roth 403(b)) deferral contributions up to applicable limits and not to exceed 100% of pretax annual compensation, as defined in the Plan. The Plan includes an auto-enrollment feature whereby employees are automatically enrolled in the Plan at a 2% deferral rate, unless elected otherwise. Employees can opt out at any time. Participants who have attained the age of 50 are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

Participants are eligible for employer matching contributions after completing 12 months and not less than 1,000 hours of service. The maximum matching contributions are 2% of compensation for participants with fewer than 5 years of service and 4% for participants with 5 or more years of service, as defined by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Organization's matching contributions, and (b) Plan earnings and changes in the value of investments, net of expenses. Allocations are based on account balances, deferrals and years of service as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions, Organization matching contributions, and actual earnings thereon.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 and a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of 5.85% which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits - On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or in amounts of at least \$100 withdrawn on a monthly basis if the participant has attained age 59.5 or has terminated employment at age 55 or later.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer contributions are allocated on the same basis as participant contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect amounts reported in the financial statements during the reporting period. Actual results could differ from such estimates.

Payment of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Valuation of Investments - Pooled separate accounts are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses - Administrative expenses for legal, auditing, and administration of the Plan, except for custodian advisory, trust and loan fees, are paid either by the Plan or by the Organization at the Organization's discretion. Expenses paid by the Organization are excluded from these financial statements.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

4. FAIR VALUE MEASUREMENTS (Continued)

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are each invested in a distinct underlying mutual fund. The fair value of each pooled separate account is determined using the value per unit, which is based on the value of the underlying mutual fund shares which are actively traded. There are no redemption restrictions in the pooled separate accounts. Because net asset value (NAV) is used as a practical expedient, these investments are not categorized within the fair value hierarchy.

The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the pooled separate accounts could result in a different fair value measurement at the reporting date.

5. INTEREST ACCUMULATION ACCOUNT

The Plan has an interest accumulation account with Mutual of America. This account is considered a cash equivalent. Mutual of America maintains the contributions in its general account. The account is credited with earnings at the crediting interest rate and charged for participant withdrawals and administrative expenses. The account balance represents contributions made to the interest accumulation account, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balance.

There are no reserves against the interest accumulation account for credit risk. The crediting interest rate is determined from time to time by Mutual of America but currently may not be less than 1.00%. The minimum rate is determined each January 1. Interest credited to participants was 2.85% and 3.00% during 2024 and 2023.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all of the assets will be distributed to the participants based upon the balances in their respective accounts.

7. INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

8. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are shares of pooled separate accounts managed by and an interest accumulation account held by the custodian and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment custodian services were included as a reduction of the return earned on each pooled separate account and the interest accumulation account.

The Plan's sponsor pays certain administrative expenses of the Plan. These expenses were approximately \$9,450 during 2024.

The Plan paid Mutual of America \$2,671 during the year ended December 31, 2024.
