### 1. Description of the Plan

The following description of the Cape Henry Associates, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of Cape Henry Associates, Inc. (the Company or Plan Sponsor). There is no age requirement and employees are eligible to participate upon completion of 3 months of service with the Company. Plan entry dates for eligible employees are the first day of each month after completion of the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective January 1, 2022, the Plan adopted the restated pre-approved plan from John Hancock Retirement Plan Services, LLC to reflect remedial amendments associated with its restatement of its pre-approved plan.

On September 30, 2022, JANUS Research Group, LLC acquired 100% of the stock of Cape Henry Associates, Inc., the Plan Sponsor, under the terms of a Stock Purchase Agreement.

Effective April 19, 2023, the Plan was merged with the JANUS Research Group 401(k) Plan (the JANUS Plan). Net assets of the Plan totaling \$4,430,961 were transferred, which included \$80,031 of outstanding loans.

#### *Trustee, Custodian and Administration of the Plan*

The trustee of the Plan is John Hancock Trust Company, LLC and the recordkeeper of the Plan is John Hancock Retirement Plan Services (collectively, John Hancock). The administrator of the Plan is the Company. John Hancock holds all assets of the Plan in accordance with the service provider contract with the Company. The Company's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Contributions*

Each year, participants could contribute up to 100% of eligible compensation, as defined in the Plan. Salary deferral agreements could be made, terminated, or changed according to procedures and limitations set up by the Plan Administrator and the Plan Document. The Plan also allowed for Roth contributions. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company could make a discretionary employer matching contribution as a percent of eligible compensation deferred by participants. Catch-up contributions were not eligible for discretionary matching contributions. During the period from January 1, 2023 through April 19, 2023, the Company matched 100% of participant contributions up to 3% of eligible compensation. Contributions received by the Plan during this period were contributions collected for an affiliate plan, specifically the JANUS Research Group 401(k) Plan (Note 8). No contributions were made or received by employees of Cape Henry Associates, Inc. during the period from January 1, 2023 through April 19, 2023.

The Company could also make a discretionary non-elective contribution as determined by the Company's management. No such contributions were made during the period from January 1, 2023 through April 19, 2023. Participants directed the investment of their contributions into various investment options offered by the Plan.

All contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account was credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants were immediately vested in their voluntary contributions, employer matching contributions, and rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary non-elective contributions, plus earnings thereon, was based on years of continuous service. A participant was vested according to the following schedule:

Participants became fully vested in the event of retirement, death, and disability, as defined by the Plan.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Partial withdrawals or installments were only permitted for participants or beneficiaries who must receive required minimum distributions under Code §401(a)(9). In-service distributions could be made to participants upon attainment of age 52 and the distribution must be at least \$1,000. Immediate lump-sum distributions could be made to terminated participants if the participant's vested account balance is \$5,000 or less, excluding rollovers. For terminated participants with vested balances less than \$1,000, their vested balance could be automatically rolled into an IRA unless otherwise elected. Participants could also receive a distribution of their elective deferral contributions in the event of proven financial hardship. The

hardship distribution must have been at least \$1,000 and only one distribution was allowed per Plan year.

### ***Forfeited Accounts***

At April 19, 2023 and December 31, 2022, forfeited non-vested accounts totaled approximately \$0 and \$5,802, respectively. These accounts could be used to pay administrative expenses and reduce future employer contributions. No forfeitures were used to pay administrative expenses and/or fund employer contributions during the period from January 1, 2023 through April 19, 2023.

### ***Notes Receivable from Participants***

Participants were permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants could borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans were secured by the participant's account and bore interest at the prime rate plus 2% and interest was fixed for the term of the loan. The notes were repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence in which case they could be repaid up to 15 years. These loans were subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Also, each participant could not have more than one loan outstanding at any time.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

### ***Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for further information on fair value measurements.

The Plan's shares of mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds or a money market fund that were registered with the SEC. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The investments in the collective trust funds were valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee of the collective investment trust, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) could occur daily. There were no unfunded commitments and the collective trust funds were direct-filing entities during the year ended December 31, 2023.

The preceding methods described above could produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants were measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor as provided by the Plan Agreement. Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements related to investments and notes receivable from participants held as of April 19, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through April 19, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### 5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments were in funds and accounts that were managed by John Hancock or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to John Hancock by participants. The Plan also issued loans to participants which were secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan held various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Income Tax Status

The Plan used a pre-approved plan document sponsored by John Hancock. John Hancock received an opinion letter from the IRS, dated June 30, 2020, which stated that the pre-approved plan document, as then designed, satisfied the applicable provisions of the IRC. Although the Plan had been amended since the date of the opinion letter, Plan management believed that the Plan was currently designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Operational and Voluntary Compliance

During the period from January 1, 2023 through April 19, 2023, it was discovered that certain Plan provisions were not properly applied in the daily operations of the Plan. The Plan Sponsor permitted all previous employees of Cape Henry Associates, Inc., who became employees of JANUS Research Group (JANUS) effective January 1, 2023, to continue making contributions to the Plan. The Plan failed to adopt a participating employer addendum allowing these employees to continue their participation in the Plan as JANUS employees and therefore, this is considered to be an operational defect. The Company is in the process of determining the appropriate corrective action for this error and determining any amounts due. The amount of any corrective contributions or distributions are not known, but are not expected to be material to the financial statements. The Company will make corrections as soon as administratively feasible. Any required corrections will be reflected in future periods within the JANUS Research Group 401(k) Plan (JANUS Plan) financial statements, as the Plan merged into the JANUS Plan effective April 19, 2023.

For one payroll period in March 2023, the Company made certain errors in calculating contributions to participants' accounts. The Company is in the process of determining the appropriate corrective action for these errors. The Company will make corrections as soon as administratively feasible. Any required corrections will be reflected in future periods within the JANUS Plan financial statements, as the Plan merged into the JANUS Plan effective April 19, 2023.

### 9. Prohibited Transactions

During the Plan year ended December 31, 2022, participant contributions and loan repayments totaling \$227,427 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Employer is in the process of correcting these transactions. The related lost earnings are expected to be remitted to the Plan during 2025.
