Opinion

We have audited the accompanying financial statements of Electric Power Research Institute Self Insured Temporary Disability Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Electric Power Research Institute Self Insured Temporary Disability Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a self-insured single-employer health and welfare plan established in 1996 to provide benefits to eligible employees of Electric Power Research Institute ("EPRI") and its affiliates who have adopted the Plan. EPRI employees assigned to a location outside of California but within the United States are automatically enrolled in the Plan. The Plan is intended to meet the reasonable income needs of an eligible employee who is unable to work in the event of a short-term disability. The plan administrator believes the Plan is designed and operated in conformity with applicable provisions of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Contributions

Effective January 1, 2024, the contribution rate is 0.60% of the earnings with the Company. Contributions are withheld on an after-tax basis. Costs to participants for state-mandated disability coverage, if any, are deducted from amounts participants otherwise would contribute to the Plan.

C. Benefits

The Plan provides earnings protection to participants during short-term disabilities for up to 120 days. Benefit payments begin on the earliest of the eighth consecutive day of disability or the first day in the hospital. Benefits provided by the Plan also include up to 56 days (70 days effective January 1, 2025) of paid family leave. Claimants are eligible to receive 60% of their regular wages, up to a maximum weekly benefit of \$1,800 in 2024. Effective January 1, 2025, claimants are eligible to receive 70% of their regular wages, up to a maximum weekly benefit of \$1,800.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

B. Expenses

EPRI designated a third-party administrator to process benefit claims. Claims administration and other administrative expenses may be paid by the Plan or by EPRI at the discretion of the plan administrator. During 2024, claim administration fees were paid by the Plan. EPRI paid other costs of plan administration.

C. Benefits

Benefits are recorded when paid.

D. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

NOTE 3 - INCOME TAX STATUS

The Plan has not applied for tax-exempt status with Internal Revenue Service. The Code effectively provides that earned income on pre-funded benefits is subject to unrelated business income tax. The Plan recorded no investment income in 2024.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

EPRI pays participant claims approved under terms of the Plan and is reimbursed by the Plan. Amounts due to EPRI were approximately \$82,900 and \$54,300 at December 31, 2024 and 2023, respectively, for unreimbursed claims.

NOTE 5 - TERMINATION

Although it has not expressed any intent to do so, EPRI reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. Upon termination, assets of the Plan will be used to fund benefits for participants whose disability or paid family leave commenced prior to termination.

NOTE 6 - CONCENTRATION OF CREDIT RISK

During the year ended December 31, 2024, the Plan maintained a bank account with cash balances in excess of the federally insured limit of \$250,000 per financial institution. The amount in excess of the limit is subject to risk if the financial institution does not perform. The Plan has not incurred any losses on the uninsured balances. Management believes the financial institution is credit worthy.
