INDEPENDENT AUDITORS' REPORT

To the Retirement Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Roscoe Moss Company Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Roscoe Moss Company Profit Sharing and 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTE A - DESCRIPTION OF THE PLAN

The following description of the Roscoe Moss Company Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

Effective September 1, 1950, the Board of Directors of Roscoe Moss Manufacturing Company (the "Employer") adopted the Plan. The Plan is a defined contribution plan covering eligible employees of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is the plan sponsor and plan administrator. The general duties of the administrator are to administer the Plan in accordance with the Plan rules and ensure compliance of the Plan with ERISA.

2. Eligibility

An employee is immediately eligible to defer and to receive a matching contribution on entry dates of January 1 and July 1. Upon completion of 1,000 hours during the plan year and if employed on the last day of the plan year, an employee is eligible to receive an Employer discretionary contribution. Participants who terminate due to death, disability, or after attaining normal retirement age are not subject to the 1,000-hour or last day of the plan year requirements. Employees who are covered by a collective bargaining agreement, leased employees, independent contractors, and non-resident aliens are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute on a tax-deferred basis or make Roth deferral contributions up to the maximum deferral limit per Section 402(g)(1) of the Internal Revenue Code (IRC), subject to the maximum compensation limit under section 401(a)(17) of the IRC. Additional "catch-up" contributions can be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer makes a matching contribution equal to 50% of participant contributions, not to exceed 6% of the participant's compensation. Employer matching contributions totaled \$242,432 for the year ended December 31, 2024. The Employer may also make Employer discretionary contributions equal to a uniform percentage of compensation (not exceeding \$100,000), as determined by the Employer. The Employer discretionary contribution totaled \$987,192 for the year ended December 31, 2024. This amount includes \$800,000 contribution related to the 2024 plan year and \$187,192 in corrections to prior year contributions (see Note F).

4. Participant Accounts

Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's discretionary contribution, plan earnings, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Investment Options

Participants may direct employee and Employer contributions, as desired, in any of a variety of investment options held by Lincoln Financial Group Trust Company, Inc. ("Lincoln"), as selected by the Employer.

6. Vesting

Participants are fully vested in their contributions, rollovers, and Employer matching and Employer discretionary contributions and actual earnings thereon.

7. Benefit Payments

Upon termination of service for any reason, a participant, or participant's beneficiary in the case of death, may receive a single lump-sum payment. In-service and hardship distributions are permitted if certain criteria are met.

8. Forfeitures

Employer contributions are 100% vested and there are no forfeitures outstanding at December 31, 2024 and 2023. In the event of excess Employer contributions, forfeitures are applied against future Employer contributions, as provided in the plan document.

9. Notes Receivable from Participants

Participant loans are not allowed.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Payment of Benefits

Benefits are recorded when paid.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

5. Administrative Expenses

Except for administrative expenses incurred on specific participant initiated transactions, all out-of-pocket administrative expenses of the Plan are paid by the Employer. Expenses paid by the Employer are not included in these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

6. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln (the trustee of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: The net asset value (NAV) is determined daily based on the value of the underlying assets owned by the trust minus its liabilities, divided by the number of shares outstanding. The NAV is not a quoted price in an active market. Investment income earned is reinvested and included in the determination of NAV. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - GROUP ANNUITY CONTRACT WITH THE LINCOLN NATIONAL LIFE INSURANCE COMPANY

The Plan invests in a traditional fully benefit-responsive investment contract with The Lincoln National Life Insurance Company (Lincoln National) totaling \$4,508,856 and \$7,899,611 at December 31, 2024 and 2023, respectively. Lincoln National maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest credited, less participant withdrawals. Participant initiated withdrawals to a competing fund, as defined by the contract, are not permitted.

The Plan may terminate the contract at any time by giving notice of such termination at least 90 days in advance of the termination date and electing one of the available payment options in the contract specifications. One payment option allows for the contract to be paid out at book value over five years and another option allows for a lump sum payment with a market value adjustment.

Lincoln National may notify the Plan of termination under certain events. Examples of such events include the following:

1. Failure of the Plan to pay fees due to Lincoln National
2. The Plan ceases to meet the requirements of the IRC for purchasers of this contract

3. At any time following the end of the third contract year, the Plan's account balance is less than \$15,000
4. At any time following the end of the third contract year, there is no deposit activity for a 24-consecutive-month period and the Plan's account balance is less than \$50,000
5. The Plan fails to furnish requested information or other documentation
6. Lincoln National discovers any misrepresentation of material information
7. Lincoln discontinues offering this contract form to the public
8. The Plan terminates its recordkeeping agreement with Lincoln

Lincoln National will specify a termination date at least 90 days from the date of notice. The Plan may elect one of the available payment options provided in the contract.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE F - TAX STATUS

The Employer adopted a non-standardized pre-approved profit sharing plan ("non-standardized plan"), which received a favorable opinion letter dated June 30, 2020. The Internal Revenue Service (IRS) stated that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. The plan administrator and the Plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. During the year ended December 31, 2024, the Employer discovered that certain eligible participants were inadvertently excluded from the Employer discretionary contributions for the years ended December 31, 2017 through December 31, 2023. To correct for this error, contributions totaling \$187,192 and earnings totaling \$40,100 were remitted to the Plan and allocated to affected participants in December 31, 2024. Other administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Employer reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, further contributions to the Plan would cease, and the assets would be distributed among the participants of the Plan in accordance with the provisions of the Plan.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest, by definition, include a plan sponsor or employer, fiduciaries (including those who provide investment advice or who have discretionary control over plan assets), and those who provide services to the Plan. Plan investments are held and managed by Lincoln, the trustee and Lincoln National, a custodian of the Plan. Lincoln Retirement Services Company, LLC is the record-keeper for the Plan. These transactions qualify as exempt party-in-interest transactions.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE J - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to require one year of service for participants to receive Employer discretionary contributions.

Plan management has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued and has determined that there were no other events to be disclosed in the accompanying financial statements.
