## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants  
**L&L Products Employees' Profit Sharing Plan and Trust**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the L&L Products Employees' Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Note 1 – Description of the Plan

#### General

The Plan is a defined contribution profit sharing plan that was established on July 1, 1977 by L&L Products (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

#### Administration

The Plan Sponsor and named Plan Administrator is L&L Products. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed an Investment Committee which includes Company officers and members of the human resources department. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees with the support of the Plan's Investment Advisor, Retirement Funding Advisors. The Plan's Trustee and Investment Custodian is State Street Bank and Trust Company (SSBT). The Investment Custodian holds all of the Plan's assets. SSBT has contracted with Transamerica Retirement Solutions to provide certain trustee services including executing all of the Plan's transactions. The Company has also retained Transamerica Retirement Solutions to provide participant recordkeeping and administration services.

#### Eligibility

The Plan covers all employees of the Company, except those who are covered by a collective bargaining agreement, non-resident aliens, interns, leased employees, and independent contractors. All eligible employees may begin participating in the Plan upon completing three months of service with the Company, with the entry date being the first day of the month coinciding with or next following completion of the eligibility requirements.

#### Contributions to the Plan

Each year, employees may elect to contribute a portion of their pre-tax annual compensation, as defined in the plan document, up to the maximum amount allowed by law, to their accounts through payroll withholdings. The Plan also allows employees to make after-tax Roth contributions. Employees who have attained age 50 before the end of the year are eligible to make 'catch-up' contributions. Employees may also contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled at a deferral rate of 5% unless they affirmatively elect not to participate or a varying rate. Auto-enrollment contributions are invested in the Plan's Qualified Default Investment Alternative until changed by the employee.

The Company has adopted a flexible Safe Harbor option. This election must be made every year and is subject to Board approval. For the year ended December 31, 2024, the Company made Safe Harbor contributions on behalf of eligible employees equal to 5% of those employees' eligible compensation. Compensation for plan purposes is limited to \$345,000 for 2024. For the year ended December 31, 2024, total Safe Harbor contributions to the Plan amounted to \$3,171,339. The eligibility requirement for the employer Safe Harbor contributions is one year of service with a minimum of 1,000 hours for the first year and a minimum of 1 hour of service thereafter. Employees do not have to be employed on the last day of the plan year to be eligible; however, an employee must have received compensation from the Plan Administrator (employer) to be entitled to allocations of Safe Harbor contributions.

The employer may also make an additional discretionary contribution to each eligible employee based on a uniform per capita dollar amount. These annual employer contributions to the Plan are determined at the discretion of the Board of Directors. An additional contribution in the amount of \$2,843,518 was made for the year ended December 31, 2024. Eligibility requirements to receive the additional discretionary contribution are equivalent to that of the Safe Harbor eligibility requirements.

Employees direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The Company's contributions are allocated in the same manner as that of the employee's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions as well as plan earnings. Participant accounts are charged directly for recordkeeping and investment advisory fees, and credited for fund revenue sharing, based on the investment options held in their accounts. See Note 2 for a discussion of revenue sharing, fees, and expenses. Participants are entitled to the benefit that can be provided from the participant's vested account.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance, subject to certain Department of Labor and IRS requirements. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prevailing prime rate plus 1%. Principal and interest is paid ratably through payroll deductions each pay period.

### Payment of Benefits

On termination of service, participants with vested account balances of \$7,000 or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent unless they elect a rollover. Participants whose vested account balances exceed \$7,000 may elect a lump sum distribution, periodic equal installment payments, a partial withdrawal, or a rollover of their account balance to another qualified account. Additionally, they may also elect to defer the distribution of their plan balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses, but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability, and retirement. Participants should refer to the full plan document for details.

The Plan allows for in-service distributions upon attainment of the Plan's normal retirement age (age 59 1/2 for employees hired on or after January 1, 2011, and age 50 for employees hired prior to January 1, 2011) for all deferral contributions, discretionary employer contributions and rollover contributions for any reason. Regardless of an employee's hire date, the participant must reach age 59 1/2 prior to eligibility for in-service distributions for employer Safe Harbor and discretionary contributions made for plan years beginning January 1, 2011. The Plan also allows for in-service distributions prior to attainment of the Plan's normal retirement age due to financial hardship, as defined in the plan document, from deferral contributions, rollover contributions, and Company contributions made prior to the plan year beginning January 1, 2011. In-service distributions taken due to financial hardship are only permitted provided that the participant has an outstanding loan at the time of distribution.

### Vesting

Participants are 100% vested at all times in both employer and employee contributions.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements are prepared using the accrual basis of accounting. Income from investments is recorded when it is earned. Employee contributions are recorded in the period to which they pertain. Expenses are recorded in the accounting period in which they are incurred.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Collective Trust is valued at fair value using the net asset value as a practical expedient. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the participant notes receivable is reclassified to benefits paid to participants.

### Payment of Benefits

Benefits are recorded when paid.

### Revenue Sharing, Fees, and Expenses

Certain mutual funds offered by the Plan provide revenue sharing payments to the Plan's recordkeeper. During 2024, the Plan received \$92,101 in revenue payments and paid \$71,634 in investment advisory fees, and \$114,287 in administrative fees to the Plan's recordkeeper. Other fees paid by participants amounting to \$16,637 relate to loan initiation and maintenance, distribution, Qualified Domestic Relations orders, and other fees paid to the Plan's recordkeeper. Certain investment related expenses are included in investment income presented in the accompanying statement of changes in net assets available for benefits.

Management fees and operating expenses charged to the Plan for the investments in mutual funds are deducted from income earned on a daily basis.

### Subsequent Events

### **Note 3 – Unaudited Information Certified by the Custodians**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by SSBT and Transamerica Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; and
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

### **Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Mutual Funds' fair values are determined by reference to quoted market prices and other relevant information generated by market transactions, and therefore the Company classifies these as Level 1 investments.

Collective Trust

The Collective Trust Fund is not publicly traded and represents a Stable Pooled Fund. Fair value is determined by the underlying assets' daily value as reported by the Galliard Stable Return Fund W using net asset value as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5 – Party-in-Interest Transactions**

Certain plan investments are managed by State Street Bank and Trust Company and Transamerica Retirement Solutions, who are the Plan's Trustee and recordkeepers, respectively. The Plan Administrator also engages a third-party to provide investment advisory services. Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) was paid to the recordkeeper from total annual operating expenses charged on the balance of fund investments at various percentages, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA.

### **Note 7 – Plan Amendment and Tax Status**

The Plan is utilizing a pre-approved plan document, which was amended and restated effective October 14, 2021. The IRS has determined and informed the Company by letter dated June 30, 2020, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). While the amended and restated plan document has not received an individual IRS determination letter, plan management believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan permitted provisions of SECURE Act 2.0 during the year ended December 31, 2024. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

The plan document was most recently amended, effective November 2024, to update historical plan provisions and current administrative procedures.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Administrator believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined.
