To Whom It May Concern:

We are writing to provide an explanation for the delayed filing of our Form 5500 for the plan year ending December 31, 2024.

Alpas Wellness is a Substance Abuse and Mental Health treatment facility committed to upholding the highest ethical standards and complying with all applicable federal and state regulations. As an organization that centers its values around care, integrity, and accountability, we sincerely regret the delay in filing our Form 5500 and take full responsibility for this oversight.

The cause of this delinquency was due to a former employee who was entrusted with overseeing our benefits administration and compliance tasks, including the timely preparation and submission of Form 5500 filings. Unfortunately, this individual failed to carry out these duties appropriately. We have since terminated this individual due to a demonstrated pattern of incompetence and discovered several compliance failures, including the missed filing.

In early 2025, we hired a Human Resources Officer who began a comprehensive audit of our HR and benefits processes. Through this audit, we uncovered a range of administrative oversights and took immediate steps to correct them, including initiating the Delinquent Filer Voluntary Compliance Program (DFVCP) filing process.

We want to assure the Department that we are committed to maintaining compliance moving forward. We are now implementing more robust oversight and process controls to ensure that our responsibilities under ERISA and other relevant laws are met timely and accurately.

We respectfully ask that our explanation of reasonable cause for the late filing be accepted as we continue to correct past errors and reinforce a culture of accountability and regulatory compliance at Alpas Wellness.
