Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Douglas J Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Douglas J Management, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Douglas J Management, LLC (the "Company") who meet the eligibility requirements outlined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants are eligible to participate in the Plan if they are 18 years of age and have two consecutive months of service. Participants are eligible to receive employer matching contributions if they make elective deferrals during a plan year. Participants are eligible to receive discretionary contributions if they have met the eligibility requirement to participate in the Plan.

Contributions

The Plan provides for elective deferral contributions subject to dollar limitations contained in Internal Revenue Code Section 402(g). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees of the Company automatically become enrolled in the Plan at a 4 percent deferral rate upon meeting eligibility guidelines unless they elect otherwise. Company matching and nonmatching contributions are discretionary. For the 2024 and 2023 plan years, the Company elected to offer a matching contribution of 25 percent of employee deferrals up to a maximum of 4 percent of compensation. For the 2024 and 2023 plan years, management elected not to make a discretionary nonmatching contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service from employment date. Participants vest in matching contributions made by the Company 100 percent after one year of service, and profit-sharing contributions vest 100 percent after three years of service. The employee is fully vested upon death or disability for all employer contributions.

Participant Notes Receivable

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by any other loans from the Plan that had outstanding balances during the preceding one-year period, or 50 percent of their account balances. Loans, other than qualifying home loans, must have a term no longer than five years and interest at an annual rate based on the prime rate on the day that the note is executed and will take into account the participant's creditworthiness and collateral offered.

Note 1 - Plan Description (Continued)

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a direct rollover to another qualified retirement plan, an Internal Revenue Code Section 403(b) tax-deferred annuity, a governmental 457 plan, or an IRA. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a participant's vested accrued benefit does not exceed \$5,000 at the time of the participant's termination from service, the amount will be distributed in a single cash payment or rolled over to an IRA.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Forfeitures

If a participant is not fully vested on his or her termination date, nonvested amounts are forfeited. Forfeitures are used to reduce future company contributions. At December 31, 2024 and 2023, there was no forfeiture balance.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

Common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 8, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Reliance Trust Company (the "Trustee") held the Plan's investments and executed all related transactions during the periods under audit. The investments and participant notes receivable and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information provided by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require that certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Party-in-interest Transactions

The Plan invests in certain investments managed by Reliance Trust Company or its affiliates. Reliance Trust Company functions as a trustee of the Plan's assets and as the transaction clearinghouse for the Plan; therefore, these transactions qualify as party-in-interest transactions.

In addition, the Company pays certain administrative fees of the Plan. These fees are not significant to the Plan's net assets, although they qualify as party-in-interest transactions.
