INDEPENDENT AUDITOR'S REPORT

To the Administrators
Hutson, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hutson, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employment Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting; and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 – PLAN DESCRIPTION

The following brief description of the Hutson, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan established by Hutson, Inc. (the Company) under the provision of Section 404(c) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan was established effective January 1, 1997 and covers substantially all employees of the Company who have completed one month of service. Hutson, Inc. of Michigan is an affiliate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Salary deferral contributions may be made by participating employees from 1% to 80% in 2024 and 1% to 50% in 2023 of the participant's eligible compensation as defined by the Plan. The Plan permits the automatic enrollment of eligible employees in the Plan, unless the employee affirmatively elects otherwise. The automatic deferral percentage is 6% of eligible compensation. The automatic deferral amount increases by 1% each year up to a maximum of 15%. Participants who have obtained the age of 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers participants the option to invest in various mutual funds.

The Company may elect to make a contribution to match employees' elective deferrals. Matches for the current year are contributed in the following year. For the years ended December 31, 2024 and 2023, the Company contributed 30% of a participant's deferrals up to a maximum of 10% of compensation to the Plan for prior year elective contribution. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer matching contributions, discretionary contributions and earnings thereon is based on years of continuous service. A participant vests according to the following schedule:

Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six years or more	100%

The plan administrator will distribute vested account balances of amounts less than \$5,000. Amounts greater than \$1,000 will be subject to automatic rollover unless a lump-sum distribution is requested by the participant. A participant becomes fully vested upon termination due to death, disability or retirement.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution. Plan earnings are charged with an allocation of administrative expenses. All allocations are based on participant account balances or current contributions defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable – Participant Loans

Participants may borrow a minimum of \$500 up to a maximum of \$50,000 or 50% of the vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at prime plus two percentage points. Principal and interest are paid ratably through bi-weekly payroll deductions. Outstanding loans must be repaid in full before a new loan can be made.

Payments to Participants

On termination of service, a participant may receive a lump-sum distribution or a direct rollover to an Individual Retirement Account (IRA) equal to the value of the participant's vested account balance. If a participant's balance is greater than \$5,000, the benefits may be paid in installments, a partial withdrawal, or deferred until the participant reaches their required minimum distribution (RMD) starting age. The RMD starting age is defined by the participant's birth date as follows:

Born before July 1, 1949	70 1/2
Born between July 1, 1949, and December 31, 1950	72
Born between January 1, 1951, and December 31, 1959	73
Born on or after January 1, 1960	75

In-service distributions to participants after age 59 ½ are allowed, as well as hardship distributions, provided that certain criteria are met.

Forfeited Accounts

Forfeitures are applied against the current year match at the Company's discretion. The prior year forfeited non-vested accounts totaling \$30,373 were applied against the 2023 match that was contributed in 2024. The forfeitures of \$99,651 will be applied against the 2024 match contributed in 2025. These amounts are held in a separate account within the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements were prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles (GAAP). The primary difference between the two methods of accounting is the timing of recognition of revenue and expenses.

Use of Estimates

The preparation of financial statements with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets. Actual results could differ from those estimates.

Investment Valuation and Recognition

The market value of the investment assets was furnished to the plan administrator by the Trustee of the Plan. Market values are based on the quoted market price of the investment. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Participant loans are valued at amortized cost, which represents fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the date on which they are received.

Net Appreciation in Fair Value Investments

Net realized and unrealized appreciation is recorded in the accompanying Statement of Changes in Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Subsequent events have been evaluated through July 10, 2025, the date the financial statements were available to be issued.

New Accounting Pronouncements

From time-to-time, new accounting pronouncements are issued by the Financial Accounting Standards Board (FASB) or other standards setting bodies that the Company adopts as of the specified effective date. Unless otherwise discussed, management believes the impact of any other recently issued standards that are not yet effective are either not applicable at this time or will not have a material impact upon adoption.

NOTE 3 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820 *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 guidance are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include: quoted prices in active and inactive markets, observable inputs other than quoted prices and other inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Mutual funds: Valued at the net asset value of shares held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – TAX STATUS

The Plan was adopted under a Prototype Non-standardized Profit-Sharing Plan that obtained an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020. The opinion letter states that the form of the Plan is acceptable under section 401 of the IRC. No separate determination letter has been obtained by the Plan as it is no longer required by the IRS for plans that are adopted under Prototype Non-standardized plans.

Although the Plan has been amended, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, therefore, believe that the Plan is qualified, and the related trust is exempt.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Reliance Trust Company is the Trustee as defined by the Plan, thus, transactions qualify as party-in-interest transactions. Fees paid by the Plan to Reliance Trust Company amounted to \$194,164 and \$190,134 for the years ended December 31, 2024 and 2023, respectively.

NOTE 9 – SUBSEQUENT EVENTS

On January 1, 2025, the Plan was amended to increase the amount a terminated participant’s vested account balance will be distributed or rolled over by the plan administrator from \$5,000 to \$7,000. Additionally, the Trustee of the Plan was changed from Reliance Trust Company to ADP Retirement Trust Services, LLC.

On January 14, 2025, the Trustee of the Plan was changed again to Great Gray Trust Company, LLC.
