Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Pension Plan for U.S. Employees of Rogers and Toronto Blue Jays (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements (Expressed in U.S. dollars)

1. Plan Description

The Pension Plan for U.S. Employees of Rogers and Toronto Blue Jays (the Plan) is a defined contribution plan sponsored by Rogers Blue Jays Baseball Partnership. Effective January 1, 2012, Rogers Venture Partners LLC was added as a participating employer. Rogers Blue Jays Baseball Partnership and Rogers Venture Partners LLC are collectively referred to as the Employer and Plan Sponsor. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The following summary of the Plan provides general information only. Participants should refer to the Plan Document and the Adoption Agreement, restated effective January 1, 2022 (collectively known as the Plan document), for the complete description of the Plan's provisions.

General

The Plan was established, effective January 1, 1990, by the Employer for the benefit of its employees and to qualify under Section 401(k) of the U.S. Internal Revenue Code (IRC). The Employer contracts with Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, FSB (collectively, Prudential) for the investing, safekeeping, and accounting for the Plan's assets and recordkeeping of the individual participant's accounts.

On April 1, 2022, Empower Annuity Insurance Company of America (EAICA), formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC (Empower), acquired the full-service retirement business of Prudential Financial, Inc. (Prudential). In connection with the transaction, Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, FSB were acquired by Empower. On October 3, 2022, Prudential Retirement Insurance and Annuity Company was renamed Empower Annuity Insurance Company. Effective March 31, 2023, Prudential Bank & Trust, FSB merged into Empower Trust Company, LLC, an Empower affiliate, and all services performed by Prudential Bank & Trust, FSB was assumed by Empower Trust Company, LLC.

Eligibility

The Plan covers U.S.-based salaried employees who have completed six months of service or 1,000 hours of service within the Plan year who are eligible to participate in the Plan and exclude employees compensated on other than a salary-only basis, employees whose regular place of employment is located in Canada, and interns. If the employees have prior professional baseball experience, the service requirement is waived.

Effective January 1, 2024, employees working at least 500 hours of service during each of three consecutive 12-month periods becomes eligible to make deferrals on the date specified in the Plan provided that the employee is an eligible employee on such date.

Contributions

Each participant may contribute to the Plan up to a maximum amount permitted under the IRC regulation for the applicable Plan year. The maximum amount was \$23,000 and \$22,500 for 2024 and 2023, respectively, with an additional amount of \$7,500 for each of 2024 and 2023, permitted for participants ages 50 and older for catch-up contributions. Effective January 1, 2024, the Plan also allows for Roth contributions.

The Employer will contribute up to 2%, equal to 50% of each participant's contribution up to 4% of each participant's pretax annual compensation. In addition, the Employer will make non-discretionary contributions equal to 6% of pre-tax annual compensation to all participants, subject to limits prescribed in the IRC.

The Plan permits participants to have their interest in other qualified plans rolled over into the Plan (rollover).

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's contribution, and Plan earnings (losses) on investments, net of allocable investment fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants, at their direction, must invest their contributions in one or more investment fund options offered by the Plan. Participants may change their investment options daily, unless restricted by the investment options previously selected.

Participant Withdrawals and Distributions

Upon the termination of service, a participant (or a designated beneficiary) will receive the current value of his or her own participant account plus the value of the Employer's contributions in which the participant is vested (account value). Account values will be paid in full when a participant retires at the normal retirement age of 65 (or an early retirement at the age of 55 and completes two years of service) or becomes totally disabled. Upon death, the participant's vested account value will be paid in full to the participant's designated beneficiary.

In addition, at age 59½, participants are permitted to withdraw balances that have been rolled into the Plan.

Distributions are either in a lump sum cash payment or through the purchase of an annuity, in accordance with the Plan's provision.

Vesting and Forfeitures

Participant contributions and the earnings thereon are fully vested at all times. Employer contributions and the earnings thereon are fully vested after two years of eligible service. However, if an employee has prior professional baseball experience, this shall be counted toward the vesting requirements under the Plan.

Amounts forfeited by nonvested participants who terminated their employment are used to reduce future Employer contributions or pay for Plan expenses. For the years ended December 31, 2024 and 2023, forfeitures used to reduce the Employer contributions were \$6,395 and \$0, respectively, while forfeitures used to pay for Plan expenses were \$11,868 and \$0, respectively. At December 31, 2024 and 2023, nonvested forfeited accounts amounted to \$12,918 and \$19,267, respectively.

Plan Expenses

Certain administrative expenses are paid by both the Plan and the Employer. Expenses paid by the Employer are excluded from the financial statements. Investment-related expenses are paid from investment funds that participants' accounts are invested in and reflected in the net appreciation or depreciation in the fair value of investments in the statements of changes in net assets available for plan benefits.

2. Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with U.S. generally accepted accounting principles (GAAP).

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date.

The net appreciation (depreciation) in the fair value of Plan investments presented in the statements of changes in net assets available for plan benefits consists of realized gains or losses on investments bought and sold and the change in unrealized appreciation or depreciation on those investments still held from one period to another.

Investments held by the Plan are stated at fair value with the exception of the guaranteed interest account, which is stated at contract value, as described in Note 4 below.

Payment of Benefits

Benefits are recorded when paid.

Revenue Credits

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. During 2024 and 2023, the Plan received credits of approximately \$27,506 and \$779, respectively, which was used to pay eligible participants' administrative expenses. Administrative expenses are presented net of revenue credits in the statements of changes in net assets available for plan benefits.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC as of December 31, 2024 and 2023 and for the period from April 1, 2023 to December 31, 2024, and Prudential Bank and Trust, FSB for the period from January 1, 2023 to March 31, 2023, which are qualified institutions.

4. Guaranteed Interest Account

The Plan holds a traditional guaranteed interest account benefit-responsive investment contract with Prudential Retirement Insurance and Annuity Company (Insurance Provider), whose name changed to Empower Annuity Insurance Company as described in Note 1. Empower Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company, as issuer of the contract, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual calendar year basis for resetting but may not be less than 3%.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include: (a) amendments to the Plan documents (including complete or partial termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value, is probable.

There are no events that allow Empower Annuity Insurance Company to terminate the contract that requires the Plan to settle at an amount different than contract value paid either within 90 days or over time. There are, however, certain restrictions on withdrawals such as maximum amounts that may be withdrawn in an individual year if the withdrawals are to certain related contracts or other funding agents.

5. Fair Value Measurement

GAAP establishes a framework that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Fair value is the price the Plan would receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. In the absence of active markets for the identical assets and liabilities, such measurements involve developing assumptions based on market observable data and, in the absence of such data, internal information that is consistent with what market participants would use in a hypothetical transaction that occurs at the measurement date.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

Level 1 - This level consists of quoted prices in active markets for identical investments.

Level 2 - This level consists of quoted prices for similar investments in active markets; quoted prices for identical or similar investments in markets that are not active; and model-derived valuations whose inputs are observable or whose significant value drivers are observable.

Level 3 - This level consists of significant unobservable inputs to the valuation model.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account - The value of the pooled separate account (PSA) is determined at the close of each business day at unit value, which is based on the fair value of the underlying assets, which may consist of registered investment companies and securities. The unit value of the PSA is published on NASDAQ; however, the PSA is not publicly traded. The value of the underlying investments in the registered investment companies and securities are based on the daily value of the underlying registered investment companies and securities on an open market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan and the underlying trust have adopted a pre-approved plan, which received an opinion letter dated September 16, 2022, from the Internal Revenue Service (IRS), stating that the plan is qualified under Section 401(a) of the IRC and is, therefore, exempt from federal income taxes under provisions of Section 501(a) of the IRC. The Plan administrator and the Plan's ERISA counsel believe that the Plan and the underlying trust were designed and have been operating within the terms of the Plan, and the trust remains qualified under the applicable provisions of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts and the Plan assets distributed in accordance with the provision of applicable laws.

8. Related Party Transactions

Certain of the Plan's investments are managed by Empower Trust Company, LLC for the period of April 1, 2023 to December 31, 2024, and Prudential Bank and Trust, FSB for the period from January 1, 2023 to March 31, 2023, and these transactions qualify as exempt party-in-interest transactions.

9. Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

10. Subsequent Events

The Plan has evaluated subsequent events from December 31, 2024 through June 17, 2025, the date at which the financial statements were available to be issued, and no disclosures were required.
