Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Norlen, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion



NOTE 1 - Description of Plan

The following description of the Norlen, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan, as adopted effective January 1, 1998, and restated January 1, 2022, covering all employees of Norlen, Inc., Tomcor Industries, LLC, and Suthers Family Limited Partnership (collectively referred to as the "Company"), who have completed one month of service and are age 21 or older. The Plan was amended effective September 28, 2023, to discontinue Tomcor Industries, LLC and Suthers Family Limited Partnership as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service ("IRS"). The Plan provides for both pre-tax and Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution to each participant based on their elective deferrals in a percentage set by the Company each year. The Company matches on catch-up contributions but does not match on rollover contributions. During 2024 and 2023, the Company made a discretionary matching contribution equal to 50% of the first 4% of salary reduction contributions for each participant. The Company's discretionary matching contributions for the years ended December 31, 2024 and 2023 were \$126,218 and \$109,567, respectively.

The Company may also make discretionary nonelective contributions to the Plan, which are shared by participants. These contributions are based on an integrated allocation outlined in the Plan document using the participant's compensation for the Plan year. The Company's discretionary nonelective contributions for the years ended December 31, 2024 and 2023 were \$200,000 and \$200,000, respectively.

Participant Accounts - Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's discretionary matching contributions, (b) the Company's discretionary nonelective contributions, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting - Participants are immediately vested in their voluntary contributions, rollover contributions, and the Company's discretionary matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions plus actual earnings thereon, is based on years of continuous service. A participant is fully vested in the Company's discretionary non-elective contributions after six years of continuous full-time service. Additionally, participants are 100 percent vested in all their accounts under the Plan (assuming they are not fully vested) if they reach normal retirement age (59 ½), or in the event of death or disability while they are employed with the Company.

Participant Loans - Participants can take out loans against their accounts. The minimum loan amount is \$1,000 and the total loan outstanding cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. Participants may have one loan outstanding at any given time. Loan terms range from one to five years. Loans for the purchase of a primary residence may exceed the five-year term but may not exceed 15 years. The loans are secured by the balance in the participant's account and bear an interest rate equal to the prime rate plus 1%. Interest rates range from 4.25 to 9.25 percent. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits - Benefit payments may commence upon the termination of employment, death, disability, or attainment of normal retirement age. A participant whose account balance is greater than \$5,000 may elect to receive the total vested portion of their account balance in a lump-sum distribution, periodic installments if subject to lifetime required minimum distributions, or ad-hoc distributions, as described in the Plan's provisions. Participant account balances that do not exceed \$1,000 will be paid out in the form of a lump-sum distribution upon termination. Participant account balances that exceed \$1,000, but do not exceed \$5,000, will be rolled over into another eligible retirement plan.

Forfeited Accounts - Nonvested portions of participants' accounts will be forfeited upon termination of employment. Dollars forfeited due to terminations of employment will be used to pay administrative expenses of the Plan or used to reduce future employer discretionary nonelective contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,832 and \$2,165, respectively. During 2024 and 2023, forfeitures totaling \$10,500 and \$4,032, respectively, were used to reduce employer discretionary nonelective contributions and pay Plan administrative expenses.

Administrative Expenses - All administrative expenses may be paid out of the Plan unless paid by the Company, at its discretion. During 2024 and 2023, expenses were paid by both the Plan and the Company.

NOTE 2 - Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

Basis of Accounting and Presentation - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reclassified as a distribution and a benefit payment is recorded.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued.

NOTE 3 - Concentrations

The Plan's investments that represented 10 percent or more of the Plan's net assets available for benefits as of December 31, 2024 and 2023 are as follows:

NOTE 4 - Fair Value Measurements

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Fixed annuity:** Valued at fair value using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - Tax Status

The Company became a participating employer in the Wipfli, LLP Non-Standardized Pre-Approved Profit Sharing Plan with CODA effective January 1, 2016, and is relying on its opinion letter dated June 30, 2020. The Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 7 - Transactions with Parties-in-Interest

Fees for legal and professional services rendered to the Plan may be paid for by the Company at its discretion. Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the trustees and recordkeepers for the Plan. In addition, the Plan allows participants to take out loans against their account balances and those activities are deemed party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

NOTE 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100 percent vested in their accounts.

NOTE 11 - Subsequent Events

On April 1, 2025, the Plan resolved to merge into the Ryerson Holding Corporation 401(k) plan (the Ryerson Plan), a multiple-employer plan sponsored by Ryerson Holding Corporation, effective April 1, 2025. The plan transferred its net assets into the Ryerson Plan on May 20, 2025.
