Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Clark Contractors, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Clark Contractors, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1: Description of Plan

The following description of the Clark Contractors, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for more complete information.

General

The Plan, established January 16, 2009, is a defined contribution plan covering substantially all employees of Clark Contractors, LLC (the “Employer”). Employees include all employees of the Employer excluding union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining and certain non-resident aliens who have no earned income from the United States. All employees, as defined above, are eligible to participate in 401(k) employee deferral contributions and employer matching contributions immediately upon employment by the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of their annual compensation not to exceed the limit set by the Internal Revenue Code, which was \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to an additional \$7,500 in 2024 and 2023, respectively. Compensation is defined as total compensation subject to income tax, including any salary reduction contributions.

The Plan allows the Employer to make “safe harbor” contributions equal to 100% of the amount that a participant contributes to the Plan equal to 3% of their compensation and 50% of their contribution on the next 2% of their salary. In addition to the “safe harbor” contributions, the Employer may provide an additional discretionary profit-sharing contribution. To receive an allocation of any discretionary profit-sharing contribution, the participant must have accrued at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year. The Employer did not make any additional discretionary profit-sharing contributions during 2024 or 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of a) the Employer’s contributions and additional profit-sharing contributions and b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, employer “safe harbor” contributions, and any earnings thereon. Vesting in the portion of their account attributable to the Employer’s discretionary profit-sharing contributions is based on each participant’s years of service. A participant is 100% vested after six years of service based on a graduated vesting schedule. A participant will also become fully vested upon death, disability, or retirement at age 65 or older.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

Investment Options

Upon enrollment in the Plan, a participant may elect to have any portion of their account allocated to the investment options under the Plan. Participants may change their investment selections at any time. The Plan currently offers 14 mutual funds as investment options for participants.

Forfeitures

Forfeitures are used to restore participant accounts, offset Plan expenses, and then to reduce any Employer nonelective contributions. At December 31, 2024 and 2023, forfeiture balances totaled \$3,170 and \$2,797, respectively. There were no forfeitures utilized in 2024 or 2023.

Notes Receivable from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are required to be repaid within five years of the loan origination unless the loan is used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a fixed rate of interest equal to the prime rate at the loan date plus one percent. Principal and interest are paid weekly through payroll deductions.

Payment of Benefits

Upon termination of service, death, disability, or retirement a participant, limited by certain Plan provisions, may elect to withdraw all or part of his or her vested balance in a single lump sum. Any balance remaining with the Plan continues to be adjusted for Plan earnings, gains, or losses. According to the Plan, hardship withdrawals are allowed prior to termination. The reason for such hardship withdrawal must meet certain criteria as determined by the Plan. Withdrawals are permitted after a participant's attainment of normal retirement age. There were no benefits requested during 2024 and 2023 that were not paid until the following year.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues and expenses, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred.

Payments of Benefits

Benefits are recorded when paid.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan administrators to make estimates and assumptions that affect the reported amounts of assets and liabilities and the reported amounts of additions and deductions during the reporting period, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated all subsequent events for potential recognition and disclosure through July 14, 2025, the date these financial statements were available to be issued.

Note 3: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer discretionary profit-sharing contributions portion of their account. Employee contributions, employer "safe harbor" contributions and their related earnings are always fully vested.

Note 4: Fair Value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The following section describes the valuation methodologies the Plan uses to measure financial instruments at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

During 2024 and 2023, the Plan's investments (including realized gains and losses on investments bought, sold, and held during the year as well as unrealized appreciation (depreciation) of the investments held at the end of the year) appreciated in value by \$2,144,304 and \$2,067,472, respectively.

Note 5: Income Tax Status

The Plan adopted a prototype plan created by Ascensus, Inc. The prototype plan obtained an opinion letter dated June 30, 2022, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6: Party-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employee association or relatives of such person.

Ascensus is the third-party administrator, Ascensus Trust Company is the trustee, and Stephens Inc. serves as an advisor to the Plan. They are by definition a party-in-interest and as a result, these transactions qualify as party-in-interest transactions. The Plan paid \$46,070 and \$38,535 for investment management, administrative and other fees during the years ended December 31, 2024 and 2023, respectively. These transactions are exempt from being prohibited transactions under ERISA.

Note 7: Information Prepared and Certified by Trustee

All assets of the Plan are held by Ascensus Trust Company and Newport Trust Company, LLC. All investment information and note receivables from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and investment income and interest on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company and Newport Trust Company, LLC the trustees of the Plan.

Note 8: Reconciliation with Form 5500

Certain amounts reported in the Plan's 2024 Form 5500 for changes in net assets available for benefits are different from the amounts reported in the accompanying financial statements. These differences are due to the different presentation of investment income of the Plan.
