Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rödl Management, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

The following description of the Rödl Management, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 1985, to provide retirement and other benefits for the employees of Rödl Management Inc. (the “Sponsor”). Employees of the Sponsor become eligible upon hire and attainment of age 21. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Ascensus Trust Company (“Trustee”) is the trustee of the Plan.

Contributions

Each participant may contribute a portion of his or her compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations, in the form of a salary deferral. Participant salary deferrals may be traditional 401(k) (pretax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

The Sponsor makes safe harbor contributions equal to 3% of participants’ base compensation. The Sponsor, at its sole discretion, may also make additional matching contributions and/or profit-sharing contributions to the Plan annually on behalf of participants. Profit-sharing contributions are allocated amongst participants based upon the ratio that each participant’s compensation bears to the total compensation of all participants. No discretionary contributions were made during the year ended December 31, 2024.

Investment Options

Participants direct all contributions in any whole percentage increments to any of the available funds. Participants may change their allocation among the various investment options at any time via telephone or the internet. The Plan currently offers mutual funds and a money market fund as options.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Sponsor’s contributions on behalf of the participant, and the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant and the participant’s pro-rata share of recordkeeping and investment advisory fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Each participant is immediately fully vested in the portion of his or her account attributable to his or her contributions, Sponsor safe harbor contributions, and earnings thereon. Vesting in the portion of his or her account attributable to the Sponsor's non-safe harbor contributions and earnings thereon is based on years of employment service with the Sponsor as follows:

Notes Receivable from Participants

Loans are allowed for financial distress, medical expenses, education expenses, or the purchase of a principal residence. For such purposes, participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or 50% of their vested account balance. The maximum term of repayment for a loan is five years, except for a loan for the purchase of a principal residence, which may exceed five years. The loans are secured by the balance in the participant's account and bear interest at Prime plus 2%. Principal and interest are paid ratably through payroll deductions. Interest rates ranged from 5.25% to 10.50% on loans outstanding at December 31, 2024.

Payment of Benefits

Upon termination of service with the Sponsor due to death, disability, or retirement, a participant may request a lump-sum distribution equal to the value of his or her vested account balance. A terminated participant whose vested account balance does not exceed \$1,000 will receive a lump-sum distribution of the vested account balance immediately following termination. Account balances for terminated participants between \$1,000 and \$7,000 will be automatically rolled over into an individual retirement account outside of the Plan assets. Participants who are still employed by the Sponsor may request an in-service distribution of their contributions and earnings due to financial hardship, disability, or attainment of age 59.5.

Forfeitures

Forfeitures of non-vested account balances may be used to reduce future Sponsor contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,368 and \$1,291, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the agent. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in investments includes realized and unrealized gains and losses on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. While delinquent notes receivable from participants may be treated as a deemed distribution for purposes of participants' taxes, for financial statement purposes, such notes receivable are reclassified as distributions based upon the terms of the Plan document. Accordingly, this may result in a reconciling item between the financial statements and the Form 5500.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative costs associated with certain participant-initiated transactions are charged to the accounts of the participants who initiate the transactions while recordkeeping and investment advisory fees are first reduced by any administrative fee credits earned by the Plan and then charged to the accounts of the participants pro-rata based on the account balances of the participants.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds or money market funds managed by Vanguard Fiduciary Trust Company, the recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Sponsor directly pays any other fees related to the Plan's operations.

Fees paid by the Plan for administrative services and investment advisory services were \$80,817 during the year ended December 31, 2024. The Sponsor provides certain administrative services to the Plan at no cost.

Note 5. Fair Value Measurements

Fair value, as defined under U.S. GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Money market fund

The money market fund is a public investment vehicle valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Income Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the prototype plan agreement was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts and benefits will be distributed in accordance with provisions of the Plan.

Note 9. Subsequent Events

The Sponsor has evaluated subsequent events through June 30, 2025, the date the financial statements were available to be issued.
