### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Krause Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022 and the related statement of changes in net assets available for benefits for the years ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter**

As discussed in Note 11 to the financial statements, The Plan spun out \$5,252,285 of assets into a new plan, effective October 24, 2023. The Plan also merged the remaining assets of \$68,848,410 into the FJ Management Inc. 401(k) plan effective December 29, 2023. All plan assets after the spin out were transferred to the control of FJ Management Inc. 401(k) on December 29, 2023. Our opinion has not been modified with respect to these matters.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of Krause Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan sponsored by Kum & Go, L.C. and affiliates, including Solar Transport, L.C., FC Des Moines, L.C. and Teamwork Ranch, LLC. (collectively, the Companies). Employees of the Companies are eligible to make salary deferral contributions on the first day of the quarter after attaining the age of 21 years and completing one year of service in which 1,000 hours were worked. Employees are eligible to receive Companies' contributions following the completion of 1,000 hours and being employed on the last day of the Plan year. The Fiduciary Review Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (the Code) provisions. Effective October 1, 2022, the Plan was amended to allow participants to contribute to the Plan upon hire and become eligible for an employer match one year after their hire date.

**Contributions and investment options:** Each year, participants may contribute a stated percentage of pretax annual compensation that does not exceed the maximum contribution allowed by federal law. The Plan provides an automatic deferral election of 3% of compensation for all eligible employees. Employees may elect a different percentage or elect not to make any elective deferral contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of both their contributions and employer contributions into various investment options offered by the Plan. Participants may currently invest their contributions into a variety of mutual funds, pooled separate accounts, a bank common trust fund and a deferred income annuity option. Participants may change their investment options daily. The Companies contribute 50% of the first 8% of the participant's compensation that a participant contributes to the Plan. In addition, the Companies offer an additional loyalty match for participants employed 10 or more years whereby the Companies match an additional 1% of the participant's compensation for tenure from 10 years up to 15 years and an additional 2% of the participant's compensation for tenure greater than 15 years if the participant is contributing at least 8% of their compensation to the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Companies' matching contribution, loyalty matching contribution and allocations of: (a) discretionary contributions, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' matching and discretionary contributions plus earnings thereon is based on continuous years of service. A participant vests 20% for each year of service with at least 1,000 hours of service and is 100% vested after five years of credited service.

**Payment of benefits:** Upon termination of service, death, disability, retirement or reaching age 59½, participants may elect to receive a lump sum amount equal to the value of his or her account. Participants with an account balance less than \$5,000 may roll the amount into another qualified plan or receive a mandatory lump sum distribution upon termination of service. Employees, regardless of age, who have a financial hardship, may request a lump sum withdrawal from their 401(k) elective deferral account, subject to limitations as defined.

#### Note 1. Plan Description (Continued)

**Forfeited accounts:** Forfeited balances of terminated participants' nonvested accounts are used to reduce future Companies' contributions. At December 31, 2023 and 2022, forfeitures available to reduce future Companies' contributions totaled approximately \$0 and \$116,000, respectively. During the year ended December 31, 2023, forfeitures used to reduce employer contributions totaled approximately \$0. The employer contribution receivable on the statements of net assets available for benefits as of December 31, 2023, has been reduced by approximately \$0 of available forfeitures.

**Notes receivable from participants:** Participants may borrow from their fund accounts a maximum amount equal to the lesser of: (i) \$50,000 reduced by the highest outstanding note receivable balance during the one-year period ending on the day before the new note receivable is made, or (ii) the greater of 50% of their vested account balance reduced by any outstanding note receivable balance on the date the new note receivable is made or \$10,000. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participants fund. Terms range from one to five years; however, repayments of notes receivable for the purchase of a primary residence may exceed five years and are due within a reasonable time. The notes receivable are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. Notes receivable outstanding at December 31, 2023, had maturity dates ranging from 2023 to 2034 and bear interest between 5.25% and 10.50%. Notes receivable outstanding at December 31, 2022, bear interest between 5.25% and 9.50%.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Accounting estimates and assumptions:** The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fiduciary Review Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

**Payment of benefits:** Benefits are recorded when paid.

**Excess contributions payable:** Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through November 5, 2024, which is the date the financial statements were available to be issued.

#### Note 3. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Note 4. Information Certified and Provided by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Custodian

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and ERISA required supplemental schedules, obtained by management and agreed to or derived from information certified by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

#### Note 5. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 6. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Under the accounting guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### **Note 7. Related-Party Transactions**

Certain Plan investments are shares of pooled separate accounts and the common collective trust fund managed by Principal, the custodian as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the custodian totaled \$424,237 for the year ended December 31, 2023. The Companies also pay certain administrative expenses on behalf of the Plan.

#### **Note 8. Risk and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 9. Fair Value Measurements**

Fair Value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

**Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements. There have been no changes in valuation methodologies at December 31, 2023 compared to December 31, 2022.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

**Deferred income annuity:** The deferred income annuity cannot be sold to a third-party; thus, the only option to exit the deferred income annuity is to withdraw or transfer the funds. The fair value for each deferred income annuity surrendered within 90 days from the date of the purchase is the purchase amount of the surrendered portion. The fair value for each deferred income annuity surrendered more than 90 days after the date of the purchase is the lesser of the guaranteed income balance or the commuted value associated with the surrendered portion of the deferred income annuity. The fair value will never be greater than and may be less than the guaranteed income balance associated with the surrendered portion of the deferred income annuity. The fair value of the deferred income annuity is reflected in Level 3.

**Pooled separate accounts:** The net asset value is used as a practical expedient to determine fair value for all pooled separate accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Each pooled separate account provides for redemptions by the Plan at the net asset value per share, with little to no advance notice requirement.

**Common collective trust funds:** Common collective trust funds are composed of investment contracts that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transaction (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required.

Participants are not allowed to transfer back into this category until the 30-day period has expired. New contributions are allowed during this time period.

#### **Note 11. Plan Merger**

In October of 2023, \$5,252,285 of assets related to certain Plan participants were spun out into a new plan. The remaining assets of the Plan were merged into the FJ Management Inc. 401(k) plan effective December 29, 2023, which was the liquidation date of certain investments, which are presented as "due from broker" on the statement of net assets available for benefits. Included in the total Plan assets transferred into the FJ Management Inc. 401(k) were \$1,160,470 of investments that were transferred in kind due to early withdrawal penalties. Additionally, as of December 31, 2023, there were \$1,290,548 of notes receivable from participants and \$4,012,109 of employee and employer receivables that were transferred and will be collected by the FJ Management Inc. 401(k) plan subsequent to year-end.

#### **Note 12. Prohibited Transactions**

During the year ended December 31, 2023, the Plan Sponsor inadvertently failed to deposit approximately \$405,600 of participant contributions within the required time frame by the DOL regulations. In addition, the Plan Sponsor has late deposits totaling approximately \$19,100 from prior years they are working on correcting. The Plan Sponsor intends to file Form 5330 and intends to pay applicable excise tax to the IRS. The Plan Sponsor deposited lost earnings in 2023 to correct approximately \$1,400 of late deposits related to the current year and \$379,300 of late deposits related to prior years. The Plan Sponsor filed Form 5330 and paid applicable excise tax to the IRS. The corrections will be made from the Plan Sponsor's assets and not assets from the Plan.
