We are the Accountants for the Chapter 7 Bankruptcy Trustee of Hope Dental Clinic (“HDC” or the “Debtor”), the Sponsor of the Hope Dental Clinic 401(k) Plan. HDC filed for protection under Chapter 7 of the United States Bankruptcy Code on February 25, 2025, at which time Patti J. Sullivan was appointed as the Chapter 7 Trustee (“Trustee”). The Debtor ceased all operations and payroll as of the Chapter 7 filing.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. § 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of the Hope Dental Clinic 401(k) Plan (“the Plan”).

The 2024 annual informational return (“Form 5500”) was prepared by Human Interest, the Plan Asset Custodian, Third-Party Administrator, and 3(16) Advisor, from the best information available; that is, data provided by the Debtor’s former personnel. Due to the cessation of business, the filing of bankruptcy, and lack of cooperation from the Debtor’s former personnel, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable. In addition, the Debtor’s former personnel provided limited assistance to the Trustee in contacting Human Interest to determine the status of the Plan, so there were extenuating circumstances surrounding the bankruptcy. Human Interest has remained in place as the Plan’s 3(16) Advisor, and as such it is continuing to administer the Plan until all assets have been distributed, and it is currently in the process of contacting participants and collecting and processing their distribution requests.

The period on this return pre-dates the appointment of the Trustee and her professionals. Neither the Trustee nor the Trustee’s Accountants have any direct knowledge of the transactions recorded by the Debtor and Human Interest as reported on this Form 5500 return. In addition, the Trustee and her professionals have no knowledge of the processes used or policies put in place by the Debtor or Human Interest.

The Trustee has relied on Human Interest’s expertise in preparing the return from the available records, which were limited due to the entity's cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
