### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Delta Electrical 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103() (3)(C) audit). **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Delta Electrical 401(k) and Profit Sharing Plan is provided only general information. Participants should refer to the plan agreement for more complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan covering employees of Delta Electrical, Inc., Townsend Systems, LLC, and Coltek Services, LLC (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees, excluding union employees, nonresident aliens, and employees of Townsend Door and Hardware, LLC, are eligible to participate in the Plan after attaining 18 years of age and one year of service. Entry into the plan after eligibility is on the first day of March and September.

**B. Contributions**

Each year, participants may contribute any amount, up to the legal limit, of their pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company will make an employer 3 percent non-elective safe harbor contribution for all eligible participants. Participants do not have to be participating in the plan to receive the safe harbor contribution. The Company may also make a non-elective discretionary contribution (profit-sharing contribution) to the Plan. Participants must have attained age 18 and performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for the profit-sharing contribution. Participants direct the investments of the contributions to their account to various investment plans offered by the Plan. The Plan also allows for Roth contributions. For the year ended December 31, 2024 and 2023 the employer made a non-elective discretionary contribution of \$175,000 and \$325,497, respectively. Contributions are subject to certain IRS limitations.

**C. Participants' Accounts**

Each participant's account is credited with the participant's contribution and an allocation of the Sponsor's contribution, plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

**D. Vesting**

Participants are vested immediately in their contributions plus actual earnings on them. Vesting in the Company contribution portion of their accounts plus earnings is based on years of continuous service. For employer nonelective contributions, a participant is 100 percent vested after five years of credited service.

**E. Payments of Benefits**

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age at 65, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$5,000 or less. For terminated participants with vested balances greater than \$5,000, participant

consent is required. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

**F. Forfeited accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,348 and \$11,989, respectively. These accounts will be used to reduce Employer contributions. The amount of forfeitures used during the year ended December 31, 2024 and 2023 were \$1 and \$251, respectively.

**NOTE 2 - SUMMARY ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are stated at fair value (except for the fully benefit responsive investment contract, which is reported at contract value- See Note 8 for the discussion on contract value consideration). Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan's Insurance & Retirement Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and insurance company. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**D. Contributions**

Participant contributions and any related employer contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective safe harbor/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

**E. Payment of Benefits**

Benefits are recorded when paid.

**F. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Participant accounts are directly charged for distributions and are included in the administrative expenses in the statements of changes in the net assets available for benefits. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

**G. Subsequent Events**

The Plan has evaluated subsequent events through July 9, 2025, the date the financial statements were available to be issued.

**H. Reclassification**

**NOTE 3 – CERTIFIED INVESTMENT INFORMATION**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ameritas life Insurance, Corp, a qualified institution.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled Separate Accounts (PSAs):* Pooled separate accounts are valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by Empower, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is not a publicly quoted price in an active market.

**NOTE 5 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are pooled separate accounts and a guaranteed insurance contract managed by Ameritas Life Insurance Corp (custodian and recordkeeper) for the Plan, and therefore, those transactions qualify as party in interest transactions.

Administrative services to the plan provided by Ameritas Life Insurance Corp (custodian and recordkeeper) included in the statements of changes of net assets are \$700 and \$1,625. Also included are Mesirow Financial Investment MGMT (investment advisor) with fees of \$737 and \$754 for the years ended December 31, 2024 and 2023, respectively.

Participant distribution processing fees are paid to Ameritas by participants.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 – TAX STATUS**

The Employer adopted the Ameritas Life Insurance Corporation Non-Standardized Pre-Approved Profit Sharing 401(K) Plan. That Plan received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document as then designed satisfies the applicable provisions of IRC.

Although the Plan has been amended since receiving this opinion letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Ameritas where they maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The weighted average interest crediting rate, as of December 31, 2024, is 3.11%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The following represents the contract value for the investment contract held by the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by National, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to, the following:

- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Premature termination of the contract.
- Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan).
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may vary depending on the contract. Examples of such events include, but are not limited to, the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreement without the consent of the issuer.
