Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of David H. Martin Excavating, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Opinion (Continued)

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (Continued)

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The supplemental Schedule H, Item 4i - Schedule of Assets Held for Investment Purposes as of December 31, 2024, is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO THE FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of David H. Martin Excavating, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) plan adopted by David H. Martin Excavating, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is intended to comply with Section 401(a) of the Internal Revenue Code of 1986. The Plan was most recently amended and restated effective January 1, 2022.

The Plan is administered by a committee comprised of officers of David H. Martin Excavating, Inc. (Administrator). The Plan Administrator has appointed the officers of the Company as individual Trustees of the Plan.

The Trustees have contracted with Voya Retirement Insurance and Annuity Company (VRIAC) to provide for the funding of and payment of benefits under the Plan. The Plan's assets are managed by VRIAC under the terms of the Plan Services Agreement. Plan assets are held in pooled separate accounts and a fixed account, which offer participants various investment options to self-direct their individual accounts.

Eligibility: Beginning January 1, 2019, Company employees are eligible to participate in the Plan upon the sooner of completion of six months of consecutive service or 1 year of service (defined as 1,000 hours) and the attainment of age 18. Plan entry dates are the first day of every quarter (January 1st, April 1st, July 1st, October 1st).

Contributions: Each year, participants in the Plan may contribute a percentage of their compensation into a regular 401(k) account and/or into a Roth 401(k) account, as defined in the Plan. However, the total of all such participant contributions is subject to annual limits set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make additional ("catch-up") contributions up to a prescribed annual limitation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Beginning on January 1, 2019, the Plan provides for an enhanced employer safe harbor matching contribution of 100% of a participant's elective deferrals that do not exceed 4% of compensation. In addition, the Company may make discretionary profit-sharing contributions at an amount determined annually by the Company's Board of Directors.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions, an allocation of the Company's discretionary profit-sharing contribution and an allocation of plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change the allocation of their contributions among investment options at any time. Market valuations of the Plan's assets are generally made daily.

Note 1. Description of the Plan (Continued)

Vesting: Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portions of their accounts, plus earnings thereon, is gradual based on years of credited service and starts at the rate of 20% per year, commencing after two years of service until fully vested after six years of credited service. A participant is fully vested in the event of death, disability, normal retirement at the later of age 65 or the fifth anniversary of Plan participation.

Payment of Benefits: Upon termination of service, death, disability or retirement, a participant is eligible to receive a distribution of their vested account balance. Benefit payments are distributed as a lump-sum or in partial withdrawals.

Forfeited Accounts: When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures are accumulated in a separate account and may be utilized for payment of administrative expenses and then to reduce the Company's matching and non-elective contributions. There were unused forfeitures remaining of \$0 and \$111, respectively, at December 31, 2024 and 2023. Forfeitures of \$116 were used to pay plan expenses during the year ended December 31, 2024.

Administrative Expenses: Administrative expenses may be paid by the Plan if not paid by the Company.

Note 2. Summary of Significant Accounting Policies

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of the investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through July 7, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and investment interest for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the Custodian of the Plan).

Note 4. Investments and Fair Value Measurements

All investments are participant-directed. The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

Note 4. Investments and Fair Value Measurements (Continued)

The Plan's investments are held by Voya Retirement Insurance and Annuity Company in pooled separate accounts and in a fixed account. The following is a description of valuation methodologies used for Plan assets. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts, at fair value: Units of participation in pooled separate accounts are reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by VRIAC. The accumulated unit value is determined daily by VRIAC and is based on the net asset value of shares in the underlying fund, the fund's dividends and the contract's separate account charges. The fair value of the underlying fund shares are generally based on level 1 input. Since the fair value hierarchy level to be used is to be the lowest level that would be significant to the measurement in its entirety, inputs used to determine the fair value of pooled separate accounts include other observable inputs that are considered to be Level 2.

Fixed account, at contract value: The fixed account consists of a fully benefit-responsive fixed income investment contract option which guarantees a minimum rate of interest. All assets are invested in the insurance company's general account. The fixed account is stated at contract value, as reported to the Plan by VRIAC.

The preceding methods may produce a fair value or contract value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan has invested in a group contract with VRIAC within which participants may direct their contributions into either pooled separate accounts or a fixed account (guaranteed interest) investment option. The pooled separate accounts consist of variable fund investment options, both institutional and retail, covering multiple assets classes. The fixed account provides a guaranteed rate of return that obliges VRIAC to repay the principal and a specified interest rate to the Plan.

The fixed account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The crediting interest rate is based on a formula agreed upon by the issuer, but it may not be less than a minimum guaranteed interest rate that is declared annually in advance by VRIAC. There is no specified maturity date of the contract, and the contract can be terminated at any time.

The Plan has elected the equity wash option provided for transfers from the fixed account to other investment options. This option generally only restricts transfers of funds from the fixed account to a competing investment option.

The Plan's ability to receive amounts due in accordance with its fully benefit responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer, such as partial or complete termination of the contract, plan termination or merger, changes to the Plan's prohibition on competing investment options, bankruptcy of the Plan Sponsor or other plan sponsor events. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6. Related Party Transactions

Plan investments include shares of pooled separate accounts and a fixed account managed by Voya Retirement Insurance and Annuity Company or its affiliates. VRIAC has contracted with the Plan to provide certain investment and administrative services and, therefore, these transactions qualify as party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

Note 8. Tax Status

The Plan has adopted a pre-approved profit-sharing plan with CODA sponsored by Smith Elliott Kearns & Company, LLC. The Plan Sponsor received an opinion letter from the Internal Revenue Service, dated June 30, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended subsequently, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
