Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cedar Holdings Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of Plan

Overview:

The Cedar Holdings Inc. 401(k) Plan (the "Plan") is a defined contribution plan, covering the employees of Cedar Holdings, Inc., Silveus Southeast, LLC, Silveus Insurance Group, Inc., Stark Ventures, LLP, Winona IT, LLC, Winona Heritage Room LLC, and S. Silveus Services, LLC (referred to collectively as the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Effective May 1, 2024, Silveus Southeast, LLC and Silveus Insurance Group, Inc. were no longer participating employers in the Plan as a result of a company divestiture. Effective March 31, 2024, Winona Heritage Room LLC was dissolved.

Eligibility:

All employees are eligible to participate in the Plan after they have completed three months of service and are at least 18 years of age. Participation in the Plan is voluntary. Participants may enter the Plan on the first day of the month immediately following completion of these requirements.

Participant Contributions:

Participants may make voluntary pre-tax contributions or after-tax ROTH contributions to their individual accounts each Plan year up to 100% of their compensation not to exceed the maximum permitted under the Internal Revenue Code. The Plan also allows catch-up elective deferral contributions under Code Section 414(v) for those participants who have attained age 50 by the close of the Plan year. The amount of the participant's contribution to the Plan can be changed at any time.

Company Contributions:

The Company makes a safe harbor matching contribution of 100% of the participant's elective deferral up to 6% of eligible wages. In addition, the Company may, at its discretion, make profit sharing contributions to the Plan in an amount determined by the Company's management. No discretionary contribution was made for the year ended December 31, 2024.

Participants' Accounts:

Each participant's account is credited with participant contributions, Company contributions, and Plan earnings, and charged with administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options:

Participants have the option of investing in a variety of investment options offered through John Hancock Life Insurance Company, the recordkeeper of the Plan. All amounts in participant accounts are participant-directed.

Note 1. Description of Plan (Continued)

Vesting:

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Company matching and profit sharing contributions is based on years of continuous service. A participant becomes 25% vested after two years of credited service. Vesting percentages increase 25% each year thereafter with 100% vesting after five years of credited service.

Forfeitures:

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their share of the Company's contributions. These forfeitures are used to pay Plan expenses or to reduce future Company contributions. At December 31, 2024 and 2023, there were \$1,094 of forfeitures available to reduce future Company contributions or Plan expenses, respectively. There were no forfeitures used to reduce Company contributions or Plan expenses for the year ended December 31, 2024.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are to be repaid in five years or less unless the note is for the purchase of a principal residence, in which case the term may be longer. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with current prevailing rates (determined at origination). The loan plus interest must be repaid to the participant's account based upon terms of the loan agreement. Principal and interest is paid ratably through regular payroll deductions. The Plan limits participants to two outstanding notes. Loans outstanding at December 31, 2024, mature through October 2028 and bear interest at rates ranging from 7.25% through 9.50%.

Benefit Payments:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount, rollover into another qualified plan or remain in the Plan as an inactive participant. However, if a terminated participant's vested account balance is \$5,000 or less, the balance will automatically be distributed to the participant in accordance with the Plan document. Hardship withdrawals are allowed from the fully vested portion of a participant's account balance. In-service distributions may be made from the fully vested portion of a participant's account balance provided the participant has attained the age of 59 1/2.

Termination of the Plan:

Although the Company has not expressed any intent to terminate the Plan, it has the right to do so at any time, subject to the provision set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Collective investment trusts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive stable value funds because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan will be deemed distributed and the loan balance will become taxable to the participant.

Payment of Benefits:

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through June 26, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Recordkeeper

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the recordkeeper, John Hancock Life Insurance Company, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net realized and unrealized appreciation in fair value of investments, as shown in the accompanying statement of changes in net assets available for benefits.
- c. Schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

Note 4. Fair Value Measurements (Continued)

Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA"): Valued at net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2024 and 2023, respectively.

Collective investment trust: Composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Transactions With Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Plan investments at December 31, 2024 and 2023, include pooled separate accounts and shares of a collective investment trust managed by the recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

Note 6. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code (IRC) and therefore, not subject to tax. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.


