Opinion

We have audited the financial statements of The Graham Company Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets in liquidation available for benefits as December 31, 2024 and 2023, and the related statements of changes in net assets in liquidation available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets in liquidation available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets in liquidation available for benefits for the years ended December 31, 2024 and 2023 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 5 to the financial statements, William A. Graham Company, the Plan's sponsor, entered into a share purchase agreement with Marsh McLennan Agency and consequently, the Company's Board of Directors and the ESOP Trustee voted to terminate the Plan effective July 31, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. (1) Description of Plan

The following description of The Graham Company Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

William A. Graham Company (the Company) established the Plan effective January 1, 2017. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975 (e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective August 20, 2019. Employees are eligible to participate in the Plan retroactively to the first day of the Plan year in which the employee first completes 1,000 hours of service, measured from the employee's date of hire. Employees covered under a collective bargaining agreement, leased employees and nonresidential aliens are not eligible for the Plan. The Plan is designed to invest primarily in securities issued by the Company and is authorized to borrow money for such investments. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan purchased Company common stock using the proceeds of a note payable to the Company and holds the stock in a trust established under the Plan. As the Plan made debt payments, an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing was collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender had no rights against shares of common stock once they were allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan for the year ended December 31, 2023 presents separately the changes in net assets therein pertaining to:

- a) The accounts of employees with vested rights in allocated common stock (allocated) and
- b) Common stock not yet allocated to employees (unallocated).

On July 31, 2023, all of the outstanding shares of the Company were acquired from the ESOP Trust by Marsh McLennan Agency, in exchange for consideration. Contemporaneous with the sale of the Company stock, the Board of Directors of the Company and the Trustee of the ESOP voted to terminate the Plan (see Note 5). Effective July 31, 2023, the Plan was terminated.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account, forfeitures, terminated participants' nonvested accounts, Company discretionary contributions, and dividends paid on Company stock. Only those participants who have completed 1,000 or more hours during the Plan year and employed on the last day of the Plan year will receive an allocation, except in the case of death, disability, or retirement. Allocations are based on a participant's eligible compensation, relative to total eligible compensation, as defined. Plan earnings or losses are allocated based on each participant's share of the investment at the beginning of the year, less distributions and withdrawals during the year. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Vesting of participant's accounts is based on years of credited service with the Company. A participant's Company discretionary contribution account becomes fully vested after six years of service with the Company. A participant is fully vested in their Company contribution account upon reaching normal retirement age, death, or disability. As of July 31, 2023, the Plan was terminated (see Note 5). As of the termination date of the Plan all participants became fully vested.

Payment of Benefits

Upon termination of service, a participant will receive a lump sum distribution of their account balance without the participant's consent if their balance does not exceed \$5,000. Participant accounts in excess of \$5,000 will be paid in substantially equal annual installments over a period of five years. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are made in cash.

As of July 31, 2023, the Plan was terminated. All participant balances are expected to be distributed during 2026.

(2) Summary of Significant Accounting Policies

Basis of Accounting

As a result of the Plan termination, the Plan has utilized the liquidation basis of accounting when presenting the financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid directly by the Company.

Subsequent Events

The Plan has evaluated subsequent events through July 17, 2025, the date the financial statements were available to be issued.

(3) Investment in Sponsor Company Common Stock

On February 28, 2017, the Plan purchased 24,116 shares of the Company's common stock for \$6,000,000.

Due to the Plan's termination on July 31, 2023, all Company stock was released, transferred to cash, and allocated to the participants.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. The money market and mutual funds held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

US. government securities and corporate and municipal bonds: Valued using pricing models maximizing the use of observable inputs or similar securities. This includes basing values on yields currently available on comparable securities of issuers with similar credit ratings.

There were no significant transfers among investment levels during the years ended December 31, 2024 and 2023.

Change in Fair Value of Level 3 Investments

During 2023, the ESOP received \$142,502,289 in exchange for the common stock held by the Plan. During 2023, there were no transfers into or out of the investment and no purchases of the investment included in level 3 of the fair value hierarchy. See Note 1 for an explanation on the exchange of William A. Graham Company common stock during 2023.

(5) Plan Termination

Effective July 31, 2023, in conjunction with the sale of the Company stock, the Board of Directors of the Company and the Trustee of the ESOP voted to terminate the Plan. Upon such termination of the Plan, the interest of each participant in the trust fund became fully vested and will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Board of Directors shall direct the Trustee to pay all liabilities and expenses of the plan. Approximately 80% of Plan assets were distributed to participants during 2023, and the remaining balance of participant accounts will be distributed in 2026.

(6) Plan Tax Status

The IRS has determined and informed the Company, by a letter dated January 14, 2025, that the Plan and related trust are designed in accordance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(8) Related Party and Party-in-Interest Transactions

The Plan is administered by William A. Graham Company. Certain officers of the Company are the Plan trustees. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan engages in investment transactions involving the disposition of Company common stock. William A. Graham Company is considered a party-in-interest.

Company contributions are held and managed by the trustee, which invests interest and dividend income and makes distributions to participants.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
