Opinion

Notes to the Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Red Dot Corporation Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

General

Red Dot Corporation (the "Company") established the Plan effective as of January 1, 1988. The Plan may operate as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by an Administrative Committee composed of one or more persons appointed by the Board of Directors of the Company. The Plan agreement should be referred to for specific information regarding benefits and other Plan matters. The Trustee holds the investments of the Plan and executes investment transactions.

Eligibility

Employees of the Company who are not covered under collective bargaining agreements and who work 1,000 or more hours annually are eligible to participate in the Plan following the completion of one year of service and the attainment of age 18 on the next plan entry date. The plan entry dates are the first day of the Plan year and the first day of the seventh month of the Plan year. Participants who do not have at least 1,000 hours of service or who are not employed on the allocation date are not eligible, with the exception of employees entering retirement in the current plan year, to receive Company contributions for that year.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to cover principal and interest on any associated loan to the Plan. At December 31, 2024 and 2023, there is no loan outstanding. The Company may also make discretionary contributions in cash to the Plan at the election of the Administrative Committee. During the year ended December 31, 2024, the Company approved a total discretionary cash contribution of approximately \$3,099,000.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. In years during which there are outstanding borrowings for the purchase of Company stock, each participant's account is credited as of the last day of the Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account. Otherwise, each participant's account is credited with an allocation of Company contributions, earnings, and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation of the Company's contribution and forfeitures. Allocations are based on participant's eligible compensation, relative to total eligible compensation or account balances, as defined by the Plan.

Vesting

Employees earning hours on or after January 1, 2017, begin to vest at 20% after one year of service, and vest an additional 20% each year thereafter. All accounts become 100% vested after completion of five years of service. Employees earning hours prior to January 1, 2017, begin to vest 30% after two years of service, 40% after three years of service, and an additional 20% each year thereafter. All accounts become 100% vested after completion of six years of service. A participant's account shall fully vest upon retirement, death, or disability.

1. Description of Plan (Continued)

Distributions

Distributions shall be made when a participant retires, becomes disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. A participant's account shall be distributed in cash or in shares at a price representative of the fair market value of the stock based on the most recent available valuation. If the account balance is \$5,000 or less, the distribution will be paid in a single lump sum. If the account balance is in excess of \$5,000, the Administrative Committee may select among the options to distribute the account as a single lump sum, in substantially equal annual installments over a period not exceeding five years (unless the account balance is above certain thresholds as defined in the Plan document), or any combination of the foregoing.

Diversification

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in the Company stock into investments that are more diversified. Participants who have completed at least 10 years of participation in the Plan and have reached age 55 may elect to take a distribution in order to diversify their retirement assets. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the balance in their account less all amounts previously diversified. In the sixth year, the percentage increases to 50%. Participants who elect to diversify receive a cash distribution, which they can rollover to another qualified retirement plan.

Forfeited Accounts

At December 31, 2024 and 2023, there were no unallocated forfeitures. For the year ended December 31, 2024, forfeitures allocated to remaining participant's accounts totaled approximately \$133,000.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any share for which instructions have not been given by a participant.

Put Option

Under federal income tax regulations, the Company's stock that is held by the Plan and its participants is not readily tradable on an established market, or subject to trading limitations, and includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can fund the repurchase with interest over a period of four years. The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under GAAP.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Significant estimates include the valuation of the Company's common stock. Accordingly, actual results may differ from those estimates.

Risk and Uncertainties

The Plan's investments consist of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits.

Investment Valuation

Investments are reported at fair value as described in Note 3. There has been no change to the methodology used at December 31, 2024 and 2023.

Income Recognition

The net appreciation or depreciation in fair value of investments consists of both the realized gains or losses, and unrealized appreciation and depreciation of those investments.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board ("FASB") fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value of Financial Instruments (Continued)

The following is a description of the valuation methodology used for the assets measured at fair value at December 31, 2024 and 2023:

- The fair value of the Red Dot Corporation, Inc. is a level 3 fair value measurement and was determined by an independent third-party appraisal. Methods for the valuation included discounted cash-flow, guideline public company, and merger and acquisition methods.

The methods described above include significant estimates and may produce a fair value calculation which may change in the near term and which may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Recently Adopted Regulations

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reform that began with the 2020 CARES act. Most of the provisions of SECURE 2.0 became effective in 2024. The Plan Administrator has determined which provisions of SECURE 2.0 applied to the Plan.

Subsequent Events

The Plan has evaluated subsequent events through July 17, 2025, the date which the financial statements were available to be issued.

At December 31, 2024 and 2023, the Plan owned 472,734 shares of Company common stock.

4. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated September 19, 2017, that the Plan is qualified and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan and trust are operating in a manner that did not jeopardize this tax status.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Administration of Plan Assets

The Plan assets, which consist principally of Company common stock, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest and dividend income, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensations from the Plan. Administrative expenses of the Plan are paid by the Company.

6. Related Party Transactions

The Plan invests in Company common stock. These are related party and exempt party-in-interest transactions. The Plan also has a number of service providers. Such providers are parties-in-interest under ERISA.

7. Termination of Plan

Although the Company has expressed no intent to do so, it reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon complete or partial termination of the Plan, the entire interest of each of the affected participants shall become 100% vested. The trustee shall distribute the interest of each participant in the trust fund to such participant, or his or her beneficiary at the time, prescribed by the Plan terms and the IRC.
