Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 80/20, LLC Retirement Readiness 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).



Note 1. Description of Plan

Overview:

The 80/20, LLC Retirement Readiness 401(k) Plan (the "Plan") is a defined contribution plan. The Plan covers all eligible employees of 80/20, LLC (the "Company" or "Employer"). All employees are eligible on the first of the month following their hire date, or any date thereafter, without a service or age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Contributions:

Participants may defer salary reductions of any percentage of their eligible compensation, not to exceed the maximum permitted under the Internal Revenue Code. Plan entry dates are the first day of each month. Roth deferral contributions are allowed.

The Company may provide a discretionary matching contribution based on each participant's elected compensation deferral. For the year ended December 31, 2024, a discretionary matching contribution of 50% of elective deferrals was made for each participant. The Company may also provide a discretionary nonelective contribution to be allocated to all participants who were employed on the last day of the Plan year. For the year ended December 31, 2024, no discretionary nonelective contribution was made.

Participants' Accounts:

Each participant's account is credited with participant contributions, employer contributions, plus an allocation of Plan earnings less administrative expenses. Plan earnings are allocated to participants' accounts on a pro rata basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

Investment Options:

Participants have the option of investing in a variety of investment funds offered through Voya Retirement Insurance and Annuity Company. A participant can change their investment options on a daily basis.

Notes to Financial Statements (Continued)

Note 1. Description of Plan (Continued)

Notes Receivable From Participants:

Participants may borrow up to the lesser of one-half of the participant's vested account balance or \$50,000, but not less than \$1,000. Participants must show financial hardship or evidence that the note receivable is for the purchase of a principal residence. The notes bear a reasonable rate of interest as determined by the Plan Administrator at the time the loan is granted. A participant may have only one outstanding loan at any given time. The interest rates on loans outstanding at December 31, 2024, range from 5.25% to 10.50%. Loans must be repaid within five years, or longer if the loan is for a principal residence. Loans outstanding at December 31, 2024, mature through October 2029. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through weekly payroll deductions.

Starting January 1, 2024, the plan no longer requires that loans be taken exclusively for hardship purposes, and the interest rate charged on loans was set to prime +2%.

Payment of Benefits:

Benefit payments are payable as a lump-sum payment or equal installments at normal retirement age, termination of employment, in-service distribution after age 59 1/2, or as a hardship withdrawal with certain restrictions, as defined by the Plan.

Vesting:

Participants are immediately vested in their voluntary contributions. Participants begin vesting in employer contributions after one year of service at 20% and increase 20% each year until fully vested after five years of service.

Forfeitures:

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Forfeitures can be used to pay Plan expenses or reduce future Employer contributions. During 2024, approximately \$25,700 was used to reduce Employer contributions and pay Plan expenses. At December 31, 2024 and 2023, approximately \$600 and \$4,500, respectively, of forfeitures were available to pay Plan expenses or reduce Employer contributions.

Termination of the Plan:

Although the Employer has not expressed any intent to terminate the Plan, it has the right to do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits:

Benefit payments to participants are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through July 14, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Insurance Company

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Voya Retirement Insurance and Annuity Company, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest income from the guaranteed investment contract and net realized and unrealized appreciation in fair value of pooled separate accounts.
- c. Schedule of assets (held at end of plan year), except for notes receivable from participants.

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA"s): Valued at net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2024 and 2023, respectively.

Guaranteed investment contract: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan holds a traditional investment contract with Voya Retirement Insurance and Annuity Company (the "Insurance Company"). The contract does not meet the fully benefit-responsive investment contract criteria and is therefore reported at fair value with an adjustment to contract value. Contract value is the relevant measure because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

Discontinuance of the contract would result in certain surrender charges as defined by the contract. Guaranteed crediting rates are based on a formula agreed upon with the insurance company. Such interest rates are reviewed quarterly for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Principal and interest are guaranteed; however, there is no stated maturity date.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Note 6. Party-in-Interest Transactions (Continued)

Certain Plan investments at December 31, 2024 and 2023, are shares of an investment contract managed by the Insurance Company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also invests in pooled separate accounts affiliated with the Insurance Company. Notes receivable from participant transactions are also party-in-interest transactions. Certain administration expenses are paid by the Employer on behalf of the Plan. The Employer also provides certain administrative services at no cost to the Plan.

Note 7. Income Tax Status

The Plan obtained its latest determination letter on November 30, 2020, from the Internal Revenue Service, stating the Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has since been amended. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

In March 2025, the Plan changed Custodians from Voya Retirement Insurance and Annuity Company to Empower Finance Services Company. Certification letters will be provided by both companies for the 2025 audit.
