### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Preparis, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (going concern), the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter—Plan Termination and Liquidation Basis**

As discussed in Note 1 and 2 to the financial statements, the Board of Directors of Preparis, Inc, the Plan's sponsor, voted on August 13, 2024 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

#### Note 1. Plan Description

The following description of the Preparis, Inc. 401(k) Plan (the Plan) (f/k/a Agility Recovery Solutions, Inc. 401(k) Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan, established on January 1, 2003. The Plan is available to all employees of Preparis, Inc. (the Company or Plan Sponsor), excluding employees covered by a collective bargaining agreement, leased employees and nonresident aliens. Prior to Plan termination, the Plan covered any employee who attained the age of 18 or older. Employees were able to enter the Plan on the first day of each quarter coinciding with or following the employee meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Prior to November 20, 2023, the Plan was also available to employees of Agility Recovery Solutions, Inc.

**Plan Termination:** On August 13, 2024, the Board of Directors of the Plan Sponsor passed a resolution to terminate the Plan effective September 16, 2024. As a result, management determined liquidation was imminent as of September 16, 2024. All participants became fully vested in their accumulated benefits as of September 16, 2024. During 2024, Plan assets were distributed, as elected by each participant or as directed by the Plan Sponsor if no election was made by November 15, 2024. All Plan assets were distributed as of December 31, 2024, except for outstanding checks in the amount of \$195,714. The Plan paid all administrative expenses related to the termination by December 31, 2024, and any remaining expenses were paid by the Company.

**Contributions:** There were no contributions made to the plan after September 12, 2024. Prior to that, participants could contribute up to 100% of their pretax annual compensation, as defined in the Plan, not to exceed certain limitations established by the Internal Revenue Service (IRS). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions in the amount of \$7,500. The Plan allowed participants to designate contributions as Roth 401(k) contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allowed for employer safe harbor matching contributions of 100% of the first 3% of participant contributions and 50% of the next 3% of participant contributions. The Plan also allowed for discretionary company matching contributions. There were no discretionary company matching contributions during the year ended December 31, 2024.

**Participant accounts and investment options:** Each participant's account was credited with the participant's contributions and allocations of (a) the employer safe harbor matching contributions; (b) the discretionary company matching contributions (if any); and (c) Plan earnings or losses and was charged with transaction fees for distributions and an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants directed their investment of both their contributions and the Company's contributions into various registered investment and common collective accounts offered by the Plan. Participants could change their elections daily.

**Vesting:** Participants were immediately 100% vested in their voluntary contributions and employer contributions, plus allocated earnings and losses thereon.

#### Note 1. Plan Description (Continued)

**Notes receivable from participants:** Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period was limited to five years, except for participant loans used for the purchase of a principal residence, which was limited to 10 years. Participants could have no more than one loan outstanding at any one time. The notes receivable were secured by the balance in the participant's account, and bear interest at rates which were commensurate with local prevailing rates at note origination, as determined by the Plan Administrator. Principal and interest were repaid ratably through payroll deductions. Notes receivables bore interest at rates ranging from 4.25% to 9.50% per annum. As a result of the Plan's termination, all unpaid loans were deemed distributed by the Plan Administrator and recorded as benefit payments in 2024.

**Payment of benefits:** As a result of the decision to terminate the Plan during 2024, distributions pursuant to the Plan termination were paid at the participants' election by (a) cash distribution of the present value of the participant's account, subject to mandatory income tax withholding; (b) rollover distribution to an eligible retirement plan; or (c) a combination of cash distribution and rollover distribution to an eligible retirement plan. If an election was not made by November 15, 2024, the participant's balance was rolled over to a qualified individual retirement account (IRA) sponsored by Inspira Financial Trust, LLC. Prior to the Plan termination, upon termination of service due to death, disability or retirement, a participant or designated beneficiary could elect to receive a lump sum distribution or installments equal to the value of the participant's vested interest in his or her account balance at the date of distribution. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or as a direct rollover to an individual retirement account or individual retirement annuity (IRA) or to another employer's tax qualified plan. Participants could also withdraw money from their account in the event of a financial hardship.

Participants with vested account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination. Participants with vested account balances less than \$5,000 but greater than or equal to \$1,000 would automatically have their vested account balances rolled into an individual retirement account unless they otherwise instructed the third-party administrator and took a lump-sum distribution as soon as practicable following termination.

**Administrative expenses:** Certain administrative functions were performed by employees of the Company. No such employee received compensation from the Plan. Administrative expenses of the Plan were charged against earnings, except to the extent expenses were paid by the Company.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** Due to the decision to terminate the Plan during the year ended December 31, 2024, management determined that liquidation of the Plan was imminent and unlikely to be blocked. As a result, the 2024 statements have been prepared using the liquidation basis of accounting, including the accrual of dividends, appreciation (depreciation) of investments and Plan expenses through December 31, 2024 recorded as of the date management determined liquidation was imminent (September 16, 2024). The 2023 financial statements are prepared as a going concern using the accrual basis of accounting.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer were recorded in the year in which the employee contributions were withheld from compensation.

#### Note 2. Significant Accounting Policies (Continued)

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan utilizes various registered investment companies and common collective trusts as investment instruments. Investment securities are exposed to various risks, such as interest rate and credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment valuation and income recognition:** There were no investments held by the plan as of December 31, 2024 due to the plan termination. All investments held on the December 31, 2023 statement of net assets available for benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the liquidation basis, including amounts expected to be earned through the final distribution of assets. Dividend income was recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Certain investment management fees and operating expenses were charged to the Plan for investments in registered investment companies and were deducted from income earned on a daily basis and reflected as a component of net appreciation in fair value of investments.

**Notes receivable from participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable were treated as distributions based upon the terms of the Plan Document.

**Payment of benefits:** Benefits payments to participants were recorded upon distribution.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued, and determined that there are no subsequent events that require disclosure.

#### **Note 4. Fair Value Measurements**

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are described below:

- Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.
- Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no investments held by the Plan as of December 31, 2024. The investments on the December 31, 2023 statement of net assets available for benefit are reported at fair value. The following is a description of the valuation methodologies used for assets measured at fair value.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

**Common collective trusts (CCT):** These investments are public investment vehicles using NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. There are no quoted prices available in active markets for identical instruments for the CCT. The fair value of the CCT is not classified within the fair value hierarchy pursuant to ASC 820-10. As published prices are not available for the CCT, the CCT is eligible to use NAV as a practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

#### Note 5. Tax Status

The Plan was a defined contribution preapproved plan sponsored by Fidelity Management & Research Co., an affiliate of the trustee. The preapproved plan had received an opinion letter from the IRS dated June 30, 2020, as to the preapproved plan's qualified status. The preapproved plan opinion letter had been relied upon by the Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan was designed and operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan followed the accounting guidance for uncertainty in income taxes. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements; therefore, no provision of liability for income taxes has been included in the financial statements.

#### Note 6. Prohibited Transactions

During the years ended December 31, 2024, 2023 and 2022, the Company failed to deposit participant contributions within the required timeframe estimated by their normal business practice totaling, excluding lost earnings, \$115,420, \$266,210 and \$72,345, respectively. The Company corrected the late deposits for the years ended December 31, 2023 and 2022, outside of VFCP during 2024, and compensated participants with lost earnings resulting from the late deposits from the Company's assets and not from assets of the Plan.

#### Note 7. Related-Party Transactions

The Plan paid direct compensation for record keeping service to Fidelity Investments Institutional, an affiliated company to the Plan trustee. These transactions qualify as exempt party-in-interest transactions. The fees paid during the year ended December 31, 2024, were \$17,544.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Preparis, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (going concern), the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter—Plan Termination and Liquidation Basis**

As discussed in Note 1 and 2 to the financial statements, the Board of Directors of Preparis, Inc, the Plan's sponsor, voted on August 13, 2024 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, line 4a—schedule of delinquent participant contributions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Plan Description

The following description of the Preparis, Inc. 401(k) Plan (the Plan) (f/k/a Agility Recovery Solutions, Inc. 401(k) Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan, established on January 1, 2003. The Plan is available to all employees of Preparis, Inc. (the Company or Plan Sponsor), excluding employees covered by a collective bargaining agreement, leased employees and nonresident aliens. Prior to Plan termination, the Plan covered any employee who attained the age of 18 or older. Employees were able to enter the Plan on the first day of each quarter coinciding with or following the employee meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Prior to November 20, 2023, the Plan was also available to employees of Agility Recovery Solutions, Inc.

**Plan Termination:** On August 13, 2024, the Board of Directors of the Plan Sponsor passed a resolution to terminate the Plan effective September 16, 2024. As a result, management determined liquidation was imminent as of September 16, 2024. All participants became fully vested in their accumulated benefits as of September 16, 2024. During 2024, Plan assets were distributed, as elected by each participant or as directed by the Plan Sponsor if no election was made by November 15, 2024. All Plan assets were distributed as of December 31, 2024, except for outstanding checks in the amount of \$195,714. The Plan paid all administrative expenses related to the termination by December 31, 2024, and any remaining expenses were paid by the Company.

**Contributions:** There were no contributions made to the plan after September 12, 2024. Prior to that, participants could contribute up to 100% of their pretax annual compensation, as defined in the Plan, not to exceed certain limitations established by the Internal Revenue Service (IRS). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions in the amount of \$7,500. The Plan allowed participants to designate contributions as Roth 401(k) contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allowed for employer safe harbor matching contributions of 100% of the first 3% of participant contributions and 50% of the next 3% of participant contributions. The Plan also allowed for discretionary company matching contributions. There were no discretionary company matching contributions during the year ended December 31, 2024.

**Participant accounts and investment options:** Each participant's account was credited with the participant's contributions and allocations of (a) the employer safe harbor matching contributions; (b) the discretionary company matching contributions (if any); and (c) Plan earnings or losses and was charged with transaction fees for distributions and an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants directed their investment of both their contributions and the Company's contributions into various registered investment and common collective accounts offered by the Plan. Participants could change their elections daily.

**Vesting:** Participants were immediately 100% vested in their voluntary contributions and employer contributions, plus allocated earnings and losses thereon.

**Notes receivable from participants:** Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period was limited to five years, except for participant loans used for the purchase of a principal residence, which was limited to 10 years. Participants could have no more than one loan outstanding at any one time. The notes receivable were secured by the balance in the participant's account, and bear interest at rates which were commensurate with local prevailing rates at note origination, as determined by the Plan Administrator. Principal and interest were repaid ratably through payroll deductions. Notes receivables bore interest at rates ranging from 4.25% to 9.50% per annum. As a result of the Plan's termination, all unpaid loans were deemed distributed by the Plan Administrator and recorded as benefit payments in 2024.

**Payment of benefits:** As a result of the decision to terminate the Plan during 2024, distributions pursuant to the Plan termination were paid at the participants' election by (a) cash distribution of the present value of the participant's account, subject to mandatory income tax withholding; (b) rollover distribution to an eligible retirement plan; or (c) a combination of cash distribution and rollover distribution to an eligible retirement plan. If an election was not made by November 15, 2024, the participant's balance was rolled over to a qualified individual retirement account (IRA) sponsored by Inspira Financial Trust, LLC. Prior to the Plan termination, upon termination of service due to death, disability or retirement, a participant or designated beneficiary could elect to receive a lump sum distribution or installments equal to the value of the participant's vested interest in his or her account balance at the date of distribution. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or as a direct rollover to an individual retirement account or individual retirement annuity (IRA) or to another employer's tax qualified plan. Participants could also withdraw money from their account in the event of a financial hardship.

Participants with vested account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination. Participants with vested account balances less than \$5,000 but greater than or equal to \$1,000 would automatically have their vested account balances rolled into an individual retirement account unless they otherwise instructed the third-party administrator and took a lump-sum distribution as soon as practicable following termination.

**Administrative expenses:** Certain administrative functions were performed by employees of the Company. No such employee received compensation from the Plan. Administrative expenses of the Plan were charged against earnings, except to the extent expenses were paid by the Company.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** Due to the decision to terminate the Plan during the year ended December 31, 2024, management determined that liquidation of the Plan was imminent and unlikely to be blocked. As a result, the 2024 statements have been prepared using the liquidation basis of accounting, including the accrual of dividends, appreciation (depreciation) of investments and Plan expenses through December 31, 2024 recorded as of the date management determined liquidation was imminent (September 16, 2024). The 2023 financial statements are prepared as a going concern using the accrual basis of accounting.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer were recorded in the year in which the employee contributions were withheld from compensation.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan utilizes various registered investment companies and common collective trusts as investment instruments. Investment securities are exposed to various risks, such as interest rate and credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment valuation and income recognition:** There were no investments held by the plan as of December 31, 2024 due to the plan termination. All investments held on the December 31, 2023 statement of net assets available for benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the liquidation basis, including amounts expected to be earned through the final distribution of assets. Dividend income was recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Certain investment management fees and operating expenses were charged to the Plan for investments in registered investment companies and were deducted from income earned on a daily basis and reflected as a component of net appreciation in fair value of investments.

**Notes receivable from participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable were treated as distributions based upon the terms of the Plan Document.

**Payment of benefits:** Benefits payments to participants were recorded upon distribution.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued, and determined that there are no subsequent events that require disclosure.

The trustee also certified to the completeness and accuracy of the investment income information (including investments bought, sold and held during the year) and interest income on notes receivable from participants for the year ended December 31, 2024, included on the statement of changes in net assets available for benefits.

#### Note 4. Fair Value Measurements

The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC), establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are described below:

- Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.
- Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Note 4. Fair Value Measurements (Continued)

There were no investments held by the Plan as of December 31, 2024. The investments on the December 31, 2023 statement of net assets available for benefit are reported at fair value. The following is a description of the valuation methodologies used for assets measured at fair value.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

**Common collective trusts (CCT):** These investments are public investment vehicles using NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. There are no quoted prices available in active markets for identical instruments for the CCT. The fair value of the CCT is not classified within the fair value hierarchy pursuant to ASC 820-10. As published prices are not available for the CCT, the CCT is eligible to use NAV as a practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

#### Note 5. Tax Status

The Plan was a defined contribution preapproved plan sponsored by Fidelity Management & Research Co., an affiliate of the trustee. The preapproved plan had received an opinion letter from the IRS dated June 30, 2020, as to the preapproved plan's qualified status. The preapproved plan opinion letter had been relied upon by the Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan was designed and operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan followed the accounting guidance for uncertainty in income taxes. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements; therefore, no provision of liability for income taxes has been included in the financial statements.

#### Note 6. Prohibited Transactions

During the years ended December 31, 2024, 2023 and 2022, the Company failed to deposit participant contributions within the required timeframe estimated by their normal business practice totaling, excluding lost earnings, \$115,420, \$266,210 and \$72,345, respectively. The Company corrected the late deposits for the years ended December 31, 2023 and 2022, outside of VFCP during 2024, and compensated participants with lost earnings resulting from the late deposits from the Company's assets and not from assets of the Plan.

#### Note 7. Related-Party Transactions

The Plan paid direct compensation for record keeping service to Fidelity Investments Institutional, an affiliated company to the Plan trustee. These transactions qualify as exempt party-in-interest transactions. The fees paid during the year ended December 31, 2024, were \$17,544.
