Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Marine Spill Response Corporation 401 (k) Profit Sharing Thrift Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained the certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report.

Basis for Opinion

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The Marine Spill Response Corporation 401(k) Profit Sharing Thrift Savings Plan (the Plan) is a defined contribution employee savings plan established by the Marine Spill Response Corporation (the employer or MSRC) to provide retirement benefits to eligible employees. The effective date of the Plan was December 1, 1990. The following represents a summary of the Plan. A full description can be found in the Plan Document.

General

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All employees of MSRC who work or are expected to work at least 20 hours per week, with the exception of leased employees, occasional employees (i.e., employees who are hired to supplement the regularly assigned workforce or crew and complete a specific task or project) and employees who are residents of Puerto Rico, are eligible to participate in the Plan. Eligible employees may enroll in the Plan immediately upon the commencement of employment.

Contributions

The Plan allows employees who participate in the Plan to contribute from 1% to 75% of their base salary. Contributions may be made: (a) on a pre-tax basis; (b) as a Roth deferral on an after-tax basis; or (c) using any combination of both approaches. The Plan also allows employees to contribute from 1% to 10% of their base salary on an after-tax basis. The Plan allows for catch-up contributions for participants age 50 or older as permitted by the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001. Eligible employees are auto-enrolled into the Plan at 4% of base salary unless electing to opt out of Plan participation or selecting their own deferral percentage. The Plan includes the option of an annual increase program where employee deferrals are increased by 1% annually until a deferral rate of 8% is reached.

MSRC contributes a matching amount equal to the participant's pre-tax contribution and after-tax Roth contribution, not to exceed 4% of the employee base salary. MSRC may also contribute a discretionary non-elective employer contribution calculated as a percentage of its employees' base salaries. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Refunds of excess contributions in accordance with tax provisions amounted to \$1,400 and \$1,755 in 2024 and 2023, respectively.

Participants may contribute rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants' contributions, rollover amounts, and associated earnings are immediately fully vested. MSRC's matching and non-elective employer contributions, if any, as well as associated earnings, vest according to the following schedule:

- 33% vested upon one year of service
- 66% vested upon two years of service
- 100% vested upon three years of service

In addition, 100% of MSRC's matching and additional contributions are vested upon death or total disability.

Forfeited Accounts

Participants who terminate employment forfeit the MSRC matching and non-elective employer contributions that are not fully vested. Forfeitures are applied to reduce the amount of future employer contributions and pay certain administrative expenses. MSRC applied forfeitures of \$131,363 and \$85,549 for the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions. Unused forfeitures available to reduce future employer contributions amounted to \$120,269 and \$85,626 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, and a maximum amount of the lesser of: (a) 50% of the total vested portion of the participant's account balance; or (b) \$50,000 reduced by the excess (if any) of the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made over the outstanding balance of plan loans on the date the loan is made. Each participant may not have more than two loans outstanding at any time.

The interest rate charged is the prime rate as published in the Wall Street Journal as of the first day of the calendar quarter in which the loan is approved, plus 1%, and is fixed for the life of the loan. Loan terms are limited to a maximum of five years except for loans used to purchase a primary residence, which are limited to a term of 10 years. Loans are granted on a nondiscriminatory basis and comply with the requirements of the Internal Revenue Code (IRC) of 1986. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or a participant may elect distribution via installment payments under a systemic withdrawal plan. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Participants may make withdrawals of their after-tax contributions from the Plan at any time and may withdraw their pre-tax contributions if the participant qualifies for a hardship withdrawal. In-service withdrawals of after-tax contributions and hardship withdrawals cannot be repaid. On attainment of age 59 ½, participants may make withdrawals of all or a portion of their vested account balance without any suspension of making further contributions. Upon termination of employment, participants may

withdraw their vested account balances or they may leave their account balances in the Plan, so long as their respective vested balance exceeds \$7,000.

Trustee and Administration of the Plan

The administration of the Plan is the official responsibility of MSRC, as the Plan Administrator. The Plan Administrator has designated an Administrative Committee (AC) to which administrative authority and responsibility with respect to the Plan has been delegated, and an Investment Committee (IC), to which investment authority with respect to the Plan has been delegated. The AC is composed of MSRC's President and Chief Executive Officer, Vice President and Chief Financial Officer, Vice President and General Counsel, and Director-Human Resources. The IC is composed of MSRC's President and Chief Executive Officer, Vice President and Chief Financial Officer, and Vice President and General Counsel. Fidelity Management Trust Company (FMTC) serves as the trustee of the Plan and Fidelity Workplace Services, LLC serves as the record-keeper of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, rollover contribution (if any), and allocations of (i) MSRC's contribution, (ii) Plan earnings or losses, and (iii) allocation of loan processing fees and administrative expenses for certain mutual funds, as applicable, to the participant account based on the participant's direction of allocation. Allocations are based on participant earnings or losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except the fully benefit responsive contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See Note 4 for further information related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded when earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which MSRC makes the respective payroll deductions from the participant's compensation. Non-elective employer contributions are recorded in the relevant period in accordance with terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain loan processing fees and administrative expenses in relation to recordkeeping are allocated to participant accounts. As of December 31, 2024 and 2023, the administrative expenses are an annualized 0.06% of the Plan's assets and are allocated based on participant's account balances. Other administrative, accounting, and legal costs of the Plan are paid by MSRC and are excluded from these financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g. divestitures or spin-offs of a subsidiary) which cause a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

A fully benefit-responsive investment contract also provides a liquidity guarantee, by a financially responsible third party, of principal and previously reported accrued interest for liquidation, transfers, loans, and hardship withdrawals initiated by Plan participants exercising their rights to withdraw, borrow, or transfer funds under the terms of the Plan.

Pooled Separate Account - The investments in the pooled separate account New York Life Anchor Account (35) (Anchor Account) are directed to a New York Life pooled separate account which primarily invests in a diversified portfolio of high-quality, fixed income securities. This pooled account is fully benefit-responsive as defined by Financial Accounting Standards Board (FASB) ASC 962 *Plan Accounting—Defined Contribution Pension Plans* and is reported at contract value.

Participants may deposit and withdraw on a daily basis at contract value. Participants may also transfer to other investment options in the Plan. Transfer restrictions may exist for any plan offering competing funds. Competing funds may include money market funds, short-term bond funds, and self-directed brokerage options. New York Life will not provide book value coverage for redemptions following certain employer-initiated events or actions (such as a plan termination, layoffs, early retirement programs, or bankruptcy of the plan sponsor).

The Anchor Account crediting rate is subject to change daily. The deposits made in 2024 and 2023 yielded an interest rate of 3.65% and 3.31%, respectively.

6. Related Party and Party-in-Interest Transactions

MSRC is the administrator of the Plan, and as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by MSRC.

FMTC serves as trustee of the Plan, and therefore, fees and expenses paid to the trustee qualify as party-in-interest transactions. Fidelity Workplace Services, LLC serves as the recordkeeper of the Plan and as such, fees paid for services, and notes receivable from participants, also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Plan Termination

Although it has not expressed any intent to do so, MSRC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balance and would be eligible to receive all funds in their respective accounts as of the termination date.

8. Income Tax Status

Effective October 1, 2019, the Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity (Fidelity pre-approved plan). The Fidelity pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the Fidelity pre-approved plan's qualified status. The Fidelity pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
