## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Computer Task Group, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan is funded by employee and employer contributions and covers substantially all U.S. based employees of Computer Task Group, Inc. (CTG or the Company) who complete one hour of service. The Plan assets are held in shares of registered investment companies and a common collective trust fund held by Fidelity Management Trust Company, the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

Effective April 8, 2024 ("2024" Merger date), the Impiger Technologies Inc. Retirement Trust Plan (Impiger) was merged into the Plan. Amounts transferred into the Plan totaled \$194,541. All assets of the Impiger Plan were held by Fidelity Management Trust Company.

#### **Contributions**

The Plan provides for employee pre-tax contributions ranging from 1% to 100% of salary, up to the maximum annual limitations allowed by the IRC. A Roth 401(k) feature is also available under the plan. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions, also as allowed by the IRC. The Company may contribute on a discretionary basis to employee accounts. The Company made discretionary contributions to the Plan totaling \$553,806 in 2024 and \$61,668 in 2023. During 2024 and 2023, discretionary contributions were reduced by forfeitures in the amount of \$553,806 and \$61,668, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may initiate electronic or telephonic fund exchanges each business day.

The Plan provides for automatic enrollment, where each new eligible employee is enrolled contributing 6% of their salary to the Plan unless they opt out of the election at the time of hire. Each subsequent year, the employee's contributions are increased by 1% automatically until the contributions reach 10% of the employee's salary. The employees can also opt out of contributing to the Plan at a date subsequent to their date of hire.

#### **Vesting**

Participants are immediately vested in their own contributions, including actual earnings or losses thereon. Participants become 20% vested in employer contributions after two years, 50% vested after three years of service, and fully vested after four years of service. Prior matching and prior profit sharing contributions received under qualified plans that have since been merged with the Plan are fully vested. Should the Plan be deemed top-heavy as defined under ERISA guidelines, an alternate vesting schedule will apply for those top-heavy years. The Plan was not deemed to be top-heavy in both 2024 and 2023.

## 1. DESCRIPTION OF PLAN (Continued)

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to limit or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in employer contributions.

### **Forfeitures**

Amounts forfeited by participants are first used to reduce future employer contributions and then to offset plan expenses. Any excess remaining in the forfeitures account will then be distributed to increase benefits in participants' accounts. Forfeitures used to reduce employer contributions during the years ended December 31, 2024 and 2023 totaled \$553,806 and \$61,668, respectively. There were \$258,507 and \$648,775 of unapplied forfeitures at December 31, 2024 and 2023, respectively.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts, starting at a minimum of \$1,000 and increasing up to the lesser of a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years and may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings/(losses) and charged with an allocation of the administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Withdrawals and Distributions**

Unless a participant elects otherwise, distributions will be made as soon as practical after a participant's normal retirement date or the actual retirement date occurs. The normal retirement date is the date upon which a participant reaches age 65.

Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death, or disability, if their account balance is in excess of \$5,000. If the participant elects to keep their vested interest in the Plan, the participant's account will continue to receive its share of earnings and losses. Terminated participants with an account balance in excess of \$1,000, but less than \$5,000, who have not elected to receive their vested account balance, and are under the normal retirement age, will receive a distribution of their account and the funds will automatically be transferred to an IRA at Fidelity Investments.

Participants who reach age 59-1/2, but who are not separated from service, may withdraw from the Plan up to 100% of the value of their non-forfeitable interest in the Plan.

### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

All investments are carried at fair value or an approximation of fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses incurred by the plan administrator, investment manager, and trustee for their services and costs in administering the Plan are paid directly either by the Company or the Plan.

### **Income Taxes**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### 3. FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid for a liability in the principal or most advantageous market for the asset or liability, in an orderly transaction between market participants. The Plan utilizes a fair value hierarchy for its assets and liabilities, as applicable, based upon three levels of input, which are:

Level 1 - quoted prices in active markets for identical assets or liabilities (observable).

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in inactive markets, or other inputs that are observable or can be supported by observable market data for essentially the full term of the asset or liability (observable).

Level 3 - unobservable inputs that are supported by little or no market activity, but are significant to determining the fair value of the asset or liability (unobservable).

The following provides a description of the types of Plan investments that fall under each category, and the valuation methodologies used to measure these investments at fair value.

*Registered Investment Companies:* Valued at quoted prices in active markets as of the valuation date.

*Common Collective Trust:* Fund assets invested in the Fidelity Managed Income Portfolio (the Portfolio) invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into wrap contracts issued by third parties, and invests in cash equivalents represented by shares in money market funds. The net asset values (NAVs) are quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market or have observable inputs, with the exception of wrap contracts, which are valued using unobservable inputs including the Portfolio's own assumptions based on the best information available. The common collective trust's underlying investments seek to preserve capital and provide a competitive level of income over time that is consistent with the preservation of capital. The common collective trust does not have any unfunded commitments relating to its investments, nor any significant restrictions on redemptions.

NAV is a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, Fidelity Management Trust Company was the Trustee of the Plan, therefore any transactions between the Plan and Fidelity Management Trust Company, qualify as party-in-interest.

Fees paid by the participants primarily for distributions from the Plan and loan maintenance fees amounted to \$68,995 and \$67,071 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, fees paid primarily for investment advisory and audit services totaled \$72,716 and \$69,950, respectively.

Notes receivable from participants are party-in-interest transactions. Interest income from notes receivable from participants totaled \$93,057 and \$132,045 for the years ended December 31, 2024 and 2023, respectively.
