To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dobler Management Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1. Description of the Plan

The following description of the Dobler Management Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General:

The Plan is a contributory defined contribution plan established January 1, 2021 covering all eligible employees of DLP Employee Services, LLC and Dobler Management Company, Inc., the Plan Sponsor and the Participating Employer, respectively. Eligible employees are those employees who have reached twenty-one years of age, completed one year of service and is considered a long-term, part-time employee in accordance to the SECURE 2.0 Act. Employees who are a non-resident alien or part-time/seasonal/temporary employees are not eligible to participate in the Plan. Eligible employees may enter the Plan to make salary deferral contributions at the beginning of each month following the date eligibility requirements are met.

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law, which provides both required and optional future enhancements to tax qualified retirement plans and their participants. The provisions of the SECURE 2.0 Act may be effective and operationalized prior to formally amending the Plan document. The Plan has until December 31, 2026 to formally amend the Plan documents. Plan management has implemented the required provisions in accordance with the applicable effective dates and is also continually evaluating the optional provisions.

Contributions:

Upon meeting eligibility requirements, participants are automatically enrolled in the Plan with salary deferrals of 2 percent of eligible compensation with an automatic increase of 1 percent per year up to a maximum of 3 percent of eligible compensation. Participants may elect a different deferral amount or opt-out of the automatic contribution arrangement.

Each year participants may contribute up to a maximum amount allowed by the Internal Revenue Code of eligible compensation as defined by the Plan. Participant contributions may be made as pre-tax or Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan Sponsor will contribute a safe harbor nonelective contribution equal to 3 percent of the participant's compensation. The Plan Sponsor may also contribute an additional discretionary matching contribution, a nonelective profit sharing contribution and a qualified nonelective contribution (QNEC) at the discretion of the Plan Sponsor's Board of Directors.

NOTE 1. (Continued)

Participant Accounts and Investment Options:

Contributions from Plan participants and the related Plan Sponsor's matching contribution are recorded in the year in which the employee contributions are withheld from compensation.

Contributions to participant accounts are deposited into participant-directed funds at Matrix Trust Company. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Each participant's account is credited with the participant's contribution and allocation of the Plan Sponsor's contribution and Plan earnings, as determined above. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

The participants are 100 percent vested in participant salary deferral contributions, rollovers, safe harbor nonelective contributions, QNEC contributions, and the related earnings at all times. Vesting in the Plan Sponsor's discretionary contributions plus the related earnings is based on years of credited service. Generally, a participant is 100 percent vested after five years of credited service or upon age 65, retirement, death, disability or termination of the Plan.

Forfeitures:

Nonvested participant account balances forfeited into the Plan during the year ended December 31, 2024 and 2023, was \$-0-.

Forfeitures of nonvested account balances can be used to reduce the Plan Sponsor's contributions or pay Plan expenses.

Payment of Benefits:

On termination of service, a participant with an accrued benefit of 5,000 or less may elect to receive their vested account balance in a lump-sum amount or rollover their account to another qualified account. If no election is made and the balance is over \$200, the balance will be distributed in a direct rollover to an individual retirement plan as provided under the terms of the Plan. If the balance is less than \$200, a lump-sum distribution will be made regardless of election. The distribution date will be the earliest administratively feasible date determined by the administrator and custodian. Terminated participants with an accrued benefit in excess of \$5,000 may leave the funds in the Plan or elect to receive a distribution in a lump sum.

Upon death or disability, a beneficiary or participant will receive 100 percent of their account balance paid as if retired. Pre-retirement and hardship distributions are not allowed.

NOTE 2. Summary of Significant Accounting Policies

Basis of Presentation:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and present the net assets available for Plan benefits and the changes in those net assets.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Administrative and Investment Management Expenses:

The Plan's expenses are paid either by the Plan or Plan Sponsor, as determined by the trustee, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

NOTE 3. Risks and Uncertainties

The Plan is exposed to market and credit risk due to the various foreign and domestic investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 4. Information Certified by the Custodian

Certain information related to cash and investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified as complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024 by Matrix Trust Company as follows:

- Cash - non interest bearing and investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation or depreciation in fair value of investments, interest, dividends, and capital gains reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments reflected on the supplementary Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosure*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (Registered Investment Companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques and inputs are appropriate and consistent with other market participants, the use of different techniques and inputs or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. Party-in-Interest Transactions and Administration of Plan Assets

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

The Plan's investment options are held in participant directed accounts at Matrix Trust Company, the custodian of the Plan; therefore, any transaction executed with Matrix Trust Company qualifies as a party-in-interest transaction.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activities to various service providers. These transactions are party-in-interest transactions.

The Plan Sponsor, DLP Employee Services, LLC is a party-in-interest. Certain administrative functions are performed by employees of the Plan Sponsor. No such employee receives compensation from the Plan. The Plan Sponsor has the discretion to appoint or remove any trustee or agent of the Plan. The Trustee have the full power to administer the Plan and apply all of its provisions on behalf of the Plan Sponsor.

NOTE 7. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Spectrum Pension Consultants, Inc. which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Although the opinion letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE 7. (Continued)

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no material uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE 8. Plan Termination

Although it has not expressed any intent to do so, the Sponsors have the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 9. Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is July 11, 2025, which is the date on which the financial statements were available to be issued.
