## **INDEPENDENT AUDITORS' REPORT**

The Plan Administrator  
New England Sinai Hospital Pension Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of New England Sinai Hospital Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (liquidation basis) and 2023 (going concern basis), and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 (liquidation basis) and 2023 (going concern basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of New England Sinai Hospital Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of New England Sinai Hospital Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further described in Note 1 to the financial statements, the Plan sponsor approved a plan of liquidation effective April 30, 2024, and management has determined liquidation is imminent. As a result, New England Sinai Hospital Pension Plan changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of New England Sinai Hospital Pension Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedules Required by ERISA**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. DESCRIPTION OF PLAN

The following description of the New England Sinai Hospital Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The plan sponsor, New England Sinai Hospital (a Steward Family Hospital) (the Hospital), amended the Plan, effective January 1, 2007, to freeze the benefits under the Plan for certain groups of participants. Participants aged 45 or over with at least 10 years of service or age 65 or over with at least five years of service continued to accrue benefits under the Plan. All other participants' accrued benefits were frozen as of that date. New or rehired employees are not eligible to participate in the Plan. Effective January 1, 2009, the Hospital adopted a resolution to freeze the benefits under the Plan for all participants.

On January 4, 2024, Steward Health Care Systems LLC (Steward), the parent company of the Hospital, made a Reportable Event filing with the Pension Benefit Guaranty Corporation (PBGC), a U.S. government agency, in connection with New England Sinai Hospital's decision to cease operations beginning in 2024.

On April 29, 2024, New England Sinai Hospital was permanently closed.

On May 6, 2024, Steward filed voluntary petitions for reorganization under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Southern District of Texas. As of that date, the Plan is restricted from making any prohibited payments to participants and beneficiaries, as described in Internal Revenue Code (IRC) Section 436(d)(2) and Section 206(g)(3) of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 27, 2025, the PBGC issued to Steward a notice of determination that the Plan has not met the minimum funding standard required under Section 412 of the IRC and will be unable to pay benefits when due and that the Plan should be terminated. The Plan termination became effective as of April 30, 2024.

On April 25, 2025, Steward and the PBGC entered into a settlement proposal term sheet pursuant to which the parties agreed to the PBGC initiated termination of the Plan and certain related matters in connection with Steward's Chapter 11 proceeding. The PBGC was appointed as the trustee of the Plan as part of this agreement.

#### **General –**

The Plan, a noncontributory, defined benefit plan for employees of the Hospital, was established on April 1, 1977, and amended and restated January 1, 2020, to provide benefits to the Hospital's eligible employees (participants). Benefits under the Plan are based on earnings and length of service and vest after five years of service. Employees became eligible when they reached age 21 and completed at least 1,000 hours of service during the 12-month period following their dates of hire, provided that they had not attained age 65. The Plan is subject to the provisions of ERISA, as amended. All investments are nonparticipant directed.

**Vesting –**

A participant has a fully vested interest in the accrued benefit on and after the earlier of the following: (1) upon death, disability, early, normal, or deferred retirement, as defined by the Plan or (2) upon completion of three years of service. Participants who terminate before rendering three years of continuous service forfeit the right to receive their accumulated plan benefits. Prior to a plan amendment effective January 1, 2011, the vesting requirement was five years. However, all employees whose benefits were frozen are fully vested in pension benefits as of the date that their benefits were frozen.

**Funding Policy –**

The Plan's funding policy is for the Hospital to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Hospital made contributions of \$0 and \$363,246, respectively. Prior to the Plan's termination on April 30, 2024, the Plan Sponsor did not satisfy the minimum required funding contributions for the plan years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, there was unpaid minimum required contributions of \$847,064 and \$387,578, respectively. The Plan Sponsor may be subject to excise taxes under IRC Section 4971 related to the unpaid minimum required contributions.

**Pension Benefits –**

Participants who have completed the required years of service, as described in the vesting requirements below, are entitled to annual pension benefits beginning at normal retirement age (65) based on their final five-year average annual compensation and years of credited service earned with the Hospital prior to the Plan freeze date. The Plan permits early retirement at ages 55 to 64. A participant who separates from service on or after the later of their attainment of age 55 and has completed at least eleven years of service shall be entitled to receive a distribution of an early retirement benefit which shall be the participant's accrued benefit, reduced by 3.5% for each year by which the starting date of the benefit precedes their normal retirement date. Employees may elect to receive their benefits in the form of an actuarially determined joint and survivor annuity or a lump-sum benefit. The lump-sum benefit is based on the final five-year average annual compensation and years of credited service. If employees terminate before rendering the requisite years of service, as described in the vesting requirements above, they forfeit the right to receive their accumulated plan benefits. The Plan has provisions for disability, early retirement, survivor, and other benefits, each of which reduces the regular benefit by an amount stated in the Plan or determined by the Plan's actuary. Effective May 6, 2024, lump-sum benefits are no longer available to participants.

**Death and Disability Benefits –**

A participant shall be eligible for a death or disability benefit, payable in the event the participant dies or becomes disabled after he/she becomes vested in his/her accrued pension. Disability retirement benefits are also available to participants who have terminated employment after 1) having completed four or more years of service prior to January 1, 1989, or 2) have become disabled after they have completed the required years of service, based on the vesting requirements above, and attained age 55. Disability benefits, if paid before the participant's normal retirement date, shall be reduced by 1/240 for each month prior to the normal retirement date that the payment commences.

**Administrative Expenses –**

The Plan's expenses are paid either by the Plan or the Hospital, as provided by the Plan document. Expenses that are paid by the Hospital are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting –**

The financial statements as of December 31, 2023, are prepared on the going concern basis of accounting, which assumes the Plan will continue to operate on an ongoing basis. Due to the termination of the Plan, the financial statements as of and for the year ended December 31, 2024, are presented on the liquidation basis of accounting in accordance with ASC 205-30. Under this basis, assets are reported at their estimated net realizable value, representing the amounts expected to be collected or realized during liquidation and liabilities are reported at their estimated settlement amounts, reflecting costs expected to be incurred to settle all obligations during liquidation. The estimated net realizable cash value for investments as of December 31, 2024 is fair value. There are no material changes to the 2024 financial statements as a result of the change under the liquidation basis of accounting.

**Use of Estimates –**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition –**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Due Diligence Retirement Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits –**

Benefits are recorded when paid.

**Date of Management's Review –**

The Plan has evaluated subsequent events through July 8, 2025, the date the financial statements were available to be issued.

**3. EMPLOYER CONTRIBUTIONS RECEIVABLE**

As of December 31, 2024 and 2023, the Plan Sponsor had unpaid minimum required contributions under ERISA Section 430 and IRC Section 412 totaling \$847,064 and \$387,578, respectively .

Under the liquidation basis of accounting, assets should be reported at the amount of cash or other consideration expected to be received in settlement. The Plan Sponsor has not nor is it expected to make such contributions. Therefore, no contributions receivable has been recorded for the unpaid minimum required contributions.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts*

Valued at estimated fair value based on the underlying investments in the pooled separate account as reported by the issuer at the net asset value (NAV) as of the reporting date, which is the basis for current transactions. The NAV is used as practical expedient to estimate fair value. The investment strategies of the mutual funds held by the pooled separate accounts include government credit, core and short-duration bond, social, small-cap and diversified value, mid-cap growth, total return, emerging markets, real estate, and overseas international strategies.

At December 31, 2024 and 2023, the Plan's pooled separate accounts were valued at fair value, which is measured using NAV per share as the practical expedient and, therefore, have not been categorized within the fair value hierarchy. The fair value of the Plan's pooled separate accounts totaled \$15,240,777 and \$16,643,153 at December 31, 2024 and 2023, respectively. There are no unfunded commitments, and the redemption frequency and redemption notice period are both daily.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Empower Annuity Insurance Company of America, the custodians.

**6. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service participants have rendered as of the freeze date. Accumulated plan benefits include benefits expected to be paid to retired or terminated employees or their beneficiaries. Benefits under the Plan are based on the participants' compensation during their years of service up to the freeze date. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to participant service rendered to the valuation date.

The actuarial present value of accumulated plan benefits (computed using the unit credit cost method) is determined by the Plan's actuary and results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**8. PLAN TERMINATION**

The Plan terminated effective April 30, 2024. The net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former participants or their beneficiaries have been receiving for at least three years, or that participants eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- b. Other vested benefits insured by the PBGC, up to the applicable limitations, as described in ERISA.
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC when the Plan terminates. Generally, the PBGC guarantees most vested normal retirement age benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits upon plan termination will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

**9. TAX STATUS**

The Plan obtained its latest determination letter from the Internal Revenue Service (IRS) dated March 31, 2018, in which the IRS stated that the plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**10. PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Empower Trust Company and Empower Annuity Insurance Company of America, the custodians as defined in the Plan. Therefore, these transactions qualify as party-in interest transactions which are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. The Hospital directly pays certain fees related to the Plan's operations.

## **SECTION XII** **ACTUARIAL COST METHODS**

### **Traditional Unit Credit (TUC)**

The actuarial cost method used in the development of the minimum contribution was the unit credit cost method.

The normal cost is the sum of all the individual normal costs for each participant. For active participants, the individual normal cost is the present value of the benefit earned during the year being valued. For active participants whose credited service equals or exceeds the plan maximum, if any, and for non-active participants, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all participants. The individual accrued liability for an active participant is the present value of the accrued benefit as of the valuation date. The unfunded liability is the actuarial accrued liability less the valuation assets.

The total annual cost of the plan is the normal cost plus an amount to amortize the shortfall amount.

### **Projected Unit Credit (PUC)**

The actuarial cost method used in the development of the maximum contribution was the projected unit credit cost method.

Under this method, the normal cost is the sum of the individual normal costs for all participants. For an active participant, the individual normal cost is the present value at the current age of the projected benefit at the assumed retirement age, based on the actuarial assumptions, divided by the participant's expected years of credited service at that age. For a non-active participant, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all plan participants. For an active participant, the individual accrued liability is the product of the normal cost and the total years of credited service at the current age. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded actuarial accrued liability equals the actuarial accrued liability less the valuation assets.



*Average compensation:* The highest 5 consecutive years of pensionable earnings. In no event shall pensionable earnings exceed the limitation specified in Section 401(a)(17) of the Internal Revenue Code.

*Accrued benefit:* The accrued benefit is determined as follows:

A lump sum equal to the greater of (1) and (2), where

(1) The actuarial equivalent of a life annuity equal to 1% of average compensation multiplied by total years of benefit service, and

(2) The sum of (a) 11% of average compensation multiplied by years of benefit service up to a maximum of 15 years, plus (b) 14% of average compensation multiplied by total years of benefit service in excess of 15 years.

*Normal retirement eligibility:* Upon the attainment of age 65 and completion of 5 years of vesting service.

*Normal retirement benefit:* Unreduced accrued benefit payable immediately.

<i>Normal form of benefit:</i>	Married members - A pension payable for life. However, members are required by law to receive a reduced qualified joint and survivor benefit unless formally elected otherwise.  Single members - A pension payable for life.
