**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Smugglers' Notch Resort 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

### **Basis for Opinion**

(1) Description of Plan

The following description of the Smugglers' Notch Resort 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a qualified 401(k) and profit-sharing plan covering all employees of the Smugglers' Notch Management Company, Ltd. (the "Sponsor"), excluding union members and non-resident aliens. Employees will enter the Plan on the first day of the month coinciding with or next following satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2023, the eligibility requirement changed to 18 years old for all contributions and two months of service for employees to contribute to the Plan. Additionally, the Plan ceased the auto enroll provision.

- (b) Employee Contributions – Employees may elect to contribute any amount of eligible compensation, subject to Internal Revenue Code ("IRC") limits. Participants are permitted to make rollover contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.
- (c) Employer Contributions – The Sponsor may contribute a discretionary matching or profit-sharing contribution. To be eligible for the Sponsor contributions, a participant must complete 1,000 hours of service. Additionally, a participant must be employed on the last day of the plan year to receive the profit-sharing contribution. The Sponsor made a matching contribution of 50% up to 4% deferred by participants for the years ending December 31, 2024 and 2023.
- (d) Participant Accounts – Each participant's account is credited with the participant's allocation of (a) the participant's contribution; (b) the Sponsor's discretionary matching and profit-sharing contribution; and (c) Plan earnings. The allocation of the profit-sharing contribution is based on the relationship of the participant's compensation to the total compensation earned by participants in the Plan. The allocation of the Plan's earnings is based on participants' account balances. The benefit to which a participant is entitled is that which can be provided from the vested balance in the participant's account. Participants direct all contributions into various investment options.
- (e) Vesting – Participants' contributions are 100% vested. A participant's vested percentage of the Sponsor's contributions is based on years of service. There is no vesting until three years of service, at which time a participant becomes 100% vested. A participant also becomes 100% vested in the Sponsor's contributions in the event of normal retirement, death, or disability.

- (f) Forfeitures – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the Sponsor's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,094 and \$2,306, respectively. Forfeitures used for the years ending December 31, 2024 and 2023 were \$0 and \$812, respectively.
- (g) Withdrawals and Benefits – Upon termination of service, death, retirement, or disability, the participant or beneficiary may elect to receive a lump sum payment equal to the value of their account. Upon termination of service, if a participant's vested benefit is less than \$5,000, the benefits will be distributed as soon as administratively feasible.

Hardship withdrawals are permitted by the Plan in cases of heavy and immediate financial need. In-service distributions are also permitted, once the participant has reached the age of 59½.

- (h) Administrative Expenses – Generally, the Sponsor pays the administrative expenses for the Plan, except expenses of the third-party administrator. Participants pay the distribution and loan processing fees, and certain investment fees.
- (i) Income Tax Status – The Plan was formed based on a prototype plan that has received a determination letter dated June 30, 2020. The Plan has been amended since receiving the determination letter, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the section 401(a) of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

- (j) Notes Receivable – Participants may borrow any amount from \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance, as defined in the Plan. A participant may have no more than 2 loans outstanding at any time. Loans are repaid through payroll deductions on an after-tax basis for a period not to exceed a 5-year term, or up to a 15-year term if used for the purchase of a primary residence. The interest rate is based on the prime rate of interest published by the Federal Reserve Bank as of the date of the loan, plus 2%.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – Investments are valued at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for plan benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.
- Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.
- (c) Cash Equivalents – The Plan considers all highly liquid investments with an original maturity of three months or less to be cash equivalents.
- (d) Risks and Uncertainties – The Plan provides for various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.
- (e) Payment of Benefits – Benefit payments are recorded when paid.
- (f) Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.
- (g) Subsequent Events – The Plan evaluated subsequent events through July 15, 2025, the date the Plan's financial statements were available to be used.

(3) Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Reliance Trust Company, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule. The custodian has certified to the completeness and accuracy of all amounts and types of investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(4) Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

(5) Investment Contract

The Plan has entered into a fully benefit-responsive guaranteed investment contract. The custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment income contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

Investment Contract (continued)

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

(6) Withdrawing Participants

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

(7) Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Sponsor may amend the Plan at any time without consent of any participant or beneficiary, provided that no amendment deprives any participant of their accrued benefit.

(8) Related Parties

The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
