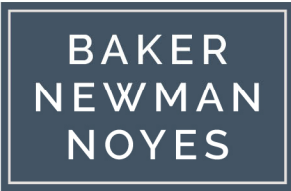

INDEPENDENT AUDITORS' REPORT

The Plan Administrator and Participants
N.R.F. Distributors Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of N.R.F. Distributors Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by, and certified to by, qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of Plan

The following description of the N.R.F. Distributors Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of N.R.F. Distributors (the Company) who are at least 18 years of age and have completed at least 3 months of service. The Administrative Committee manages the operation and administration of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Company has adopted a non-standardized 401(k) Profit Sharing Plan administered by The TPA Experts (formerly Downeast Pension Services, Inc).

Contributions

Participants may voluntarily contribute on a pre-tax and/or after-tax basis up to 100% of their compensation, subject to Internal Revenue Code (the Code) limitations. The Company may elect to match a portion of the participants' voluntary contribution at an amount determined annually by the Board of Directors. The match was 25% of participant elective deferrals up to 8% of eligible compensation in 2024 and 2023. Additional amounts may be contributed to the Plan at the option of the Company's Board of Directors. There were no additional amounts contributed in 2024 or 2023.

Eligible employees are deemed to participate and contribute 4% of their compensation unless they affirmatively elect otherwise.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time during the year.

Participant Accounts

Each participant's account is credited with an allocation of contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollover Accounts

Employees may roll over into the Plan assets distributed as a vested interest upon their termination from a qualified defined benefit plan or a qualified defined contribution plan in which they were formerly participants on or before the 60th day after the day that they received the distribution.

Vesting

Participants are immediately vested in their voluntary contributions and rollover accounts. Vesting in the employer contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of service.

1. Description of Plan (Continued)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Payment of Benefits

Distributions are allowed upon termination of service due to death, disability or retirement. A participant or beneficiary receives an amount equal to the value of the participant's vested interest in their account in a lump-sum amount. Distribution upon termination for balances less than \$5,000 is permitted without participant consent. The Plan also provides for distributions upon economic hardship subject to certain criteria set forth in the Plan Agreement. In-service distributions are permitted for participants who have attained age 59 ½.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts included in net assets available for benefits were not material. Forfeitures may be used to pay administrative expenses and employer matching contributions. For the years ended December 31, 2024 and 2023, forfeitures used to reduce employer contributions, or to pay administrative expenses, were not material.

Notes Receivable From Participants

Loans may be granted to participants upon application. In no event shall the total of any such loan or loans to any participant, plus any prior loans unpaid, exceed the lesser of (a) 50% of the participant's vested interest in their account, or (b) \$50,000. No loan shall be for a term exceeding 5 years unless the loan proceeds are used to acquire a primary residence. Participants cannot have more than three loans outstanding at a time. The loans are secured by the vested balance in the participant's account and bear interest at the Prime rate, plus 1% at the time the loan is established. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, to the extent they are not paid by the Company. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accrual basis of accounting is utilized for reporting purposes.

2. Summary of Significant Accounting Policies (Continued)

Investments

Investments at December 31, 2024, consist of mutual funds, collective trusts, and a guaranteed interest fund. Investments at December 31, 2023, consisted of mutual funds and a guaranteed interest fund. The mutual funds and collective trust funds are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See note 6 for discussion of fair value measurements.

The guaranteed interest fund, a fully benefit-responsive investment contract, is stated at contract value, as determined by the insurance company, as it is considered fully benefit responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants

Participant loans are carried at the unpaid principal balance plus any accrued but unpaid interest, if material.

Benefits

Benefits are recorded when paid.

Contributions

Contributions from participants and the employer matching contributions are recorded in the year in which payroll deductions are made.

Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Subsequent Events

For the purposes of recognition and disclosure in these financial statements, management has evaluated subsequent events through June 17, 2025, which is the date these financial statements were available to be issued.

3. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The IRS has issued an opinion letter, dated June 30, 2020, that the non-standardized preapproved plan, adopted by the Company on January 1, 2022, is qualified as tax exempt under the appropriate sections of the Code. The Plan has been amended since the preapproved plan received the opinion letter. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Related Party Transactions

In 2024 and 2023, certain Plan investments were managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, and qualify as party-in-interest. Net administrative expenses paid by the Plan for parties in interest for the years ended December 31, 2024 and 2023 were \$88,557 and \$69,077, respectively.

5. Investments

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplemental schedule. The Plan's investments and notes receivable from participants, related investment income and dividends and interest income, and interest on notes receivable from participants and investment and loan transactions, including net appreciation of investments, were certified by the custodians as of and for the years ended December 31, 2024 and 2023.

The Guaranteed Interest Fund (the Fund) is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Investment contracts are valued at contract value principally because participants are able to transact at contract value when initiating benefit-responsive withdrawals, taking loans or making investment option transfers permitted by the participating plan. A benefit-responsive withdrawal includes a payment to a participant arising from retirement, termination of employment, disability or death. In the normal course, participant events are predictable (for participants as a group) such that the economic integrity of investment contracts is largely unaffected by participant withdrawals.

Employer-initiated events, if material, may affect the underlying economics of investment contracts. These events include discontinued operations, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of the Plan or other events. The occurrence of one or more employer-initiated events could limit the Fund's ability to transact at contract value with Plan participants. As of December 31, 2024, the occurrence of an event outside the normal operations of the Plan which would limit the Fund's ability to transact at contract value is not considered probable.

The average yield earned by the Fund and credited to participants during 2024 and 2023 was 1.66% and 1.48%, respectively.

6. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC 820), has established a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable and minimize the use of unobservable inputs. Assets that are measured at fair value using the net asset value (NAV) per share practical expedient have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. The Plan has no unfunded commitments for these funds and they can be redeemed daily at NAV.
