**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Deimling/Jeliho Plastics, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1      DESCRIPTION OF PLAN

The following description of the Deimling/Jeliho Plastics, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering substantially all employees of Deimling/Jeliho Plastics, Inc. (the Company) who are at least twenty-one years old and have completed one year of service. The Company pays certain administrative costs of the Plan, and controls and manages the operation and administration of the Plan. Empower Trust Company, LLC serves as the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Each year, participants may contribute up to 100 percent of annual compensation as defined in the Plan. During the 2024 tax year, participants could contribute up to \$23,000 if the participant's age is 49 or less, and \$30,500 if the participant's age is 50 or above. (This figure will be adjusted in the future by the Secretary of the Treasury for cost-of-living increases). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

For those employees who are at least twenty-one years old and have completed 1,000 hours of service in any given one-year period and are also employed on the last day of the Plan year, the Company may contribute a matching contribution at its discretion. For the plan year ended December 31, 2024, the Company did not contribute a matching contribution.

The Company may also contribute a nonelective discretionary amount to those employees who have met this requirement. The nonelective discretionary contribution, if any, is allocated to each eligible participant on a pro-rata basis based on the compensation of the participant to the total compensation of all eligible participants. For 2024, the nonelective discretionary contribution is 1.878 percent of a participant's compensation as defined in the Plan.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, as well as allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is 100 percent vested after three years of credited service. The Plan defines "one year of service" as a twelve-month period in which the participant works 1,000 hours of service. Company contributions also become fully vested when a participant employed by the Company reaches normal retirement age, as defined by the Plan, or is terminated due to death or disability.

**PAYMENT OF BENEFITS**

On termination, a participant (or participant's beneficiary in the event of death) will receive a lump-sum amount or installment payments equal to the value of the participant's vested account balance.

**FORFEITED ACCOUNTS**

Forfeitures of Company contributions may be used to restore forfeitures, reduce Company contributions, or pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,094 and \$2,609, respectively. During 2024, the Company did not dispose of forfeited non-vested accounts.

**PLAN EXPENSE ACCOUNT**

Included in the forfeitures and asset holding account is the Plan expense account (PEA). Amounts are deducted from participant accounts for administrative expenses and remitted to the PEA. These amounts are accumulated in the PEA so they may be used to pay service providers. As of December 31, 2024 and 2023, there was no balance in the PEA. Fees deducted for administrative expenses from participant accounts and remitted to the PEA totaled \$14,894 for 2024. Administrative expenses in the amount of \$14,894 were paid from the PEA for 2024.

**SECURE ACT 2.0**

The Setting Every Community Up for Retirement Enhancement Act (SECURE) 2.0 was signed into law on December 29, 2022. The Plan was amended January 5, 2024 to be in compliance with provisions required by the SECURE Act 2.0.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following is a summary of significant accounting policies followed in the preparation of these financial statements. The financial statements and notes are the representation of the Plan's management, who is responsible for their integrity and objectivity. The policies conform to accounting principles generally accepted in the United States of America and have been consistently applied.

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**CONTRIBUTIONS**

Participants' contributions and Company matching contributions are recognized in the period that the related payroll deductions are made. Company nonelective discretionary contributions are accrued as of Plan year end and paid in the following Plan year.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

NOTES TO FINANCIAL STATEMENTS

---

FAIR VALUE MEASUREMENTS

Topic 820, *Fair Value Measurement*, of the Accounting Standards Codification (Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Value of interests in registered investment companies (mutual funds) are valued at the net asset value (NAV) of shares held by the plan at year end (Level 1).

Insurance company general account contracts (fixed income) are valued at contract value which approximates fair value. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly (Level 2).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

SUBSEQUENT EVENTS

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through July 9, 2025, the date on which the financial statements were available to be issued.

NOTE 3 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in certain mutual funds and a general account contract managed by an affiliate of Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian and record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain administrative fees related to the administration of the Plan are paid by the Plan. Other administrative fees are paid by the plan sponsor on behalf of the Plan.

NOTE 4     **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 5     **TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangements, sponsored by SMS Retirement. The pre-approved plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as designed then, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6     **INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly Empower Trust Company, LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 7     **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
