Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dialysis Clinic, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets in liquidation available for benefits as of October 4, 2024 and December 31, 2023, and the related statement of changes in net assets in liquidation available for the benefits for the period January 1, 2024 through October 4, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of October 4, 2024 and December 31, 2023, and for the period January 1, 2024 through October 4, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Plan elected to terminate the Plan effective December 31, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting used to value Plan assets from the ongoing plan basis to the liquidation basis, effective December 31, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

OCTOBER 4, 2024 AND DECEMBER 31, 2023

Note 1—Description of the Plan

The following description of the Dialysis Clinic, Inc. Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan is a defined contribution individual retirement plan. Under the terms of the Plan, amounts contributed by Dialysis Clinic, Inc. (the “Company”) and earnings thereon are available for retirement benefits. Company employees who have completed one year of service with at least 1,000 hours of service are automatically entered into the Plan.

Plan Termination – Effective December 31, 2023, the Company approved a plan of termination. All participant account balances became 100% vested as of the termination date and were not subject to forfeiture. The Plan completed the distribution of all remaining assets on October 4, 2024. All participant accounts were fully liquidated and distributed by October 4, 2024. The accompanying financial statements are for the period January 1, 2024 through October 4, 2024, the date of final liquidation.

Administration – The Plan sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Prior to June 1, 2009, the Company contributed 4.5% of each eligible employee’s total annual compensation to the Plan. Employer contributions were made concurrent with each payroll period to eligible participant accounts. Effective June 1, 2009, the Company suspended the employer 4.5% contribution.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the Company’s contribution and Plan earnings (losses) and charged with withdrawals and an allocation of Plan administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested in the Company’s contribution portion of their accounts plus actual earnings thereon based on years of continuous service. Participants vest based on a three-year cliff and are 100% vested after three years of credited service. Due to the termination of the Plan, participants became immediately vested in their total balance December 31, 2023, the effective date of the Plan termination amendment that was approved by the Company.

Investment Options – Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note receivable terms cannot exceed five years unless for the purchase of principal residence. All notes receivable bear reasonable interest rates based on prevailing interest rates and are adjusted on the anniversary of the note receivable. Effective August 1, 2016, new loans are no longer permitted.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant’s vested balance may be distributed under an annuity or other methods depending on marital status, elections made by the participant, and the size of the vested benefit. For termination of service due to other reasons, a participant may elect to receive the value of vested interest in his or her account as a lump-sum distribution. In-service distributions are allowed for participants who have attained age 59½, based on Plan provisions.

Note 1—Description of the Plan (continued)

Forfeitures – At October 4, 2024 and December 31, 2023, there were no forfeited nonvested accounts. These accounts will be used to pay Plan expenses, allocated to participants, or used to reduce future employer contributions. During the period January 1, 2024 through October 4, 2024, no forfeitures was used to pay Plan expenses or allocated to participant accounts.

Note 2—Summary of significant accounting policies

Basis of Presentation – As described in Note 1, the Company elected to terminate the Plan effective December 31, 2023. In accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), the Plan has changed its basis of accounting from the ongoing plan basis of accounting to the liquidation basis of accounting. The change in basis did not have a material effect on the financial statements.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value, except for the fully benefit-responsive investment, which is reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of October 4, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are, therefore, excluded from these financial statements. Fees related to the administration of notes receivable from participants, participant elected investment guided portfolio advice, and withdrawal fees are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses and custodian fees are included in net appreciation (depreciation) of fair value of investments.

Note 3—Investment information certified by Qualified Institutions (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Variable Annuity Life Insurance Company ("VALIC") and VALIC Trust Company Inc., the qualified institutions of the Plan, have certified to the completeness and accuracy of all following data included in the accompanying financial statements:

- Investments at fair value, investments fully benefit-responsive, at contract value, and notes receivable from participants as shown in the statements of net assets in liquidation available for benefits as of October 4, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, interest income, dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets in liquidation available for benefits for the period January 1, 2024 through October 4, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements.

Note 4—Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include the following:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4—Fair value measurements (continued)

There have been no changes in the methodologies used at October 4, 2024 or December 31, 2023. The following is the description of the valuation methodology used for assets measured at fair value:

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market or a market established by the fund manager and classified within Level 1 of the valuation hierarchy.

The method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan recognizes transfers between levels as of the actual date of the event or change in circumstances that caused the transfer. There were no transfers between levels for the period January 1, 2024 through October 4, 2024 or year ended December 31, 2023.

Note 5—Guaranteed investment contracts with insurance company

The Plan’s fully benefit-responsive annuity contracts with VALIC earn a guaranteed interest rate and are held in a general account. Because the contracts are fully benefit-responsive, contract value is the relevant measurement attribute. Contract value, as reported by VALIC, represents contributions made under the contracts, plus earnings, less Plan withdrawals and investment expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on the formula specified in the annuity contract. The Short Term Fixed Account is credited with interest on a portfolio basis; all deposits in this option receive the same crediting rate, regardless of initial date of deposit. For the Fixed Account Plus investments, VALIC employs a modified new money interest crediting policy. Under this policy, VALIC declares a “current” interest rate at the beginning of each month applicable to contributions received during that month. The current rate declared is guaranteed until the end of that calendar year for contributions received that month. It is VALIC’s intent to continue to credit interest at the same rate for such contributions for an additional calendar year. At the beginning of the third calendar year, such contributions will earn interest at a new declared pool rate. This rate is established January 1 of each calendar year and guaranteed for that entire calendar year. The contractually guaranteed minimum interest rate is applicable for the lifetime of the contract. For the Fixed-Interest Option, the interest rate is declared monthly with interest credited on a daily basis at an annual effective rate. The product offers an annual minimum crediting rate set at the beginning of each year, as well as a contract minimum rate guaranteed. The product credits interest under a portfolio interest crediting method in which all deposits receive the same return regardless of date of initial deposit.

Note 5—Guaranteed investment contracts with insurance company (continued)

The VALIC fixed account options are supported by the VALIC general account and offer guaranteed crediting rates specified in advance of participant investment and set in response to several factors: the totality of investments previously made by participants, their anticipated payout timing requirements, the current investment climate, contractual minimum interest rate guarantees, competitive requirements, and required return on invested capital supporting the product.

Participants can withdraw or transfer a portion of their value (generally 20%) from the Fixed Account Plus account during each year. There are only short-term restrictions on withdrawals from the Short-Term Fixed account. The Fixed-Interest Option account has no participant transaction restrictions except for transfers to a competing fixed option. Transfers are subject to a 90-day equity wash provision. Plan sponsor withdrawals are restricted to 20% per year or the transaction is subject to a market value adjustment.

Employer initiated events, if material, may affect the underlying economics of annuity contracts. These events include location closings, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust, or other events. The occurrence of one or more employer initiated events could limit the Plan's ability to transact at contract value with Plan participants. Management notified VALIC of its intent to terminate the Plan.

Note 6—Party-in-interest transactions

The Plan invests in mutual funds and in investment contracts sponsored by VALIC and VALIC Trust Company Inc. Therefore, these transactions qualify as party-in-interest transactions. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. In addition, fees related to the administration of the Plan are paid to VALIC by the Plan and are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Notes receivable from participants qualify as party-in-interest transactions.

Note 7—Tax status

The Plan is a prototype plan which was developed by VALIC Retirement Services Company and was approved by the Internal Revenue Service ("IRS") on June 30, 2020. Therefore, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Management has not applied for or received a determination letter from the IRS with respect to the Plan as adopted. The Company believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 4, 2024 and December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Plan termination

The Sponsor of the Plan approved a plan of termination on November 2, 2023, and management determined that liquidation was imminent. The effective date of the Plan termination amendment was December 31, 2023. The Plan was terminated. As a result, plan assets were liquidated and the participants' distribution options included rolling the proceeds to another qualified employer plan or an Individual Retirement Account, or receiving a direct taxable distribution.

Note 9—Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation available for benefits and the statement of changes in net assets in liquidation available for benefits.

Note 10—Subsequent events

The Plan has evaluated events through July 14, 2025, the date the financial statements were available to be issued.
