We have performed an audit of the financial statements of Acute Care Health System 401(k) P/S Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Acute Care Health System 401(k) P/S Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code covering substantially all employees of Acute Care Health System ("the Company") except for non-resident aliens and union employees, who have reached the age twenty-one. Participants are eligible for the Company match in the month following one year of service in which they have worked at least 1,000 hours. Participants must be employed on the last day of the plan year to be eligible for any discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's two internal trustees are responsible for oversight of the Plan. They determine the appropriateness of the Plan's investment offerings and monitor investment performance.

In 2021 the owners of the Company partnered with an investor group out of Chicago to expand their PACE business. A new partnership was formed at the Company, known as the "NJ investors", and the "Chicago Investors"; each formed their own holding company, NJ Beacon LLC and Chicago Beacon LLC, respectively. Each holding company owns 50% of each new PACE program. The agreed upon structure for new business was that each new PACE program would be under its own legal entity owned by the holding companies. Additionally, a management company was formed which would manage all the PACE business and would manage the Company existing business. All the entities have common management and are part of an affiliated service group. The Company made a decision to set up separate plans for each entity for ease of managing the plans. As a result, certain employees may have stopped being eligible for this plan and become eligible for a new plan in 2023 or 2024. At that point they could elect to rollover their plan assets to one of the related plans that they were eligible for based on the company that employed them. As a result of these changes, the plan incurred a partial plan termination in 2023 and impacted participants became 100% vested in their accounts.

Notes receivable from participants amounting to \$28,723 were transferred to the Plan sponsored by Beacon of Life.

Contributions

Each year, participants may contribute 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. During 2024, the Company contributed 50% of the first 4% of base compensation that a participant contributed to the Plan. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. There were no profit-sharing contributions during 2024. Contributions are limited to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently holds a pooled separate account that does not file as a direct filing entity; therefore, the underlying investments are reported on the Form 5500. Participants may select from various sub-accounts within the pooled separate account and a fixed account as investment options for participants.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests 25% per year and is 100% vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through regular payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in her or her account in a lump sum. In service distributions for reasons of hardship are permitted from employee deferral accounts.

Forfeited Accounts

At December 31, 2024 and 2023 there were \$20,350 and \$12,976 in forfeited non-vested accounts. Forfeitures may be used to reduce future Company contributions or pay for plan expenses. No forfeitures were used during 2024.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan directly. Investment related expenses are included in net appreciation in the fair value of investments.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. During 2024 there were no new loans deemed to be in default.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit responsive fixed account, which is reported at contract value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 and Note 5 for the fair value disclosures of the Plan's assets.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The fair values of participation units held in the registered separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the separate accounts invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund. Each of the separate accounts provides for daily redemptions by the Plan with no advance requirements and has redemption prices that are determined by the fund's net asset value per unit.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

6. Insurance Contract

In 2014, the Plan entered into a fully benefit responsive insurance contract with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate to the Plan. The account has a guaranteed interest rate set by the insurance company.

Because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. The contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract has a crediting interest rate based on a formula agreed upon with the issuer and has a guaranteed rate. The rate was 1.6 percent and 1.50 percent as of December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents, (2) changes to the Plan's prohibition on competing investment options or deletion of the equity wash provisions in place, (3) bankruptcy of the Plan sponsor or other significant Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in any un-vested employer contributions.

8. Tax Status

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan may be amended periodically, the plan administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

9. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Related Party and Party-in-Interest Transactions

Certain plan investments are units of separate accounts and an insurance contract managed by VRIAC. Transactions with this party qualify as party-in-interest transactions. Notes Receivable from Participants also qualify as party-in-interest transactions.

11. Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to include an automatic enrollment provision of 3% with an annual automatic increase of 1% each Plan year up to 10% for all existing participants, except those that had an affirmative election effective as of the date of this provision.
