Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Southminster Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

1. Plan Description

The following description of the Southminster Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that operates under Section 403(b) of the Internal Revenue Code covering substantially all employees of Southminster, Inc. ("the Organization" or "Plan Sponsor"). Employees are eligible to contribute to the plan upon hire. Employees are generally eligible to receive employer contributions upon completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective July 1, 2024 the Plan was amended offering participants the option to refinance their participant loans.

Contributions

Each year participants may contribute amounts up to the allowable deferral limit defined by the Internal Revenue Service ("IRS"). Roth elective deferrals are permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions up to \$7,500. Participants with 15 years of service may be eligible for an additional catch up contribution at their election. The Plan has an Eligible Automatic Contribution Arrangement ("EACA"). This is a delayed automatic enrollment, which will be deemed elected 1 year after a participant's date of hire. Participants who have not made elections will be enrolled at 2% of eligible compensation and will be permitted to withdraw the funds from their EACA within 90 days, should they decide to opt out. The Plan Sponsor contributes a discretionary match each pay period of 100% of the first 6% that a participant contributes to the Plan. The Plan Sponsor may also make other discretionary contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the employees' contributions and the Organization's discretionary contributions and allocations of plan earnings and losses. Allocations of Plan earnings and losses are based on participant earnings or account balances, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into selected investment options as made available and determined by the Plan Administrator. The Plan currently offers mutual funds, registered separate account investments and insurance contracts. The Plan offers the Principal Pension Builder as an option to participants. This option creates a guaranteed monthly payment, is not subject to market fluctuations, is portable, and can be liquidated at any time, subject to surrender charges. Participants have daily access to their investment balances. Changes are self-directed by the participants through internet or telephone transfers.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contributions is based on years of continuous service, in which a participant works at least

1,000 hours. Participants become 100% vested upon death or disability; otherwise, participants vest 25% each year after two years of service and are fully vested after five years of service.

Forfeitures

The forfeiture account had a balance of \$1,651 and \$307 at December 31, 2024 and 2023, respectively. This account is used to reduce employer contributions and plan expenses each year. During 2024, forfeitures of \$40,142 and \$8 were used to offset employer contributions and plan expenses, respectively.

Notes Receivable from Participants

Participants may borrow from their Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust") fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate. Principal and interest is paid ratably through regular payroll deductions.

Plan Loans

Participants who have fund balances at The Variable Annuity Life Insurance Company ("VALIC") may borrow directly from VALIC. Adequate security is required, and a portion of the participant's account is reserved, or held in collateral, to cover 110% of the outstanding loan in case of default. The collateral is held in the fixed accounts. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 50% of their account balance. The loan interest rate for these Plan loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract as are the rate adjustment details and frequency. These amounts are not considered assets of the Plan.

Payment of Benefits

Upon retirement, disability or death, or termination, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. In-service distributions are available once a participant reaches age 65. Hardship distributions may be available upon proper cause from participants' elective deferral and rollover account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Participant loans in the amount of \$45,707 were deemed defaulted during 2024 and recorded as distributions.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and the certifying entities. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments. Administrative fees for recordkeeping, investment advisory services, loans, distributions, and other participant requested services are included in administrative expenses.

Excess Contributions Refundable

Amounts refundable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to employer contributions. The Plan distributed the 2024 excess contribution of \$10,286 to the applicable participants in April 2025. The 2023 excess contributions of \$8,536 were distributed to the applicable participants in February 2024.

3. Unaudited Information

The plan administrator has elected the alternative method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"). Accordingly, as permitted under such election, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust") and The Variable Annuity Life Insurance Company ("VALIC") have certified that the following data included in the accompanying financial statements and supplemental schedule is accurate and complete.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023, except that the VALIC registered investments are now considered valued at net asset value as a practical expedient instead of a readily determinable fair value.

Registered Investments: The investments held by VALIC are registered separate accounts that invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments and fund holdings are primarily valued using market quotations. Money market account holdings are generally valued at amortized cost. On a daily

basis, units in these investments are valued at their net asset value as a practical expedient to reflect performance of the underlying investments minus any fees and charges.

The registered investments held by Principal Trust are mutual funds. These funds are valued at their net asset value on a daily basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The registered investments are separate accounts that invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund.

6. Investment Contracts

The Plan has fixed annuity investment contracts with VALIC and a fixed income guarantee option with Principal Trust. The contract holders maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by VALIC and Principal Trust. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become fully vested.

8. Tax Status

The Internal Revenue Service has issued an opinion letter on the volume submitter 403(b) plan document that the plan utilizes, dated March 31, 2017. Although the Plan is periodically amended, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan has evaluated subsequent events through July 15 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, participants who were previously automatically enrolled at 2% and those eligible employees hired on or after January 1, 2025, who do not make a deferral election will be automatically enrolled at 3% of eligible compensation.
