Part III Accountant’s Opinion

d The opinion of an independent qualified public accountant is **not attached** because:

By way of background, on September 13, 2021, Tri-Wire Engineering Solutions, Inc. (the “Company”) filed a petition for relief under Chapter 11 of the U.S. Bankruptcy Code with the U.S. Bankruptcy Court for the District of Massachusetts (Case No. 21-11322-CJP) (the “Bankruptcy Case”). The Bankruptcy Case was caused by the Company’s increasing financial difficulties, themselves the product of a number of factors, including (i) the impact of the pandemic on its revenue, (ii) rising insurance costs, and (iii) an increasingly burdensome amount of debt – itself arising from the transaction involving the creation of the Plan – that the Company could no longer afford to pay.

The commencement of the Bankruptcy Case resulted in the creation of a bankruptcy estate which holds the Company’s assets for the benefit of the Company’s creditors. Shortly after the filing of the Chapter 11 Case, substantially all of the assets of the estate were sold to ITG Communications, LLC, pursuant to an order of the Bankruptcy Court. The net proceeds from the sale were applied in large part to reduce the Debtor’s indebtedness to its senior secured creditor, JPMorgan Chase Bank (“JPM”), but were far less than the amount of that debt, leaving only a small amount of funds to wind down the Debtor’s operations. That wind-down will be accomplished pursuant to the terms of the Company’s Liquidating Plan, approved by order of the Bankruptcy Court entered on June 30, 2022 (the “Liquidating Plan”).

At this point, other than a relatively small amount of cash reserved for funding the completion of the Company’s winding up, the only assets of the estate having any value are certain litigation claims against third parties, including the Company’s former President and Chief Executive Officer. Under the Liquidating Plan, the Company’s junior secured and unsecured creditors, who hold substantial claims against the Company, will only receive payments on account of their claims, if any, from recoveries obtained in these litigation claims, which have been transferred to a trust for the benefit of creditors (the “Creditor Trust”). On information and belief, the recoveries which may be derived from the litigation claims, if any, are not expected to exceed the amounts owed by the Company to its creditors. Thus, under the Plan, the interests of equity holders in the Company – i.e., the participants in the Plan – were extinguished.

The Plan includes a budget for expenses which the Plan Administrator appointed under the Plan may incur in connection with the wind-down of the Company's operations, which has been approved by JPMorgan Chase Bank and the Bankruptcy Court. In light of JPM's losses from its loans to the Company, that budget is extremely limited, and does not include an allocation for the audits which would otherwise be completed in connection with the preparation of the 2024 Form 5500 Annual Report. The typical fee amount for this type of work can range between \$6,000 and \$30,000. As the budget shows, the estate is unable to pay these fees. In light of the extinguishment of the equity interests of the Plan, incurring such costs would also be a wasteful use of the Company's limited funds.

The omission of the accountant's opinion for the 2024 Form 5500 Annual Report is therefore not due to willful neglect, but due to a lack of funds from the bankruptcy estate to hire an auditor to prepare the accountant's opinion. Therefore, the Plan Administrator respectfully declines to include an accountant's opinion with the 2024 Form 5500 filing.
