### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Larson Engineering Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following description of Larson Engineering Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established January 1, 1989, last amended effective January 1, 2019 and last restated effective February 17, 2022. The Plan is a defined contribution plan sponsored by Larson Engineering, Inc. (the Company) covering substantially all full-time employees of the Company who have attained age 21 and completed one month of service. An eligible employee becomes a participant on the first day of the month coinciding with or following the completion of the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Participants may elect to make contributions, on a pre-tax or Roth after-tax basis, up to the maximum amounts allowed by law. Newly eligible participants have 3% of their eligible compensation deferred to the Plan automatically unless otherwise elected.

The Company may make discretionary matching contributions for eligible participants. For the years ended December 31, 2024 and 2023, the Company contributed a discretionary matching contribution equal to 40% of the first 6% of compensation that a participant contributed to the Plan during the year. In addition, the Plan provides for discretionary Company contributions. In order to receive an allocation of the discretionary contribution, a participant must be employed by the Company on the last day of the Plan year. There were no Company discretionary contributions for the Plan years ended December 31, 2024 and 2023.

Participants may contribute amounts representing distributions from other qualified plans. The Plan allows participants who are age 50 and older to make catch-up contributions. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with an allocation of the employee contributions, the Company's contributions, and Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Employee contributions, plus actual earnings thereon, are 100% vested and not subject to forfeiture. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on the elapsed time method. A participant is subject to a graded vesting schedule and becomes 100% vested after five years of credit service. Notwithstanding the above, a participant becomes fully vested upon death, disability, or attainment of normal retirement age as defined in the Plan.

**Forfeitures**

Forfeitures of nonvested amounts are used to reduce future discretionary Company contributions or pay administrative expenses. There were \$16,689 and \$18,747 of forfeitures used to reduce Company contributions during 2024 and 2023, respectively. There were \$28 and \$15 of forfeitures used to pay administrative expenses during 2024 and 2023, respectively. There were forfeitures in the amount of \$20,971 and \$11,611 as of December 31, 2024 and 2023, respectively.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum or partial withdrawal in an amount equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service distributions if a participant has completed five years of service and financial hardship. The Plan also allows a participant to withdraw any part of their vested account resulting from certain contributions any time after the participant attains age 59½. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years and may be longer for loans used for the acquisition of a principal residence. The loans are secured by the balance in the participant's account and bear commercially reasonable rate of interest. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable is recorded as distributions on the basis of the terms of the Plan document.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**Benefit Payments**

Benefit payments are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through June 25, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Principal Life Insurance Company, on behalf of itself and Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the insurance company and custodian, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts and Collective Trust Funds* – Valued based on the net asset value (NAV) of units, which are based on the observable prices of underlying assets, held by the Plan at year-end. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions may occur daily.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

In 2024, the Plan entered into a group annuity contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in guaranteed investment contracts (GICs). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or greater than 3%. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

**NOTE 6 INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a group annuity contract with Principal Life Insurance Company (Principal Life). Principal Life maintains certain contributions in pooled separate accounts.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE 9 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan investments are currently managed by Principal Life Insurance Company and Principal Trust Company, the insurance company and custodian of the Plan. Therefore, these transactions qualify as party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
