## Notes to Financial Statements

### 1. Description of Plan

The following description of Tryon Distributing LLC 401(k) Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan sponsored by Tryon Distributing, LLC (the "Company") covering substantially all employees of the Company other than union, non-resident aliens and any part-time, temporary, and seasonal employee whose regularly scheduled service is less than 1,000 hours. The Plan was adopted effective February 1, 1997. Employees become eligible to participate in the Plan after two months of employment and upon attaining age 18. Eligibility service for employer non-elective contributions is 90 days of service and 500 hours of service during the Plan year. Under the SECURE Act of 2019, any employees who are age 21 and complete 500-999 hours in three consecutive 12-month periods, become eligible to make employee deferrals effective January 1, 2024. Secure 2.0 Act of 2022 shortens that period to two consecutive 12-month periods effective January 1, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA").

VOYA completed the acquisition of OneAmerica Financials' retirement plan business on January 2, 2025. The Plan will continue to operate on the same OneAmerica platform until February 2026, and at that time will migrate over to the VOYA platform.

#### ***Contributions***

Participants are allowed to contribute up to the annual maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan permits Roth contributions.

The Company may make discretionary matching contributions as determined by the Company. In 2024, the Company contributed 50 percent up to 6 percent of compensation to the Plan after year-end and is reported as an employer contribution receivable. The Company may also contribute a discretionary non-elective contribution as determined by the Company's Board of Directors. There were no discretionary non-elective contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with participant contributions and allocations of Company contributions and Plan earnings and charged with withdrawals and allocations of Plan losses and investment transaction fees. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a pooled separate account that holds sub-accounts that invest in registered investments and a stable value account.

### ***Vesting***

Participants are fully vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. All participants vest at a rate of 25 percent each year after two years of service and are 100 percent vested in the Company's discretionary match and discretionary non-elective contributions after five years of service.

### ***Benefit Payments***

Upon termination of service due to death, disability, early retirement with five years of plan participation, or retirement, a participant or their beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 in each year. Forfeitures may reduce employer contributions and plan expenses. No forfeitures were used to offset plan expenses. Forfeitures of \$25,193 and \$14,572 were used to offset the 2024 and 2023 employer contribution receivables, respectively.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fixed accounts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Benefits Paid to Participants***

Benefits are recorded when paid.

### ***Excess Contributions Refundable***

Amounts refundable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to employee or employer contributions. The Plan distributed the 2023 excess contributions of \$18,099 to the applicable participants in 2024. The 2024 excess contributions of \$20,227 were distributed in March 2025.

### ***Administrative Expenses***

The Company absorbs various plan expenses. Certain plan administrative expenses are paid by the Plan and may be offset with plan forfeitures. Investment management fees are included in net appreciation/depreciation in fair value of investments.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c)(1) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company ("AUL"), the certifying entity has certified the following as complete and accurate:

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to related information in the financial statements and supplemental schedule.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

The Plan holds a pooled separate account that is divided into sub-accounts. The participants may select from these sub-account offerings which include a stable value fixed contract and registered investments. As the pooled separate account does not file as a direct filing entity, the underlying investments are reported on these financial statements and on the Form 5500.

*Separate Accounts:* The Plan holds a separate account that does not file as a direct filing entity. Each of the separate accounts invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund. The fair value of participation units held in these separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the separate accounts provides for daily redemptions by the Plan with no advance requirements and has redemption prices that are determined by the fund's net asset value per unit as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no investments that fall within the fair value hierarchy as of December 31, 2024 and 2023. The following table presents the fair value of the Plan's assets as of December 31, 2024 and 2023.

### 6. Insurance Contracts

The Plan had a fully benefit responsive fixed interest account which was replaced in 2023 by a stable value account available through AUL. AUL maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the stable value account and previously the fixed interest account buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by AUL. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Interest rates on the fixed interest account are reviewed on a quarterly basis for resetting. Interest rates on the stable value account are reviewed on an annual basis for resetting.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to discontinue contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100 percent vested in their employer contributions.

### 8. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Tax Status

The Plan has received an opinion letter dated August 19, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan is amended periodically, the Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

### 10. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are units of a pooled separate account managed by AUL, the certifying entity of the Plan. Therefore, transactions with these parties qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation or depreciation in the fair value of the investment, rather than a direct payment. Direct fees member services were paid to AUL during 2024.
